Chapman Appointed Visiting Lecturer



Dave Chapman, senior vice president of Manufacturing, this year is a visiting lecturer at MIT's Sloan School of Management.

Starting this winter, Manufacturing Senior Vice President Dave Chapman will be returning to his alma mater, MIT. Not as a student, but as a visiting lecturer.

Dave takes to the podium next month, when he begins conducting a series of lectures for graduate students and executives enrolled at the college's Sloan School of Management. Primarily, Dave's topics will relate to manufacturing operations management. In addition, Dave will serve on a board which will review the Sloan School's curriculum so that courses which better meet industry's needs can be developed and offered to students. Dave also will help review and structure joint research and development activities that MIT may be conducting with industry.

The appointment is significant to both Data General and MIT. "My association with the school will be a combination of strengths," says Dave. "It will bring the needs and knowledge of industry and academia closer together. We have strengths in the application of technology, MIT has an outstanding reputation in research."

Data General Gears Up For Production In Mexico

Data General next month will officially open the Manufacturing portion of its new 40,000-square-foot facility in Chihuahua, Mexico. The plant will produce cables for use with computer systems. It is expected to initially employ about 50 people when it is completed in late February.

Ramon Real has been named plant manager, reporting to Jim Williamson, vice president of U.S. Manufacturing Operations. Ramon comes to Data General from Mitel Corporation, where he was director of Manufacturing operations. Prior to that, he worked as an operations manager at Motorola.

Along with Bangkok, the Mexican plant is Data General's primary production facility for cables. The plant also will be used for the assembly and test of ECLIPSE MV/4000 computer systems, as well as a Field Engineering repair center and the assembly and test of printed circuit boards.

New 10-Year Licensing Accord For Military Computers

Data General has reached an extended, royalty-bearing licensing accord with Loral Corporation. Under the new 10-year agreement, Loral will design, manufacture and market computers built to meet military specifications, which are based on existing and future lines of Data General computers. The two companies also have agreed to develop a joint marketing and sales relationship to meet the needs of government and military customers.

In conjunction with the extended agreement, pending litigation between Data General and both Loral and Rolm Corporation has been terminated.

Data General licenses its minicomputer technology to Loral's Rolm Mil-Spec Computers subsidiary, which designs and builds software-compatible, militarized versions of Data General hardware that can withstand extreme levels of temperature, humidity

and vibration. Rolm Mil-Spec has the largest base of commercially-developed militarized minicomputers in the U.S. defense market.

"We are pleased that Data General and Loral have reached this agreement," says Bob Miller, senior vice president for the Business Group, "and that we will continue to work together with the mil-spec subsidiary to supply computer systems built to meet military requirements. The mil-spec market which was in excess of \$1 billion in 1985 is a high priority for both companies and we and Loral intend to continue to be major suppliers to it.

"We believe the combination of Loral's leadership in defense electronics and Data General's computer technology leadership will offer customers in the military and government sectors the strongest military and Ada-related product lines on the market."

The new accord represents an important development in satisfying the Department of Defense's emphasis on procuring commercially-compatible (non-government developed) computers for its growing information processing needs into the 1990s.

Both companies recently have made major new computer product announcements. Last month Rolm Mil-Spec shipped its first HAWK/32, a 32-bit militarized super minicomputer. The HAWK/32 has been selected for several major new defense programs such as JSTARS, MILSTAR, and Trident II, broadening Rolm Mil-Spec's market participation in C3I (command, control, communications and intelligence), tactical warfare systems and weapons control.

Also, Data General recently announced its new ECLIPSE MV/20000 and ECLIPSE MV/2000 DC computer systems.

The Rolm Mil-Spec division, of Rolm Corporation, was acquired by Loral in June 1985 from IBM after IBM was ordered by the Justice Department to divest the military division in its acquisition of Rolm.

Loral Corporation is an international high-technology company. It primarily designs, develops and manufactures electronic systems and components used in defense electronics and communications. In its fiscal year ended last March, it reported \$502 million in revenues.

Manufacturing's Fourth Call For Papers

A call for papers has been issued for the 1986 symposium on "Operational and Technical Excellence in Manufacturing." Sponsored by Data General's Manufacturing Technology Institute (MTI), employees are invited to submit their ideas on how to enhance manufacturing processes in order to increase productivity.

According to Tracey Zellmann, director of Advanced Manufacturing Engineering and Technology,

"The symposium offers employees an opportunity to share their new and innovative ideas, while developing good presentation and reporting skills."

"It also is a means of recognizing those individuals for their efforts," adds Arthur John, director of MTI at Westboro.

This year's symposium, being coordinated by Jane Jelinek of MTI, has been regionalized in order to encourage the active involvement of all employees at Data General's Manufacturing sites throughout the United States. Region 1, consisting of the Portsmouth, Southboro, Westboro and Westbrook facilities, will hold its symposium at Portsmouth during the week of March 31; while Region 2, made up of the Apex, Clayton and Austin facilities, will run its regional symposium at the Clayton plant during the week of April 7.

Each regional symposium will be two days in length. The first day will consist of 30-minute presentations by participants, including a question and answer period. At that time, judges will select the semi-finalists who will be asked to make a 20-minute presentation the following day. Regional finalists will be chosen from this group of presenters.

Later this year, the regional finalists will present their papers at the 1986 Manufacturing Management Conference in Woodstock. Final judges will include Dave Chapman, senior vice president of Manufacturing, along with the Manufacturing vice presidents and other managers in attendance. Prizes will be awarded for the top papers presented at the conference.

All papers will be judged according to the following criteria:

- Data collected and analysis of situation.
- Experimental results and results expected.
- Potential value to the success of Data General.

Westboro employees should submit their one-page abstracts summarizing the major points to Site Coordinator Jane Jelinek by Friday, January 31. Final papers will be due on March 14. For more information and paper guidelines, contact Jane at extension 5534.

In the past, top papers presented at the Operational and Technical Symposium have directly contributed to the success of Data General. Examples of ideas that were integrated into Manufacturing processes include the implementation of bar code technology throughout the company; the automation of the Reproduction Distribution Services at Southboro; and the development of a low-cost, real-time quality reporting system at Westbrook.

Enhanced Support Services For SNA Products

Data General now offers several new software support services for its IBM-compatible Systems Network Architecture (SNA) software products. In addition, it has extended its Software Product Service Agreement (SPSA) telephone support service to include Data General's SNA products. These services enhance the levels of software support for customers using Data General SNA products to communicate with remote IBM hosts operating in an IBM environment.

The new services include installation of Data General SNA/Synchronous Data Link Control (SDLC)-based software products included with initial software licenses for the products. Post-install software support provided by Data General's Customer Support Center in Norcross, Georgia also is provided through an SPSA.

Supported products include: DG/SNA, DG/SDLC, SNA 3270, SNA 3278 APL, SNA/RJE, DG/XDLC and CEO DXA software running under Data General's AOS/VS, AOS and AOS/DVS operating systems.

With SPSA support, customers may access immediate toll-free telephone assistance from the Customer Support Center during business hours to help identify concerns and answer questions regarding Data General's SNA products.

Other standard SPSA services such as software and documentation updates as well as on-site support service options are also available for these products.

The new software support programs reinforce Data General's commitment to an open systems strategy and to supporting customers with "total" systems solutions.

Cafeterias Change Hands At New England Sites

Data General employees soon will have a greater selection of foods at their local cafeterias as Seilers Food Services becomes the new cafeteria and vending machine operator. Southboro, Milford and Westboro are among the New England sites that will experience the change in service. Cafeteria hours will remain the same and prices will not be affected.

This change goes into effect at Southboro on Monday, January 20; Milford on Monday, January 27; and Westboro on Monday, February 3.

An expanded menu will include such items as large deli-style sandwiches, international burgers and diet plate specials. Also, the salad bar and dessert selection will feature more variety. In addition, a new and different vending machine selection will be added. Employees are encouraged to submit their ideas and comments to the new Dining Services manager.

Prior Approval For Catered Foods

Before requesting catered foods for special functions, employees must complete an approved Food Services Request form that authorizes Dining Services to deliver an order. Request forms are available from Dining Services at Westboro and Southboro, and in Milford, at the Travel and Expense office.

New Postal Regulations For Business Reply Mailers

Data General groups that originate documentation which includes Business Reply Mailers (BRM) must set them up according to the U.S. Post Office's new specifications that went into effect January 1.

All bar codes, addresses and zip codes must be in the proper position on the BRM for the Post Office's automatic sorter to read each section. It is important to note that if the mailers are not set up according to the required specifications, the BRMs may not be delivered. Employee Courses Teach CLI Macros, CLI Skills

Employees can learn to create macros and to improve their understanding and use of the Command Line Interpreter (CLI) by attending two classes that will be held in February at the Education Center, 2400 Computer Drive in Westboro.

Introduction to CLI Macros (S159E) is a one-day class that teaches how to write, invoke and interpret CLI macros. Designed for anyone who works with the CLI, this course requires only a familiarity with CLI commands. Topics covered include: dummy arguments, range dummy arguments, switch dummy arguments, pseudo-macros, macros and the environment, and interpreting complex macros. This course will be conducted on Wednesday, February 5.

On Thursday, February 6 and Friday, February 7, Educational Services will conduct an *Introduction to CLI (S160)*. This is a two-day class that teaches how to effectively use the CLI under AOS and AOS/VS. This course will benefit anyone who wishes to learn more about the capabilities of the CLI. Topics taught in this course include: using the terminal, introduction to the CLI, files, SED text editor, file backup, the CLI environment.

Stock Purchase Reminder - Update Your Address

To avoid any confusion in distributing stock certificates purchased through the Employee Stock Purchase Program, you should make sure your address is properly recorded with the company.

The address that appears on your paycheck is the address currently listed. If this is incorrect, inform your supervisor. An Employee Profile Document (EPD) form should be filled out and submitted to your Human Resources representative. This ensures that your stock certificates and other company-related material will be mailed to the correct address.

Certificates for the current purchase period will be mailed to employees in February.

For Income Tax Purposes

Prior Plan Stock Prices

Now that income tax filing time is here, employees enrolled in the Data General Stock Purchase Plan may consider the following:

For employees who have sold purchase plan shares that were held less than two years, the difference between the purchase price and the fair market value (FMV) on the purchase date is ordinary income to be included with salaries and wages on your income tax return.

The difference between the fair market value on purchase date and your sale price is either a short or long-term capital gain or loss to be reported on Schedule D, Capital Gains and Losses, and attached to your income tax return. The holding period, for purposes of the Data General Plan, is two years from the date of grant which is the first day of the Plan (either February 1 or August 1.)

If the shares were held longer than two years, your ordinary income is the LESSER of:

- a. the excess of the FMV at time of sale over the amount paid for the shares, OR
- b. an amount equal to 15 percent of the FMV of the shares on the first day of the payment period.

The following information is provided for the prior five years of the Data General Stock Purchase Plan to help with the filing of income tax returns for those employees who may have sold shares in 1985. Also, note that for purchases prior to June 22, 1984, the long-term holding period is one year; for purchases after June 22, 1984, the long-term holding period is six months.
