Networking System Leads To PC Integration

Data General has announced several new hardware and software products and a customer services program to link IBM and IBM-compatible personal computers (PC) with ECLIPSE MV/Family computer systems. CEO/PXA, an electronic mail and document exchange connection between the IBM Professional Office System (PROFS) and CEO comprehensive electronic office software also has been announced.

Testing of the new networking products has been successfully completed at several customer sites in the U.S. including the Federal Reserve Bank of New York; a Chicago Research & Trading Group; and Paul, Hastings, Janofsky & Walker, a large Los Angeles-based worldwide law firm.

"DG/PC*I (Personal Computer Integration) emphasizes freedom of choice for users by integrating a wide range of personal computers with larger departmental computers in an organization," says Dave Lyons, vice president of Group Marketing. "It facilitates the most efficient division of work among these systems in an organization."

DG/PC*I is an integrated set of products consisting of industry-standard local-area networks, industry-standard distributed operating systems and data communication services. This supports specific network-ready applications such as the new CEOwrite word processing package and other popular network-ready Microsoft MS-DOS applications.

The new products allow users to divide work in a network of personal and ECLIPSE MV/Family computers by assigning certain jobs to the personal computers and others to the larger department computers. Typically, those jobs that support a single person such as word processing, spreadsheet development and accounting, would be assigned to a personal computer. Those that either organize, arbitrate and control resource use among many users would be assigned to departmental computers such as those of the ECLIPSE MV/Family. Departmental computers handle jobs or functions like access to centralized data files or printers.

DG/PC*I offers users a choice of three different local area networks so physical wiring schemes already

installed can be used to reduce costs: DG/StarLAN, "Thin" Ethernet, and Ethernet.

The local area networks can link small departments or work groups in which personal computers are connected directly to a local departmental server or for corporate-wide connections between department systems and personal computers by giving users access to all departmental systems in a network. The selection of a local area network is based on cost and performance requirements of the specific application environment. Ethernet is particularly suited for connecting department systems.

"Data General is the first vendor to offer three different local area networks for personal computer integration," says Colin Crook, senior vice president of the Communications Systems Group. "This gives the user the widest choice and flexibility in applying networked systems to a particular application or pre-existing wiring scheme."

Data General also announced a new Network Services Group to implement network planning and design programs for customers, and service contracts that include maintenance for the IBM family of PC products, along with certain popular peripherals and option cards. Data General will also qualify other PC-compatible computers for maintenance coverage on a case-by-case basis.

At the same time, a development and marketing agreement has been made between Data General and Gold Hill Computers for artificial intelligence products to be used with DG/PC*I.

CEO Enhancements

CEO/PXA makes it possible to exchange electronic mail and documents between CEO and PROFS, IBM's professional office system.

"CEO/PXA is also the only PROFS document exchange interface among major competitors that doesn't require an IBM host-based software component," says Dave. "This approach reflects our commitment to technical leadership in the area of IBM connectivity."

CEOwrite

Data General also introduced new functionality to CEOwrite, the MS-DOS word processing program for the DATA GENERAL/One family, DASHER/One, DASHER/286, the IBM PC, XT, AT, and fully PC-compatible computers.

"CEOwrite is entering a level of functionality currently found in high-end PC-based word processors such as WordPerfect, Multimate and Officewriter," comments Chris Stone, manager of Office Systems Software. "When you combine these functions with the main strength of CEOwrite - its ability to integrate with a corporate office automation system - CEOwrite is a formidable candidate in the word processing arena."

New CEOwrite features include:

- A spelling corrector and automatic hyphenation - the CEOwrite spelling corrector contains 65,000 words.
- Column editing and snaking - snaking allows users to insert text into columns. Multiple format rulers allow a user to create columns of text side by side.
- Scientific and math functions - new functions include layout options to prepare scientific formulas for printing, and math crossfooting.

Firms Make Connections With Data General

From the floor of the major exchanges, to the Federal Reserve Bank, to a Los Angeles-based law firm, Data General customers are already experiencing what personal computer (PC) integration can do for their company's networking needs.

This personal computer integration, DG/PC*I, is an architecture which is part of Data General's long-term strategy and methodology for integrating PCs into customers' corporate information system environments.

Chicago Research and Trading (CRT), a large options trading firm, utilizes the benefits of DG/PC*I with its computer systems. Time is money, so the faster it can respond to market activity the better.

To accelerate this process, CRT is using DG/PC*I to transfer market data between its ECLIPSE MV/20000 computer and IBM PC/ATs in a "real-time" trading environment. The PCs are mainly used for analysis and display representations of market data.

The Standard & Poor's 500 ticker feed is continuously monitoring what is happening on the floors of the exchanges, and all that information is stored on the ECLIPSE MV/20000 system. Further trading information from worldwide exchanges including Chicago, New York and London are also stored on the ECLIPSE MV/20000 computer. A composite view of market data is then available to the PC user, and DG/PC*I provides a much faster way of downloading this information.

"This approach is much faster than a 9600-baud link that we were using before," says Gerry Duffy, MIS

director of CRT. "We've just begun, so we have yet to realize the potential of DG/PC*I."

The Federal Reserve Bank of New York uses computer systems from Data General, IBM and Wang, with a mix of both Data General and IBM PCs. Its goal was integration, on and off site.

The Federal Reserve Bank just installed an ECLIPSE MV/10000 computer as an office support system. This system deploys the new Data General StarLAN twisted pair wiring and incorporates the bank's various stand-alone resources (personal computing, word processing, mainframe services, office requirements) into an integrated environment that will support the needs of both professional and clerical staffs from a single workstation.

StarLAN integrates existing IBM PCs and the DASHER/286 workstations, desktop computers, laser printers, and communication equipment. These workstations are linked to the ECLIPSE MV/10000 computer, and function as communication gateways to mainframes in New York and Washington, D.C.

In the Federal Reserve Bank's multi-vendor computer environment, Data General not only adapted to the existing environment, but provided for even more advanced technological innovations in the future.

Paul, Hastings, Janofsky & Walker (PHJ&W) is one of the fastest growing law firms in the country. PHJ&W has been using computers since it acquired an ECLIPSE MV/8000 system more than five years ago. During the past two years, a great demand for personal computers within PHJ&W has resulted in a proliferation of IBM PCs and other "intelligent workstations." During that same period, PHJ&W added an ECLIPSE MV/10000 system to its principal office.

As a part of the firm's automation plan, the MIS staff reviewed various methods of interfacing PCs with the firm's network of ECLIPSE MV/Family systems. The automation plan included: standardizing the PC as the workstation; becoming a test site for DG/PC*I; and implementing a network of ECLIPSE MV/Family systems in each office. The ECLIPSE MV/Family systems then communicate with the PC workstations via DG/PC*I and with the main office via a public data network (Telenet).

In January 1987 with initial DG PC*I hardware, PHJ&W began its testing of the DG/PC*I approach along with some significant application software development which would complement the DG/PC*I platform strategy.

PHJ&W programmers developed a PC-based Time Entry and Accounting System. This was facilitated by writing ANSI-standard COBOL code on the ECLIPSE MV/8000 computer which was then transported over the DG/PC*I link to the development PC. The COBOL code ran in MS-DSOS without any changes or modifications.

This system allows attorney's time records to be entered directly onto a PC. The branch ECLIPSE MV/Family system will accumulate the individual "time slips" and telecommunicate them to the main office for processing.

On a monthly basis, the main office will produce a Preliminary Billing Report and transmit it to the appropriate office for final edits and adjustments. The client bills are processed and transmitted to the office for printing and billing. What was once a ten-step, time-consuming manual process has been reduced to a simple two-step process.

PHJ&W uses DG/PC*I in four other ways: application software support, shared peripheral use, data file back-up and teleprocessing. Considering that PHJ&W may ultimately employ as many as 500 PCs, the time and effort saved is crucial for this busy law firm.

According to Mark Cartier, manager of Information Systems at PHJ&W, "DG/PC*I will allow us to integrate our stand-alone PCs with existing Data General computers. We have already developed distributed systems using DG/PC*I as the standard and we are modifying our existing procedures to take advantage of the DG/PC*I architecture. We view DG/PC*I as an excellent way to increase productivity, decrease costs and time delays, and to better manage our firm's information."

New Zealand Department Of Trade, Industry Signs Deal

The New Zealand Department of Trade and Industry recently signed a contract with Data General which will result in the installation of one of the country's largest integrated office automation networks.

The \$1.4 million order is part of the Trade and Industry department's strategy to build a comprehensive business information system that has the ability to store, manipulate, and provide policy advice, information and services to department ministers and business clients. The overall purpose of the project is to allow New Zealand business to compete more effectively within the domestic and international marketplace.

The system is based on the Data General ECLIPSE MV/15000 computer which will be upgraded to provide increased capacity to meet the changing needs of the department. ECLIPSE MV/7800 computers also will be added to the system as the department's needs and the number of users increase. The combination of Data General CEO comprehensive electronic office software, Powerhouse 4th Generation Language, and the DG/SQL relational database, will let the department provide a fully-integrated office environment, a comprehensive company and product database, as well as a tariff and trade database. Other systems will be implemented and developed in the future.

The office automation capabilities, to be used eventually by all 400 employees, are an important part of the department's strategy to build a comprehensive system. A key feature of the system is the total integration of eight database applications, all accessed through the CEO software.

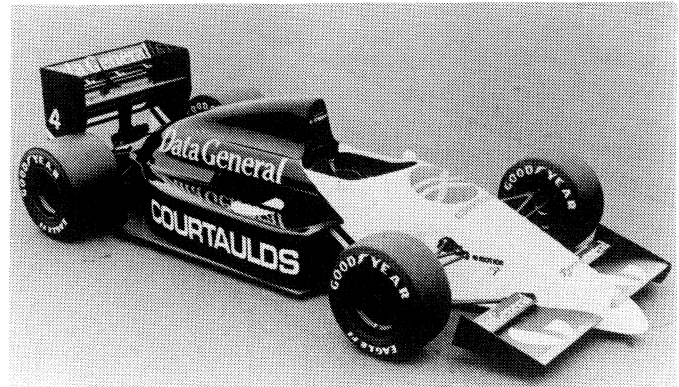
Peter Donovan, deputy secretary of the Department of Trade and Industry, says, "CEO will be the delivery

vehicle for our eight business applications. Although we expect to see at least 50 percent of our productivity gains through the use of CEO itself, it is equally important as the link to provide different people in different areas of the department with information in all our databases."

When looking at the office automation system requirements, the Trade and Industry department was most impressed by the power and simplicity of the Data General CEO software.

"Not only is there a recognized need for word processing and electronic mail within the department, but there is already a high level of enthusiasm for the CEO system," adds Peter.

Team Tyrrell Formula 1 Car To Be In Westboro



The Data General Team Tyrrell Formula 1 race car will be in Westboro on Tuesday, June 16, as the car and crew make a stop on the way to Detroit for the Detroit Grand Prix. On hand to meet with employees will be Ken Tyrrell, the founder of the Tyrrell racing organization, drivers Philippe Streiff and Jonathon Palmer, and Nigel Besford, who has been responsible for the design of the 1987 car.

The car can be viewed on the lawn between the Building 14B lobby and the employee entrance near the cafeteria from 11:30 a.m. and 1:30 p.m. that day. Ken, Philippe, Jonathon and Nigel will be available to answer employees' questions at that time, as well. Team Tyrrell hats and color brochures will be given out to employees viewing the car.

Computer-Aided Design

The Data General-Team Tyrrell partnership began last year, when Data General became a major sponsor of the racing syndicate. That partnership was broadened this year when four Data General DS/7540 workstations were used in the design of the car. These workstations run Data General's technical electronic office (TEO)

system, a "platform" on which Tyrrell engineers have been building specialist applications to design and test Formula 1 cars. These applications include aerodynamics analysis, automated drafting, and suspension behavior simulation.

The Team Tyrrell headquarters in England makes use of Data General's CEO comprehensive electronic office software, which is used for electronic communications between the design and management offices.

A Reminder To Employees: Open Enrollment Ends June 19

Now through June 19 is the enrollment period for medical and dental coverage offered to employees through Benefits Plus, Data General's expanded benefits plan, as well as changes in Supplemental and Dependent Life Insurance. All coverages take effect on July 1.

Everyone must complete a new Benefits Enrollment Form by Friday, June 19. Benefits Plus introduces pre-tax employee contributions for medical as well as a requirement that information be provided on all dependents. If an employee does not complete an enrollment form by June 19, enrollment will be automatic for employee coverage only in PLUS 3 medical and the traditional dental plan. That enrollment will not be able to be changed, due to government regulations, until January 1, 1988.

Data General Employees Share Canoe Adventure With Explorers

When Bob Fogg and John Gareri became voluntary advisors for the Westboro Computer Explorer Post, they knew they could rely on their technical backgrounds to teach local students the wonders of high technology.

Bob, an Educational Services Systems Training specialist, and John, an instructor for Educational Services, realized teaching kids to be well-rounded students also means taking the time to appreciate the outdoors. That is one of the reasons Bob and John arranged for a weekend canoeing trip on the Battenkill River in Vermont for the post this past weekend.

According to Bob, the group left Westboro last Friday evening, and arrived in upstate New York around 10 p.m. After spending the night at a campground on the river at the Vermont-New York border, the group then drove up-river into Vermont to rent canoes Saturday morning, and spent the day on the river paddling back downstream toward their campsite.

"We stopped at all the bridges along the way, so the kids could jump off into the water," Bob says. "Of course, we observed all the safety regulations, and made sure the kids wouldn't hurt themselves. John recently completed an eight-hour canoe safety course, and is a certified water safety instructor."

The group camped out Saturday night and spent Sunday on the river, as well. Bob and John agreed the weather was perfect, as were the canoeing conditions.

"The Battenkill was definitely the cleanest and best river we've canoed yet," says Bob. "It was safe enough for even the most inexperienced paddlers, yet had enough quickwater and riffles to keep our adrenalin up!"

"We had a great time," John says. "The trip gave the kids a chance to work together, and a chance to enjoy the environment. The Computer Explorers plan events like this throughout the year, with skiing trips in the winter, and camping trips or days at the beach in the warmer months."

"I enjoy watching the kids grow to be able to do adult kinds of things," Bob says. "The kids have to get along, and work as a group. It's definitely a cooperative effort. This was the best trip yet."

The Computer Explorers post is open to young men and women from age 14 through age 20, and meets year-round, on the first and third Monday of each month, at Data General's 2400 Computer Drive facility. Typically, the first part of each two-hour session is devoted to a class, which may deal with graphics instruction, word processing or programming. The remainder of the meeting is free time and each member can pursue individual computer interests.

"We'd like to see more children of Data General employees join the post," Bob says. "They, as well as other young people who are interested in computers are encouraged to drop in for a visit at any meeting and see whether joining Computer Explorers is for them."

Training

Educational Services is offering the following software and office automation courses in June.

- **AOS/VS Internals (S410)** - This course provides an overview of the inner workings of the AOS/VS operating system, and is geared toward AOS/VS programmers. This five-day course has the following prerequisites: S105/VS (ECLIPSE MV/Family Assembly Language Programming), S309/VS (AOS/VS System Programming, Part 1), S310/VS (AOS/VS System Programming, Part 2), and familiarity with operating system theory. This course starts on Monday, June 22.
- **RDOS System Programming (S304)** - This course is geared toward RDOS system programmers and analysts in the features available to user programs through the use of system calls and task calls. To be eligible for this class, employees must have taken S200 (RDOS User) and one of the following courses: S101 (Fundamentals of Assembly Language Programming); S102 (NOVA Assembly Language Programming; or S105 (ECLIPSE Assembly Language Programming). This five-day course starts on Monday, June 22.
- **Designing Applications Under AOS/VS (SM508)** - This course introduces to AOS/VS system designers, system managers, and technical users the significant performance-related design options that they will encounter in designing an AOS/VS application. The prerequisites for this three-day course, which starts on Monday, June 22, are S209 (AOS & AOS/VS User) and S219/VS (AOS/VS System Manager).
- **CEO System Manager (S221)** - This class is designed for CEO system managers responsible for the installation, maintenance, and on-going support of CEO. This three-day course teaches how to control Data General's CEO system, including the system structure of CEO. A prerequisite for this course is thorough knowledge of CEO from a user's perspective; and S209 (AOS & AOS/VS User), SH109/VS (AOS/VS Operator Training or equivalent experience. This class begins on Monday, June 29.
- **Authoring for the Computer-Based Training Environment (SM503)** - This interactive workshop is for those who want to use Computer-Based Training (CBT) as a vehicle for communicating information (i.e. new product information, marketing updates), or for developing and delivering training. It includes extensive hands-on work with Data General's Comprehensive Education Software (DG/CES) authoring system to illustrate CBT authoring principles. This three-day course begins on Monday, June 29.
- **Introduction to CEO Mail and Calendar (OA 143)** - This course teaches effective use of the features of CEO's mail and calendar, including telephone messaging and "Booker" files. There are no prerequisites, but familiarity with a typewriter keyboard is helpful. This one-day class will be held on Wednesday, June 24.
- **CEO List Processing (OA 147)** - This course focuses

on the use of the CEO merge function to produce documents for mass mailings or repetitive-type documents. This half-day class is being held on Friday, June 26.

Prior approval of your supervisor is required for course registration. Call (tie-line) 221-1647 to enroll in these or other classes. All classes will be held at the Education Center, 2400 Computer Drive, in Westboro.
