Manufacturing Establishes Support Organizations

Manufacturing is being reorganized to better support Data General Manufacturing plants around the world. All functions in Westboro directly supporting plant operations will now report to the U.S. Manufacturing or International Manufacturing Operations. The remaining Westboro-Manufacturing functions will report to Lee Henning, vice president of Central Manufacturing Services.

Bill Kelleher has been named director of U.S. Manufacturing Operations, supporting all domestic Manufacturing plants. Bill reports to Vahram Erdekian, vice president for U.S. Manufacturing Operations. Bill will remain as acting Southboro plant manager until a successor is named.

Since joining Data General 10 years ago, Bill has held a number of managerial positions within Manufacturing. Most recently, he was Southboro plant manager, a position he held since January 1984. Prior to that, he was Quality Assurance director, Manufacturing New Products director, Design Assurance Engineering (DAE) director, and DAE manager. Bill holds a master's degree in engineering management from Northeastern University and a bachelor's degree in electrical engineering from Rensselaer Polytechnic Institute.

Carroll Halva has been named director of Technology and Corporate Quality reporting to Lee Henning.

Carroll was most recently general manager for Peripherals Manufacturing. Prior to that, Carroll was plant manager at Westbrook for more than four years. He joined Data General in 1978 at Clayton where he managed the establishment of the PCB Fabrication operation. Carroll holds a master's degree in chemistry from the University of Arizona and a bachelor's degree in chemistry from Iowa State University.

The realignment of these support functions will begin immediately and will be completed over the ensuing weeks. In addition the Westboro-based support organization for International Manufacturing Operations will be established over the next several weeks.

New Contract Billing System Offers Flexibility

The Field Engineering division has established a better way for Data General and its customers to keep track of service orders, thanks to Support Plus.

The new system makes it easier for Data General to monitor contract billing procedures, and allows customers to keep abreast of their contract conditions. In addition, a Support Plus Service Hotline answers customers' questions regarding the service arrangements specified on their maintenance contracts.

According to George Potts, director of Strategic Planning, the company now has a system-wide data base for contract billing. It was jointly developed at the Data General-Europe headquarters in Paris and Field Engineering headquarters in Milford.

"We are now much better able to keep track of billing. We have greater flexibility because the system is now completely stored on a computer," George says. "Rather than taking the time to look through hard-copy records by hand we can work with the computer terminal and perform searches and update customers' records.

The contract system provides customers with three different invoices.

The initial invoice provides an itemized, full configuration of model numbers, product descriptions and quantities of Data General equipment ordered. This invoice also gives the customer a detailed breakdown of the service and the cost of that service. The second summary invoice makes reference to the service agreement and cost for that particular type of service. The third adjustment invoice is used when a customer adds equipment or needs additional service.

"What makes this better is that we now have detailed invoices which cover all terms and conditions, product descriptions, and order adjustments," George says. "Data General customers can clearly see what they have ordered, what service they have contracted, and what the service will cost. The new system allows for greater detail, which in turn allows for better understanding. It also allows Data General to more closely keep track of billing procedures. The new system is a plus for everyone."

Insurance Firm Purchases \$1.8 Million Of DG/Ones

Colonial Mutual, an insurance firm based in Melbourne, Australia, has purchased 500 DATA GENERAL/One Model 2T computers valued at \$1.8 million. Colonial Mutual will supply its sales agents with the portable computers to help in their "one-stop" sales approaches. Eventually, all the units will be fitted with modems so that the agents located in remote offices throughout Australia will be able to communicate with an office automation system, which will be installed at the headquarters facility.

Colonial Mutual, the third largest life insurance company in Australia, considered laptop systems from Toshiba, Hewlett-Packard, Wang, Sharp, IBM and NEC before settling on the Data General computers. The firm chose the recently-announced Model 2T system based on its technical features, such as: its memory capacity; back-lit, high-resolution screen; and its full-battery portability. Colonial Mutual also cited the service programs for the DATA GENERAL/One computer as a reason for its decision.

According to David Drinkwater, the leading sales representative in the Colonial Mutual deal, the firm was impressed with how Data General presented itself. David accompanied the firm's executives to Westboro, and with the help of the Insurance Industry Marketing group, convinced the decision makers of Data General's commitment to and knowledge of the insurance industry.

Operating in Australia for more than 100 years, Colonial Mutual offers a wide range of financial services, including pension funds, general insurance, fixed term investments, short-term money market, and housing, as well as life assurance, its major product line.

Data General To Participate In Government Trade Show

Data General's Federal Systems Division (FSD) will participate in AFCEA-East, the largest military electronics show of the year, next week at the convention center in Washington, D.C. "Our participation in this year's AFCEA show will demonstrate that we are in the important Command, Control, Communication and Intelligence marketplace to stay," says Larry Holswade, FSD's vice president.

More than 1,500 industry and military exhibits from some 450 companies, including GTE, Raytheon, and IBM are involved in the exposition. Displays will deal with the full range of military communications and electronics from complex security devices and sophisticated telecommunications switches to road-mobile computers, electronic warfare devices and battle management communications.

According to John Williams, director of Product Development for FSD, Data General's display will be targeted for Department of Defense applications. "A lot of solid,

Data General teamwork has gone into preparation for this show," says John. "We've gotten exceptional support across-the-board and especially appreciate the long hours from Manufacturing, Industrial Design, Mechanical Engineering, Design Assurance Engineering, Public Relations, Marketing Communications and Medical Services -- to mention just a few of the organizations. It's exciting to see a project like this all come together."

The Exposition begins on Tuesday, June 16, and ends on Thursday.

Team Tyrrell Formula 1 Car To Make Pit Stop In Westboro

The Data General Team Tyrrell Formula 1 race car will be in Westboro on Tuesday, June 16, as the car and crew make a stop on the way to Detroit for the Detroit Grand Prix.

The car can be viewed on the lawn adjacent to the Building 14A cafeteria from 11:30 a.m. to 1:30 p.m. that day. From 4:00 to 5:00 p.m. that afternoon, in the Building 14A cafeteria, the Tyrrell crew will formally discuss Formula 1 racing and Data General's sponsorship. Interested employees are invited to attend.

The Data General-Team Tyrrell partnership began last year, when Data General became a major sponsor of the racing syndicate. That partnership was broadened this year when four Data General DS/7540 workstations were used in the design of the car. These workstations run Data General's technical electronic office (TEO) system, a "platform" on which Tyrrell engineers have been building specialist applications for Formula 1 cars. These applications include aerodynamics analysis, automated drafting, and suspension behavior simulation.

The Team Tyrrell headquarters in England makes use of Data General's CEO comprehensive electronic office software, which is used for electronic communications between the design and management offices.

On hand to meet with employees will be Ken Tyrrell, the founder of the Tyrrell racing organization, drivers Philippe Streiff and Jonathon Palmer, and Nigel Beresford, who has been responsible for the design of the 1987 car.

Ken, the founder and head of the Tyrrell Racing Organization, has been involved with motor racing since the 1950s.

In 1959, Ken switched from being a driver to an entrant and team manager. Since Ken began entering cars in the Grand Prix motor races, the Tyrrell team has won three World Drivers Championships, two World Constructors titles and 33 individual Grand Prix events.

Ken has built a reputation for spotting potential champions. He team managed Jackie Stewart to a record 27 Grand Prix victories and three World Drivers' Championships. Other drivers in whose careers Ken also played an important role are John Surtees, Didie Pironi, Jodi Scheckter, Patrick Depailler, Ronnie Peterson and Michele Alboreto.

Philippe is in his second full Grand Prix Formula One season, and his second year with Data General Team Tyrrell, as well.

Born in France, Philippe began motor racing in 1977. In 1980, he finished sixth in the European championship. He won the French Formula 3 title and finished fourth overall in Europe the following year.

Last year, Philippe's best races came when he finished fifth in Adelaide and sixth at the British Grand Prix.

Jonathon is the newest member of the Data General Team Tyrrell organization.

In 1976 and 1977, Jonathon began to make his mark on the racing scene by driving a Marcos sports car to 27 race victories and seven lap records. In 1981 he won the Marlboro British Formula 3 Championship, which marked the beginning of his introduction to Formula One Grand Prix teams.

Nigel has been a major player in the design of the 1987 Formula 1 race car, joining the Tyrrell team last year to manage the installation of the Data General DS computer.

Nigel has attended the British Government's National Maritime Institute, working on wind tunnel testing of oil platforms, ships and other industrial aerodynamics. He has also attended Brunel University where he was involved with statistical analysis of software, engine test work, and suspension design and simulation.

After completing his studies at Brunel, Nigel worked for 18 months on a project using fiber-reinforced plastics for structural engine components. After that, he spent six months at Ralt Cars performing general race car design work before joining the Tyrrell team in 1986.

Employees Speak At IBC Conference



Financial managers and consultants from throughout New England are better aware of International financial practices, thanks to two Data General employees. George Doble, director of Leasing, and Roland Theriault, manager of Foreign Exchange, offered their insights in that area during presentations at the "International Cash Management and Foreign Exchange" conference recently. The conference was held in Brewster, Massachu-

setts, for members of the International Business Center of New England (IBC).

According to Ellen Richstone, Data General's assistant treasurer, who served as co-chairperson for the event, the conference offered a wide range of topics geared toward those involved in international financial management. Key issues addressed during the two-day conference included forecasting worldwide cash flow, using the right tools to optimize international cash management, understanding and applying taxation rules related to foreign exchange, keeping abreast of currency swaps and the latest in international electronic banking.

"The IBC brings a special focus to international business," Ellen says. "The center allows companies to get together to discuss mutual concerns, and to come up with solutions for those concerns. Many regions of the United States do not have this opportunity, which provides the setting for corporations and bankers to meet and learn from each other's experiences."

George emphasized the benefits of leasing as a measure of monitoring cash management.

"Leasing benefits both Data General and the customer," George says. "With leasing, we can have better control over the financial options requested by our customers. We can also better address the individual customer's financial needs by providing competitive and responsive leasing programs."

Roland discussed the importance of netting and re-invoicing to achieve greater financial flexibility in foreign exchange.

"Netting and re-invoicing are tools used to manage cash flows more effectively, and to centralize foreign exchange exposure within one entity, so it can be managed more effectively," Roland explained. "Netting involves offsetting receivables against payables without actually moving any cash. The advantages include the reduction of cash float, bank fees and currency conversion costs and risks. Those involved can improve their ability to manage their cash positions."

According to Ellen, the Data General presentors were well-received by other attendees.

"Those attending were impressed with what we had to say," Roland says. "It was a good opportunity to find out what other people in the financial industry are doing and thinking. It was a good mix of bankers and people from the corporate environment. We were able to gain new perspectives, and share our views."

Savings And Investment Plan Update

Whether you are currently participating in the Savings and Investment Plan, or planning to enroll on July 1, you should be aware of recent modifications and upcoming plan deadlines.

Mallings

Savings and Investment Plan statements for the first quarter of 1987 were mailed out to all employees participating in the Savings and Investment program the week of May 11. If you have not yet received your statement, please contact the Benefits Department at 4550.

New Hire Savings and Investment packages were mailed to all employees who became eligible to participate in the Data General Savings and Investment Program as of this quarter effective July 1.

Fund Earnings

Fund Transfers

Participants in the Savings and Investment Plan can transfer all, or part, of their account balance from one investment fund to any other investment fund(s) at the start of any calendar quarter BUT not more than once every six months.

If you would like to transfer funds for the calendar quarter beginning July 1, you must complete the Fund Transfer portion of the Savings and Investment Enrollment/Change Form and return it to the Benefits department in Westboro no later than Friday, June 19. All transfers will become effective July 1.

The transfer of funds will not affect your future contributions. If your intention is to have all contributions after July 1 directed to a different fund(s) you must also complete the Investment Election portion of the form.

Enrollment/Change forms are available from your Human Resources representative or the Corporate Benefits department in Westboro.

Enrollment & Change Deadlines

Friday, June 19, is the deadline for submitting all new enrollments and quarterly changes to the Savings and Investment Plan. The enrollment form (used for both new enrollments and changes) must be returned to your local Benefits department by June 19 for enrollments/changes effective July 1.

Plan Eligibility

If you are a recently-hired employee at Data General, and will have completed 90 days of employment before July 1, you will be eligible to join the Savings and Investment Plan effective July 1.

A packet of descriptive material should have been mailed to your home. If you have not received this information, contact your Benefits administrator or Human Resources representative.

After reading the information, simply complete the enrollment form and submit it to your Benefits or Human Resources representative. If you decide not to contribute to the program at this time, you will be able to enroll at the start of the next quarter in October.

If you have any questions regarding the program, contact your local Benefits administrator.

A Reminder To Employees: Open Enrollment Ends June 19

Now through Friday, June 19, is the enrollment period for medical and dental coverage offered to employees through Benefits Plus, Data General's expanded benefits plan, as well as changes in Supplemental and Dependent Life Insurance. All coverages take effect on July 1.

Everyone must complete a new Benefits Enrollment Form by Friday, June 19. Benefits Plus introduces pre-tax employee contributions for medical as well as a requirement that information be provided on all dependents. If an employee does not complete an enrollment form by June 19, enrollment will be automatic for employee coverage only in PLUS 3 medical and the traditional dental plan. That enrollment will not be able to be changed, due to government regulations, until January 1, 1988.

Anyone who has not received the Benefits Plus information should call Corporate Benefits at extension 4550 in Westboro.

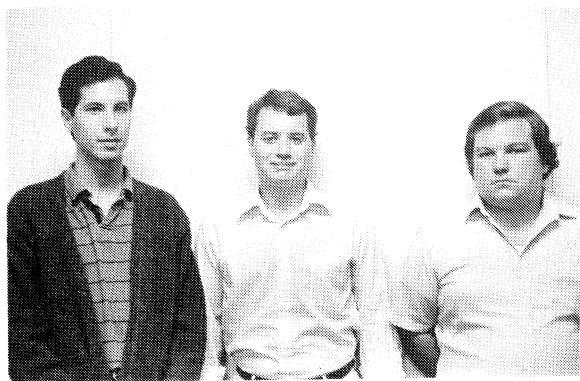
Toastmasters' Open House Scheduled For June 17

Have You Filled Out Your New W-4 Or W-4A?

The Tax Reform Act of 1986 requires that a new W-4 or W-4A be submitted to employers no later than October 1, 1987. Failure to comply with the law can result in a higher federal withholding. If a new W-4 or W-4A form is not submitted to a Data General Payroll site by October 1, the Payroll departments are required to alter employee exemptions according to the law. The law states that "if a new form W-4 or W-4A is not submitted, the employer must withhold if the employee is single, claiming one withholding allowance, or married claiming two withholding allowances, depending on whether the employee checked the single or married box on the most recent W-4 on file with the employer."

Employees can obtain W-4 and W-4A forms at the Payroll department. Should you need assistance filling out either form, the IRS, through its Taxpayer Service, can help answer your questions and provide you with additional information.

- **Introduction to MS-DOS (S145)** - This course teaches employees how to use the features of the MS-DOS operating system. This two-day course is geared toward employees with some personal computer experience, and who have a need to know how to use an MS-DOS-based personal computer. The class begins Monday, July 6.

- **ECLIPSE MV/2000 DC System Operator (S224)** - Employees who are responsible for the management and operation of an ECLIPSE MV/2000 DC will learn how to operate and manage AOS/VS using SMI menus on this system. To be eligible for this five-day course, you must have taken S100 (Computer Concepts) or have equivalent knowledge of computer concepts. This

class starts Monday, July 6.

• **DG/PC'I Systems Programming: Tips, Techniques, Pitfalls (SM525)** - This three-day seminar provides hands-on experience in NETBIOS Programming under Data General's XODIAC Transport Service (XTS), and Workstation Transport Services (WTS). Lab exercises include a sample file transfer program using the C Language. Prerequisites for this seminar are DC131 (Intro to Data Communication), S145 (Intro to MS-DOS), and an assumed knowledge of PC'I configuration and functions. This course begins Monday, July 6.

• **AOS/VS System Manager (S219/VS)** - Employees new to AOS/VS system management will be given the opportunity to learn how to install, generate, maintain and manage AOS/VS on an ECLIPSE MV/Family computer system. The prerequisite for this five-day course is S209 (AOS and AOS/VS User) or equivalent experience. This class also begins on Monday, July 6.

• **Introduction to Data General 32-Bit Computer Systems (H100/MV)** - The evolution of Data General's computer architecture from a 16-bit to the 32-bit design used in the ECLIPSE MV series is presented in this intensive ten-day course. It explains the terminology of virtual storage systems; provides an overview of mass storage devices, terminals, printers and data communications. A knowledge of general computer design concepts, digital circuitry, and number conversions is needed for this class, which begins on Monday, July 6.

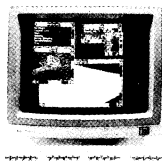
