### New Member Added To ECLIPSE MV/Family

Data General has introduced the ECLIPSE MV/1400 DC computer, bringing the power of 32-bit computing to as few as two users at a price of under \$9,995. This includes the central processing unit, 4MB of main memory, office packaging, a 38-MB Winchester disk, and a floppy diskette.

The new system, packaged in a compact under-the-desk unit, is geared toward customers in distributed data processing, departmental office automation and small business environments.

The company also has made enhancements to the ECLIPSE MV/2000 DC computer and DS/7500 graphic workstation that double the base memory of the systems to four MB from two MB. The new system boards on the ECLIPSE MV/1400 DC, the DS/7500 and ECLIPSE MV/2000 DC computers now use 1 megabit DRAMS for the first time ever on Data General low-end products.

"For many of our customers, the system represents a logical migration path from our 16-bit DESKTOP GENERATION multi-user systems to the entry level of our powerful, more fully featured 32-bit product line," says Dave Lyons, Group Marketing vice president. Dave adds that "Due to the ease in upgradeability of the ECLIPSE MV/1400 DC from the DESKTOP GENERA-

TION product line, its higher level of system performance, and a variety of operating system right-to-use licenses to choose from, this product represents an especially significant announcement for Data General resellers."

### Happy Customers

The new system has been installed at two customer sites: Agency Datasystems, a Data General Authorized System Distributor, and Beneficial Corporation.

Agency Datasystems, a subsidiary of American Airlines' SABRE Travel Information Network, provides information services to travel agencies. Beneficial Corporation is the nation's largest independent consumer finance company.

Terrell Jones, vice president of product development for SABRE Travel Information Network, states, "Preliminary evaluation of the unit indicates that it is a fully-compatible extension of the ECLIPSE MV/Family, and the price point dramatically lowers the system entry cost for Agency Datasystems customers."

Commenting on Beneficial's success with the ECLIPSE MV/1400 DC, Robert Hantak, vice president of Information Systems for Beneficial Corporation, remarks, "The ECLIPSE MV/1400 DC offers performance and configurability at a compelling price. While the ECLIPSE MV/2000 DC will continue to be our principal system for branch automation, the ECLIPSE MV/1400 DC system extends cost-effectiveness to our smaller offices. Beneficial will now be able to support the same application software for even our smaller branches with the same cost per user as the larger branches. On that basis, the ECLIPSE MV/1400 DC will become part of our plan to control administrative costs and enhance productivity throughout our 1100 offices in the U.S., U.K. and Canada."

### **Fund Transfers**

Participants in the Savings and Investment Plan can transfer all, or part, of their account balance from any investment fund(s) to any other investment fund(s) at the start of any calendar quarter. However, a transfer cannot be made more than once every six months (every other quarter).

If you would like to transfer funds for the calendar quarter beginning October 1, you must complete the Fund Transfer portion of the Savings and Investment Enrollment/Change form and return it to the Benefits department in Westboro no later than Friday, September 18. All transfers will become effective October 1.

The transfer of funds will not affect your future contributions. If your intention is to have all contributions after October 1 directed to a different fund or funds you must also complete the Investment Election portion of the form.

Enrollment/Change forms are available from your Human Resources representative, local Benefits department or the corporate Benefits department in Westboro.

### **Enrollment And Change Deadlines**

**Friday, September 18**, is the deadline for submitting all new enrollments and quarterly contribution changes to the Savings and Investment Plan. The enrollment forms (used for new enrollments, changes and fund transfers) must be returned to your local Benefits department by Friday, September 18, for enrollments/changes effective October 1.

## **Training**

Educational Services is offering the following courses in September. Prior approval of your supervisor is required for course registration. Call (tie line) 221-1647 to enroll in these classes or other classes. All classes are held at the Education Center at 2400 Computer Drive in Westboro.

- **CEOWrite and CEO CONNECTION (OA154)** - This interactive, intensive workshop will acquaint employees with the features, terms and functions of the CEOWrite word processor and its CEO CONNECTION to a host computer system. CEO word processor experience and typewriter keyboard experience is needed to take this three-day class, which starts Tuesday, September 8.
- **WordPerfect Word Processing (OA180)** - This three-

day course teaches the features of the WordPerfect word processor and how to install it. Editing, merges, formatting, and using the HELP function are a few of the topics which will be discussed. This class begins Monday, September 21.

- **AOS/VS Operator Training (SH109/VS)** - AOS/VS system operators will learn effective operation of Data General's AOS/VS-based system which includes startup, shutdown, monitoring, creating macros, error recovery and communicating with the operating system using CLI. Employees who have taken S100 (Computer Concepts) or have a functional knowledge of computer concepts are eligible for this five-day course. This class begins Monday, September 21.

- **Introduction to Data General 16-Bit Computer Systems (H100)** - This maintenance course teaches the Data General basic instruction set, standard and virtual console operations, and I/O operations. It also provides an overview of Data General mass storage devices, as well as Data General communications terminology. A knowledge of circuitry, number conversions, Boolean Concepts and oscilloscope usage is needed to attend this ten-day class, which begins Monday, September 21.

- **ECLIPSE MV/7800 Series Field Maintenance (H158)** - This course teaches employees how to install and configure a Data General ECLIPSE MV/7800 series computer system; load and run diagnostic programs; and perform system maintenance. This class also introduces the ECLIPSE MV/7800 series 32-bit architecture, power subsystem, SCP operations, upgrade procedures, and removal/replacement procedures. This five-day class begins on Monday, September 28.

## **Toastmasters' Meetings To Resume September 9**

Employees also should realize that Data General telephone directories are considered to be confidential information. Telephone directories should not be removed from Data General offices for any reason.

## Data General Clubs Support Team Spirit

Data General employees work hard. But they play hard, too.

According to Richard Lawler, Employee Activities administrator, Data General has nearly a dozen clubs operating for employees in Westboro, Southboro and Milford. These clubs have all been started, and are primarily sponsored by, employees.

"We have a number of sports-related clubs, in addition to groups with other interests in mind," Richard says. "Our softball league is our biggest club, with 32 teams and nearly 600 employees participating from Westboro, Southboro and Milford. We also have leagues for basketball, bowling, golf, ultimate frisbee, running, Wallyball, a ski club, a ski team, and aerobics.

"We have non-sports-related groups, like the Toastmasters and the radio club, as well."

Each employee participating in a club must comply with a charter established by each club. And before a club can get off the ground, it must submit the charter and a budget to the Employee Activities Committee, which in turn evaluates each club's request to be recognized as a group.

"It is not the mission of the Employee Activities Committee to provide complete financial support for these groups," Richard says. "Rather, we help defray some of the costs of running these organizations. They have to want to support the group with their time, as well."

The most important aspect to remember, however, is the true purpose of these clubs. The importance rests on the value of team spirit.

"These clubs enhance employees' time here at Data General," Richard says. "Employees can get together for non-work activities which encourage a common interest. These clubs provide another chance to get to know the people with whom you work.

"Everyone is a volunteer, also. People participate because they share an interest, and they want to further that interest. These clubs encourage employees to work, and play, as a team."

### Dasher Road Race Holds Employees' Interest

The Dasher Road Race began when Data General was 13 years old, in the fall of 1981. Then, the event was called "The Lucky 13," and was seen as a one-time race to celebrate the company's thirteenth year. The following year, however, those plans changed primarily due to the amount of interest generated by the first race.

"In the spring of 1982," remembers Betsy Anderson, a member of the Dasher Race Committee, "the race

became the Dasher, with an event in the spring and fall. The current format - two running races, a bicycle race, and a biathlon - was adopted. The number of participants has increased, and now we average nearly 200 employees per race."

According to Eric Engberg, chairperson of the race, the Dasher draws employees from several facilities, including Durham, Portsmouth and the Cambridge office, as well as Westboro, Southboro and Milford.

"The Dasher provides a great opportunity to get to know other employees, in a non-work environment," Eric says. "Participants get another perspective of the people with whom they work. The event generates a sense of camaraderie, a sort of 'I am part of Data General' feeling. The race is something to share with other employees."

Betsy emphasizes that the race is, and has always been, for every employee of every level of ability.

"We encourage everyone to participate, whether you run 5-minute miles or 15-minute miles," she says. "We have invited employees interested in walking the three-mile course to participate. And the race is a nice spectator event, also."

The Dasher Race Committee does need volunteers to help with the event. Volunteers are asked to attend to the water tables set up along the race course, act as a race marshal or help with the finish line activities. A meeting for race volunteers will be held at 4:00 p.m. Thursday, September 10, in the deli in Westboro. All volunteers will receive official Dasher t-shirts.

## Benefits Brief

### Scholarships Available To Employees' Children

This second in a series of monthly Benefits Briefs looks at the Data General National Merit Scholarship program, which was established in 1979 for the children of Data General employees. The annual awards are made by National Merit Scholarship Corporation (NMSC), an independent, nonprofit organization which identifies and honors academically talented high school students and aids as many as possible in obtaining a college education. NMSC handles the selection of the ten annual Data General National Merit Scholarship winners and the administration of their awards. Since the program's establishment, 72 Data General Scholarships have been awarded to the children of Data General employees.

### ***Who Is Eligible To Participate In The Program?***

High school students who will be completing or leaving secondary school and entering college, who are U.S. citizens, and who are sons or daughters of full-time Data General employees are eligible to compete for these scholarships. Participation requirements established by NMSC for entering the competition are explained in the 1987 *PSAT/NMSQT Student Bulletin*, which is to be distributed to students through their schools prior to the qualifying test administration.

### ***How Do Students Enter The Data General Scholarship Program?***

To enter the competition for the Data General National Merit Scholarships to be awarded in the spring of 1989, students who will complete high school and enter college in 1989 should make arrangements with their high school guidance counselors *immediately after the beginning of the 1987-88 school year to take the PSAT/NMSQT*. The test will be given only on October 17 or October 20, 1987, whichever date the school has selected for the test administration. The PSAT/NMSQT measures verbal and mathematical reasoning abilities important in college work and requires one hour and 40 minutes testing time. The fee for the 1987 PSAT/NMSQT is \$5.25 per student and will be collected by the high school.

Students who are completing grades 9 through 12 in the usual four years must be 11th graders (juniors) when they take the PSAT/NMSQT. Students who accelerate the high school program to enter college early should refer to the 1987 *PSAT/NMSQT Student Bulletin*, which explains in detail when students should take the test.

### ***How Are The Winners Selected?***

All 1989 Data General National Merit Scholarship winners will be chosen by NMSC from among employees' children who are qualified candidates. Any child of a Data General employee who will be completing high school and entering college in 1989 should submit an entry form directly to the company in addition to taking the 1987 PSAT/NMSQT. A 1989 entry form may be obtained by request from the Corporate Benefits department or local Human Resources department on or after October 1, 1987. These forms should be completed and returned to the Corporate Benefits department by December 1, 1987.

A group of candidates who score high on the PSAT/NMSQT will be notified in December 1988 that they may receive further consideration for a scholarship by meeting certain standard requirements set by NMSC. These students and their high school principals complete applications that include biographical and academic information that must be filed with NMSC. Scholarship winners will be selected on a competitive basis and without regard to family financial circumstances. An impartial NMSC committee of professionals trained in

selection will choose the winners by evaluating each eligible student's academic record throughout high school, qualities of leadership and extracurricular accomplishments, test scores, the school's recommendation of the candidate, and the student's self-description of interests and goals. In most cases, winners will be notified in March 1989, prior to any public announcement that may be made.

### ***What Is The Amount Of The Award?***

The stipend of each Data General National Merit Scholarship is determined individually by NMSC and can range from \$500 to \$2,000 per year for up to four years of college undergraduate study or until baccalaureate degree requirements are completed, whichever occurs first. The amount of the stipend takes into account both educational costs of the college to be attended and family financial circumstances. NMSC may increase or decrease the winner's annual stipend, within the minimum and maximum limits set for the scholarship, after considering other scholarship aid, a college transfer, and/or significant changes in family finances.

### ***What Are The Obligations And Responsibilities Of The Winners?***

The formal scholarship offer sent to winners by NMSC specifies terms for acceptance and continuation of the award. The Data General National Merit Scholarship winner is completely responsible for making arrangements and fulfilling all requirements for admission to a college or university in the U.S. that holds accredited status with a regional accrediting commission on higher education. The winner must enter college in the fall term following selection and must enroll as a full-time undergraduate student attending college during the day; the recipient must remain in good academic standing and pursue a course of study leading to one of the traditional baccalaureate degrees.

### ***Who Handles Scholarship Procedures?***

All phases of the competition, including the selection of winners and payment of scholarship stipends are handled for Data General by NMSC.
