Traffic Puts Area In A Jam

Being "stuck" in traffic until lately may have been experienced only by people traveling east toward Framingham or going to Cape Cod on a summer weekend. Yet, rush hour traffic jams on Rt. 9 and along Computer Drive/Research Drive have become just as serious over the last year. Data General along with other industrial neighbors is making an effort to do something about it.

Last month, Data General representatives met with the Westborough Board of Selectmen and Planning Board to review the problem and a variety of solutions. The meeting drew an overflow crowd of town residents and Data General employees. As a result, the town

officials have invited Data General to review the situation again at a special town meeting to be held on Tuesday, May 17 at 7:00 p.m. at the Westborough High School auditorium. The meeting was scheduled so that the traffic issue can be reviewed before a large cross-section of the town's residents. The session is open to the public. Data General employees interested in the traffic matter should be sure to attend.

During their presentation before the town officials, Brad Stroup, director of Public Affairs, and Bob Capobianco, an outside counsel representing Data General, painted a picture of traffic in this industrial area that was anything but rosey. They noted that traffic volumes along Computer Drive and Research Drive already are straining the roadways' capacity and drivers' patience. They took the Selectmen on a journey to the future and projected what this area would look like by the middle of the next decade, based on approved site plans, after the Westborough Business and Westborough Technology parks are completed.

"The purpose in going to the town was simple," says Brad. "Along with our neighbors, Data General is concerned for the safety of employees. We believe action must be taken to reduce the hazard of going to and from work. We believe it is a community problem that needs the attention of all citizens, not just employers and abutters. We are asking the Town of Westborough to take a leadership role in solving a situation we all face."

In his presentation to the the Westborough Selectmen, Brad noted that more than 5,000 vehicles now travel along Computer Drive/Research Drive during the morning and afternoon commute times. Those vehicles are driven by employees of Data General, New England Electric, GTE, Central New England College and firms in the Westborough Business and Westborough Technology parks.

Local businesses so far have not had employees suffer a serious health emergency during rush hours. "With the traffic tie-ups on these roads," says Brad, "it would be difficult to get an emergency vehicle into the area to help an employee, especially in the winter."

Today's traffic, however, will be nothing compared to what this area may look like, unless action is taken.

"Once the developments now planned are occupied by 1995, there can be twice as much office space in

this area," says Brad. "The number of vehicles during peak times will be between 11,000 and 17,000, according to the density of office space occupied. That is two to three times the traffic today."

Solutions Considered

State and local civic, governmental and planning agencies all have expressed concerns and conducted studies on ways to relieve traffic congestion along Rt. 9. But, no proposals have been made to solve the problem.

In the past, the following plans have been suggested by businesses, and local and state agencies. Each has its limitations. Some are impractical.

- Flextime - already in effect among employers.
- Car pooling - about 10 percent of employees already use it.
- Ramp widening - completed in 1983.
- Mass transit - minimal now, not a help due to the diversity of employee residences.
- Traffic signals or officer on scene - traffic signals are probably counterproductive, control officers might help.
- Traffic loop around Rt. 9 - rejected by state Department of Public Works, too expensive.
- Slip ramps to Rt. 495 - causes further traffic tie-up, federal opposition.
- Access to Rt. 30 - Data General proposal abandoned due to community opposition.

Access To Rt. 30

More than a year ago, Data General began a study on the possibility of constructing a driveway to Rt. 30, which lies north of Buildings 14A/B and runs to Westborough, Southborough and points beyond. This could relieve congestion from Data General traffic, but would require a number of approvals from residents, abutters, and several community and state agencies. The plan eventually was abandoned after strong opposition from local residents on Brady Rd. and Smith St.

"We estimate that 25 percent to 30 percent of our employees use Rt. 30 now," says Brad. "Direct access to Rt. 30 would serve to reduce the overcrowding on Rt. 9 until a longer-term solution is available."

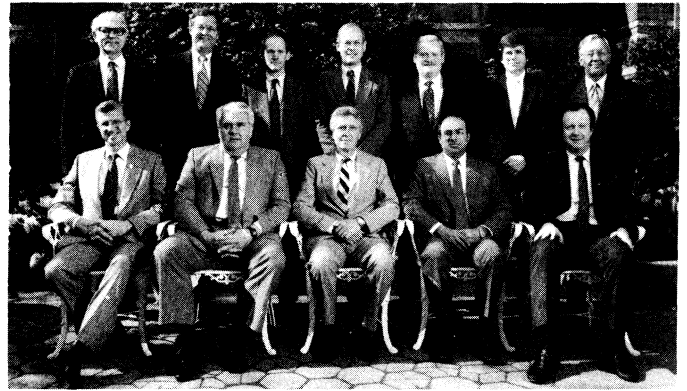
Data General would pay for the driveway cut to Rt. 30 and other expenses. Brad told the Board of Selectmen and Planning Board members that the company would be willing to donate to the town the land necessary to build a road if the town wished to pursue the project by right of eminent domain.

Such a project, Brad says, would increase Rt. 30 traffic going through Westboro (east) and Southboro, unless access to Rt. 495 was provided.

The traffic situation in this area and industry's interest in reaching a solution has sparked both interest and concern among local residents. Many oppose the company's idea for a driveway to Rt. 30. At the same time, the presentation impressed upon the town offi-

cial the severity of the traffic tie-ups in this area. Members of the Board of Selectmen agreed on the serious nature of the problem and expressed interest in working on a solution.

Data General Supports OSI

Data General joined 11 other high technology firms at a press conference in New York City last week to announce that it will make the Open Systems Interconnection (OSI) standard the way it will support multi-vendor networking in the future. Other firms announcing support for the OSI standard are: AT&T, Control Data, Digital Equipment, Hewlett-Packard, Honeywell, IBM, Sun Microsystems, Telenet, Unisys, Wang and Xerox.

Bob Tway, vice president of Eastern Operations, Don Tocher, director of the Data Communications and Networking Division (DCND), and Agnes Imregh, a senior manager within DCND, represented Data General at the press event which was sponsored by the Corporation for Open Systems (COS). COS was founded in 1986 to accelerate the introduction of multi-vendor interoperable products and services based on OSI and ISDN (Integrated Services Digital Network). Data General is a very active senior research member of COS.

Speaking on the economic impact standardization will have on business and industry worldwide, economist Murray Weidenbaum says that "the open systems movement is a heartening example of private-sector initiative." Weidenbaum heads the Center for the Study of American Business and is a member of President Ronald Reagan's Economic Policy Advisory Board. "OSI-based standards provide a platform for innovation, for opening new markets, and for increasing productivity."

Weidenbaum says that standardization creates a more competitive marketplace for computer and communications products and services, one in which users can make purchasing decisions on the basis of quality and performance, not on connectivity.

Employee Referral Program Makes Colorful Entry

Data General's new employee referral program offering extra large bonuses for experienced Sales, Systems Engineering and product development people is being promoted in colorful "New Wave" posters around the company.

Employees who make a referral get their own copy of the New Wave artwork which was designed specifically for Data General by Boston artist Lizi Boyd. Lizi, who started her career as a potter in Vermont, spent eight years in New York before coming to the Boston area. Her work has been displayed at the Museum of Modern Art in New York, and she is the author and illustrator of several children's books.

When a person who was referred is hired, the Data General employee receives a \$1,000 bonus. For the second person hired, the bonus is up to \$2,000 and for any additional referrals, the bonus is \$3,000.

Need To Order Nameplates?

The Purchasing department has set up a blanket purchase order with the Hartnett company for all requisitions for nameplates under \$50. Nameplates are one-inch by six-inches with white lettering on a wood-grain background with magnetic backing, which are to be displayed on office walls. The cost for each is \$4.50. Requests for nameplates should be processed in one of the following manners:

Requisitioners who are authorized to order supplies on-line from the stockroom may order nameplates via CEO by sending a message to Jeanne Bilodea at host system SIR. Employees requesting nameplates should include name, badge number, cost center, mail stop and a list of the names to be put on the nameplates.

Requisitioners not authorized to order on-line from the stockroom (or requests for more than 11 nameplates at one time) should order nameplates on a requisition through the Purchasing department.

Nameplates should arrive approximately two weeks after receipt of the order.

Use CEO For Travel Arrangements

Employees should use CEO to make business travel arrangements with Corporate Travel Services in Westboro. Contact ADM Travel:IMG006 to obtain a fill-in-the-blank CEO travel request form.

For travel taking place within 48 hours, the Corporate Travel department will confirm employees' CEO travel requests within approximately two hours. For travel taking place beyond 48 hours, employees' travel requests will be confirmed via CEO the following morning.

The class teaches the programmer how to write application programs for data in a DG/SQL relational database. This five-day course begins, Monday, May 23.
- **CEO 3.0 User (Including CEOwrite) (OA302E)** - This course acquaints participants with the CEOwrite word processor (features, terms and functions) under AOS/VS. This three-day course, which is a special offering for employees, begins Wednesday, June 1.

Today's The Day - Check New Race Routes

The Dasher races will be held today. Participants in the 11-mile bicycle time trial race are asked to gather at **5:05 p.m.** at the rear of Building 14A in the east corner of the north parking lot. You will then ride as a group to the new start on Lyons Street, where the race will start at **5:20 p.m.** The 3-mile and 10K foot races will start at the usual starting place in the back parking lot at **5:30 p.m.**

Note: At 5:20 p.m., all outgoing traffic will be diverted through the 2400 Computer Drive access road. At the start of the foot races, all vehicles will be asked to stop until all the runners have passed.

A map of the routes is included in this week's **Mini News**. Copies of the map are also posted on bulletin boards in Data General buildings.

3-mile foot race: Runners will start in the rear north parking lot and head off behind Buildings 14A and 14B, past the access road to 2400 Computer Drive, out the main driveway onto Computer Drive. At the end of Computer Drive, turn left (staying outside the traffic island and always on the right side of the road) and cross the bridge over Rt. 9. Run down the hill to the turn-around point - there will be a course marshal standing there to show you where to turn. Go back up the hill, turn right onto Computer Drive, run up Computer Drive and turn left into the main entrance. Run straight back to the rear of Building 14A, and finish where the race began.

10K foot race: Follow the 3-mile route to the turn-around and turn around. Go back up the hill to the intersection at the end of Computer Drive (up until this point the course is identical to the 3-mile course). At the intersection continue straight ahead bypassing the Jersey barrier on Lyons St. around the right end. Continue down Lyons St. and turn right on Rt. 30 at the end. Go east for 1-1/4 miles on Rt. 30, then take a sharp right onto High St. Follow High St. up over the hill and back down to Rt. 30. Turn left and follow Rt. 30 for 1/4 mile and turn left onto Brady St. Go 1/10 mile and bear right, and after another 1/10 mile turn left onto Hillcrest. Go UP the HILL and turn right on Crestview. Go 2/10 mile to the end of Crestview and turn left onto Lyons. Go past the Jersey barriers again and turn left on Computer Drive. Run the length
