Revenues And Earnings Up

Data General this week announced increased revenues and earnings for both the fourth quarter and fiscal 1983, which ended September 24.

For the year, revenues of \$828.9 million represent a three percent increase over 1982 revenues of \$805.9 million. Net earnings of \$23.1 million, or \$1.93 per share, compare to last year's earnings, before extraordinary gains, of \$19.9 million, or \$1.83 per share. Fiscal 1982 earnings after extraordinary gains were \$24.7 million, or \$2.28 per share.

Data General's income from operations (revenues less expenses, before other income/expense and before taxes) for the year was \$36.5 million, compared to \$35.9 million last year.

Fourth Quarter

Revenues for the 16-week fourth quarter were \$271.8 million compared to \$251.8 million last year. Earnings during the period were \$10.7 million, or \$.86 per share, compared with net earnings of \$580,000, or \$.05 per share, for the same period last year. Income from operations for the fourth quarter was \$16.2 million, compared with \$130,000, 0.1 percent of revenues for last year's fourth quarter.

The improved fourth quarter over last year is attributed to a moderate improvement in equipment sales and continued successful cost containment efforts.

"We have seen a steady, though moderate, improvement in orders," says President Ed de Castro. "I believe the improvement can be attributed both to the excellent reception for our new products and to the general improvement in the economy.

"We are particularly pleased with the acceptance of our 32-bit superminicomputer systems, our desktop computers and our office automation offerings.

"Our current product offering is the most competitive it has ever been and I believe we are well positioned for future success."

Two-For-One Stock Split

Data General has declared a two-for-one stock split payable on November 18, 1983 to stockholders of record on November 7, 1983.

The split comes in the form of a 100 percent stock dividend on Data General's common stock, \$.01 par value. This increases the company's outstanding shares to 22.6 million from 11.3 million. As a result of the split, net earnings per share for the 1983 fiscal year would be \$.96 as compared with net earnings before extraordinary gains of \$.92 for the prior fiscal year calculated on a similar basis.

Because of the two-for-one stock split, the opening day (August 1, 1983) price of the current Employee Stock Purchase Plan period will be \$28.25. Stock options will double in terms of number of shares and options prices will be halved.

Data General Debuts On The Airwayes

A series of three commercials describing the advantages of Data General computers debuted this week on television stations in Boston, New York City, Washington, D.C., Chicago, San Franisco, Los Angeles, Dallas and Detroit.

The commercials, which will appear regularly throughout the fall, complement advertisements which have been appearing in trade and business publications.

Next week, the commercials will be telecast on Boston television stations during the CBS, ABC and NBC national news at 7:00 p.m. and the local late night news at 11:00 p.m. on channels 7, 5, and 4. In addition, the commercials can be seen during:

Ada Marketing Group Formed

An Ada Marketing Group, responsible for addressing the requirements of the government and technical marketplaces, is being formed within the Technical Products Division (TPD).


Lee Ehrlichman has been named manager of the Ada Marketing Group, reporting to Don McDougall, TPD vice president and general manager.

Ada - trademarked by the U. S. Department of Defense - is expected to become the single computer language for all branches of the military by 1985. In May of this year, Data General, in agreement with Rolm Corporation, introduced a family of software development work centers for Ada programs based on ECLIPSE MV/Family computers. The Data General Ada compiler subsequently became the first from a minicomputer manufacturer to be validated by the Department of Defense.

Lee was most recently marketing manager for the Japanese Business Development group. Prior to that, he was a Sales branch manager and sales representative. He joined Data General in 1977 from Burroughs Corporation.

Lee has a bachelor's degree in psychology and a master's degree in marketing from the University of Arizona.

Helping Data General Comply

Their rallying cry was October 1, 1983, and as far as they ever were concerned, that's all that had to be said.

For the past three years, employees from throughout Manufacturing, Peripherals Development, Marketing, the Systems Development Division, Special Systems, Engineering Services and Support, and Field Engineering have been striving to help Data General meet the Federal Communications Commission's (FCC) regulations for the level of electromagnetic and radio frequency interference that can be emitted by computer products. When the regulations were adopted in 1980, the government agency set October 1, 1983 as the deadline for which all manufacturers had to have their existing products comply.

The interference caused by electronic equipment can disrupt video as well as audio signals.

With October 1 now four weeks past, the project was accomplished with flying colors as 54 different products have been "hardened" to meet the regulations. "That," says Dean Sasek, a Manufacturing program manager, "is an accomplishment which everyone associated with this project can take a great deal of pride in. We achieved our goal and have made our products even stronger for it."

According to Dean, cables, chassis and other assemblies which go into Data General computers and peripherals are taking on a different look to insure they comply with the FCC regulations. "For instance," says Dean, "cables are packaged differently and are now double shielded in foil and braid."

Another advantage for Data General, says Dean, has been a streamlining of its product line. "Some older equipment which had sold at low volume was not modified and dropped from our product line."

In appreciation for their outstanding achievements, more than 150 employees from Westboro, Southboro, Milford and Westbrook were honored last week for helping Data General conform. "T-shirts and plaques were presented to all contributors," says Dean. "But more imporantly, the event was really an opportunity to just say thanks to everyone who worked on the project. They did a super job."


tion. He holds an MS in computer science from West Coast University and an MS in electrical engineering from Moscow Electrotechnical Institute.

Savings & Investment Plan Participants Watch Your Mailbox

During the first week in November, the quarterly statement for the Data General Savings and Investment Plan will be mailed to the home of each actively participating employee. The statement will reflect your account activity for the period of July 1 through September 30, 1983.

The personalized statement will illustrate the following items in detail:

- The opening balance as of July 1 in each Fund (Guaranteed Income, Balanced and Equity). This amount should be the same as the June 30 closing balance shown on your previous quarterly statement.
- 2. Contributions made to each Fund during the quarter, any loans you have taken from your account balance and corresponding loan repayments, and amounts withdrawn during the quarter.
- 3. Earnings or losses for each Fund during the quarter and the total closing balance as of September 30.
- 4. The percentage of salary you contributed and the investment options you selected during the past quarter.

There are several points you should keep in mind when reviewing your quarterly statement. First, the closing balance on the quarterly statement will not be the same amount your paystub reflects as your contributions. Your paystub does not reflect the investment experience, loans or withdrawals.

Secondly, earnings are from *Date of Deposit*. Contributions made in August will begin earning interest from the date of deposit, not from July 1. The Guaranteed Income Fund is the only investment option which guaranteed a specific rate of earnings. That guarantee is 12.5% *Annually*. This statement will only show the total amount you have earned in each fund for the quarter ending September 20, 1983.

You will receive a statement for this quarter if you have participated in the program at anytime since April 1. If you should have received a statement, but did not, check the address on your paycheck to see that it lists your current mailing address. Your

supervisor can assist you with updating your address.

How To Estimate The Value Of Savings & Investment Funds

The Data General Savings and Investment Program, introduced in April, consists of three investment funds - a Guaranteed Fund, a Balanced Fund, and an Equity Fund. With approximately 60 percent of all employees participating in the program, there has been tremendous interest in how to estimate current value of investments.

For estimating the value of all three funds, employees should use their most recent quarterly statement as a starting point. The current statement for the quarter ending September 30, 1983 will be received before the end of October.

Guaranteed Fund

It's relatively simple to estimate the growth of a fixed return investment such as the Guaranteed Income Fund, which currently has a 12.5% annual return.

- 1 Multiply the balance from the most recent statement by one-twelfth of the annual rate for each month's growth.
- 2 Add the result to the previous statement date.
- 3 Add your contributions since the statement date.

For example, if you had a \$300 balance on September 30 and made additional contributions of \$50 in October, your balance on October 30 is \$300 plus \$3.00 (1/12 of 12.5% annual return) plus \$50.00, or \$353.00. This does not reflect interest on October contributions.

Balanced & Equity Funds


It's not quite as simple to estimate the current value of the Balanced or Equity Funds. While your quarterly statement is accurate, it is only the value on that particular day. The value may then change up or down daily. The accompanying charts show, graphically, how the share prices of the Balanced Fund and the Equity Fund have fluctuated from April through September, 1983.

You can estimate the approximate value of your account at any point in time by following these steps:

Step

Take your account balance from your most recent quarterly statement and divide it by the share price on that day. This gives you the approximate number of shares on the statement date.

(On September 30, the share price (Net Assest Value - NAV) of the Balanced Fund was \$14.96. The share price of the Equity Fund was \$11.84)



Step 2

Check the current price of funds in the Mutual Funds listing in the business pages of a daily newspaper. The funds are under PUTNAM. Our Balanced Fund is the GEORGE fund. Our Equity Fund is the INVESTORS fund. The share price for that day for each fund will be listed.

Step 3

Multiply the number of shares from Step 1 by the current share price from Step 2. Add to this the amount of your contributions since the last statement. The result is an approximate current value of your account. The only thing it does not reflect are a gain or loss on contributions since the last quarterly statement, and the value of reinvested capital gain or dividend distributions.

For example, let's estimate the current value of an employee's Equity Fund on October 10 assuming a September 30 account balance of \$453.45 and contributions from September 30 to October 10 of \$56.38.

Step 1: Account balance of \$453.45 is divided by September 30 share price of \$11.84 equals 38.3 shares.

Step 2: The October 10 share price is \$12.38

Step 3:	The number of <i>shares</i> on September 30	38.3
	is multiplied times the October 10 price	x \$12.38
	The result	\$474.15
	is then added to contributions	
	made since September 30	\$56.38
	for an approximate account balance	\$530.53

Compare the approximate account balance to your total contributions to date to determine the investment performance of the fund. You should be aware that Mutual Funds, as any other investment in the stock market, will fluctuate daily, up or down. This is the risk you take when buying stock.
