The Advanced Operating System/Virtual Storage (AOS/VS) BASIC now offers both the productive program development capabilities of an interpreter and the machine efficiency of a compiler.

The new AOS/VS BASIC compiler is intended to be used with the interpreter. Programs execute up to 100 times faster when compiled than when interpreted.

The price of the AOS/VS BASIC compiler ranges from \$3,600 to \$7,000 depending on the model and system configuration.

The first group of dealers selected to sell Data General's DESKTOP GENERATION Model 10 and 10SP computers has graduated from the company's intensive training program.

More dealers are being trained this month, and a training program also is underway for technicians who work for the dealers.

The Computer Museum in Marlboro closed last week to begin moving into expanded quarters at Boston's Museum Wharf, with reopening scheduled for late next summer.

The Computer Museum is a public, non-profit foundation dedicated to preserving computer history. Data General is a corporate founder and President Ed de Castro is a personal founder of the museum. One of the first NOVA computer central processing units made by Data General is featured at the museum.

In addition to its exhibits depicting the various generations of computer history, the museum has sponsored a lecture series that has featured Tom West, Systems Development Division vice president, and Tracy Kidder, author of "The Soul of a New Machine." The museum also includes a store which sells a variety of items related to computers, such as books and integrated circuit jewelry.

While the museum itself has closed, the Computer Museum Store will remain open through December 23 and a final lecture will be held next week.

#### Upcoming Dates To Remember

**Transferring Funds? -- Forms Due December 9** One of the many features of the Data General Savings & Investment Program is the ability to transfer account balances from one investment fund to any other investment fund or funds, on January 1 each year.

To transfer monies from one fund to another is easy. Simply, complete a Fund Transfer form and return it to the Benefits department in Westboro (D138) no later than Friday, December 9. Fund Transfer forms are available in your Personnel or Benefits offices.

The transfer form will only affect the direction of contributions made PRIOR to January 1. The form allows up to 100% of the December 31, 1983 balance to be moved to the fund or funds of your choice. All transfers become effective January 1, 1984.

# December 16 Deadline For Enrollment and Changes

Informational material describing the Data General Savings & Investment Program has been mailed to the homes of employees who will be eligible to enroll in the program for the first time. To be eligible, you must complete 90 days of employment with Data General before January 1, 1984.

Each year Data General makes a company contribution in the form of stock to employees who have at least six months of service and are employed on December 31. Therefore, the beneficiary section of the enrollment form must be completed and returned whether or not you choose to actively participate in the program at this time.

If you currently are enrolled in the program and would like to change the percentage of pay set aside each pay period or change the investment elections for future savings deductions complete and return the form.

January 1, 1984 is the effective date for new employee enrollments and for changes elected by active participants. The next opportunity to participate or to elect changes will be April 1. Send completed forms to your local benefits administrator no later than Friday, December 16.

#### **Any Questions?**

The Data General Savings & Investment Program allows employees to save a portion of their pay (up to 10%) before income tax is withheld.

#### Scholarship Applications Due December 16

December 16 is the deadline for submitting applications for the 1985 Data General Scholarship Program. Each year Data General awards six scholarships to children of Data General employees. Eligible applicants are employees' children graduating from high school in 1985 and planning to enter a U.S. college or university that same year. Applicants must have taken the Preliminary Scholastic Aptitude Test/National Merit Scholarship Qualifying Test (PSAT/NMSQT) given by all schools this past October.

Applications are available from your Personnel or Benefits office. Completed applications should be returned to the Corporate Benefits office (Westboro mailstop D138) no later than December 16, 1983. In addition to the company contribution and the loan and withdrawal provisions, there are three funds to choose from: The Guaranteed Income Fund which pays an effective annual rate of 12.5% until the end of 1984 (the interest rate for 1985 will be announced before January 1); or the Balance or Equity Funds.

#### Change In Auto And Property Insurance Coverage

Beginning December 31, 1983, Wausau Insurance Companies will replace Commerce Insurance Company as insurance carrier for the auto and property insurance payroll deduction program for Massachusetts residents. The change is a result of Data General's efforts to consolidate the program for all U.S. employees and Commerce's decision to withdraw from payroll deduction programs. Wausau currently provides insurance through the program to employees in all states outside of Massachusetts.

Briefly, here's how the change will affect participating employees:

#### Auto Insurance Coverage

Your auto insurance will automatically be transferred to Wausau on December 31, 1983 unless you notify the agent, Marsh & McLennan, before that date that you wish to make other arrangements. Wausau will issue you a new auto policy based on 1983 rates and payroll deductions will continue unless you choose to withdraw from the program. Your policy renewal date will then become December 31, 1984 regardless of your current anniversary date.

With the transfer to Wausau, there will be no change in the type of coverage you had selected and no increase in cost. Your premiums will still be based on the rates established by the Massachusetts State Insurance Department for 1983 **minus** the special 5% discount afforded to all Data General employees through this program.

If you would prefer to retain your Commerce coverage, you may -- but not through the payroll deduction plan. You may switch to individual coverage with Commerce at any time and you will be billed at your home address. Payment of any remaining premiums must be handled between you and Commerce. Contact Marsh & McLennan on Westboro extensions 4601, 4603 or 4607 for instructions on maintaining your current coverage.

#### **Property Insurance Coverage**

Your homeowner's, renter's or condo insurance coverage will continue to be insured by Commerce through payroll deductions until your next policy anniversary date. At that time, you may remain in the payroll deduction program by switching your coverage to Wausau, or you may continue your Commerce coverage on an individual basis.

You will receive a quote outlining the cost of the coverage through Wausau prior to the anniversary date. The coverage and premiums offered by Wausau are attractive, but may vary from your current cost. If you would prefer to remain with Commerce, contact Marsh & McLennan.

#### Additional Information

All Massachusetts employees currently in the payroll deduction program will receive a home mailing from Marsh & McLennan outlining full details and premium information for the new insurance arrangement. Marsh & McLennan will continue to service all aspects of the program. Direct all questions to their office in Westboro at extensions 4601, 4603 or 4607. New applicants also are encouraged. If you are not participating in this convenient payroll deduction program, contact Marsh & McLennan for details.

#### One Time Advance On Educational Assistance

To encourage employees to begin programs of continuing education, Data General is establishing a one-time loan provision as part of its Educational Assistance program.

Any employee with an approved course or program of study under the Educational Assistance program nay now be advanced up to \$500 or the total cost of fuition, books and fees, whichever is less.

This advance may be given only once and will be repaid through payroll deduction over a period of 16 weeks beginning in January . To obtain the advance, employees complete a Cash Advance Request and Tuition Advance Repayment Agreement. Both forms are submitted to the Travel and Expense office for payment.

"This benefit is designed to help employees start programs of study and to prevent the occasional disruption of a school program due to financial difficulties," said Don Bateman, vice president of Human Resources. "Following one quarter or semester of cash advance, employees should plan to continue financing their education with their educational reimbursement."

Employees needing more information on Data General Educational Assistance or a copy of the Tuition Advance Repayment Agreement should contact their Personnel Representative.

#### Streamlined Procedure For Approving All Educational Assistance

Effective immediately, Educational Assistance will have a streamlined approval cycle and quicker reimbursement process.

Final approval for courses will now be in the jurisdiction of the employee's supervisor and manager with divisional Management and Organizational

Development (MOD) departments only maintaining records.

Following successful completion of the course(s), all receipts will be attached to an Expense Report and submitted to Travel and Expense for reimbursement. A copy of the Expense Report and receipts will be submitted to divisional MOD.

Employees may obtain additional information from MOD managers or Personnel Representatives.

#### Educational Assistance Provides Full Reimbursement Up To \$3500

Data General's Educational Assistance program provides reimbursement of tuition, fees and costs for books and supplies up to \$3500 annually. The program for full-time permanent employees paid out \$1.2 million to more than 2000 employees in fiscal 1983.

Educational courses covered must be work related or part of a bachelor or associate degree program or part of an advanced degree program in a field of benefit to Data General.

The course or program must be approved in advance by the employee's supervisor and the Management and Organization Development department. Reimbursement of expenses is made following successful completion of the course.
