Data General Reports Third Quarter Results

Data General has reported third quarter revenues of \$285.5 million, compared with \$304.2 million in the prior year, a decrease of 6 percent.

The company also reported a net loss for the third quarter, which ended June 29, of \$8.3 million, or \$.32 per share, compared with an income before extraordinary gain of \$18.6 million, or \$.71 per share, for the same quarter last year. The tax rate for the quarter was adjusted to reflect a 31 percent year-to-date rate.

The loss from operations for the quarter was \$16.0 million, compared with operating income of \$28.6 million, or 9.4 percent of revenues, for the third quarter of last year.

The company had indicated in a June 17th announcement that a loss might occur. Contributing to the loss were lower than expected computer sales for the quarter, a previously announced inventory writedown of \$8.2 million to balance inventories and capacity with current product demand, and a workforce reduction of 1,400 employees which occurred in the third quarter. One-time severance costs for the workforce reduction were \$6.3 million and third quarter payroll costs for affected employees were approximately \$7 million.

Net income for the first three quarters of fiscal 1985 was \$23.8 million, or \$.90 per share, compared with net income of \$42.9 million before extraordinary gain, or \$1.67 per share, for the same period last year.

Total revenues for the first three quarters were \$939.4, compared with \$818.5 million revenues for the same period last year.

Operating income for the nine-month period was \$33.6 million, or 3.6 percent of revenues, compared with \$65.8 million, or 8 percent of revenues before extraordinary gain, in the prior year.

"We continue to experience order softness as most of the electronics industry, particularly among our industrial/manufacturing customer base," says President Ed de Castro.

"At current business levels, I expect the fourth quarter to show a small profit or loss. A shutdown of some of the company's Manufacturing operations, ranging from a few days up to two weeks, is probable in late August or early September. While we will continue to maintain stringent controls on hiring and costs, we will proceed with new product development, automation and capital investment plans as scheduled," Ed says.

Manufacturing Shutdown Probable

A shutdown of Manufacturing operations, ranging from a few days up to two weeks, is probable for late August or early September. The incoming order rate is not clear enough to allow a final decision to be made at this time.

As in the past, Data General recognizes the need to give employees as much advance notice as possible. But, since many employees no longer have vacation available and the personal impact of a shutdown is greater, the company will wait as long as necessary to determine the minimum amount of shutdown necessary.

During the shutdown, planned around the Labor Day holiday, certain critical Manufacturing functions will not be impacted. In addition, some locations may be affected to a greater degree than others.

DASHER/One Extends CEO Functionality

Data General has introduced new business automation products that integrate departmental and personal computing functions. The DASHER/One workstation is the first in a new series of intelligent workstations. CEOwrite is a powerful word processing software package that brings CEO Comprehensive Electronic Office functionality to the MS-DOS environment. An enhanced version of the ECLIPSE MV/4000 Departmental Cluster (DC) doubles the possible number of users to 32 and offers a cost-per-

workstation of less than \$5000, depending on the application.

The DASHER/One workstation is the key element in combining personal and departmental systems because it offers users stand-alone computing power with full CEO integration. With processing power at the DASHER/One workstation, users can run applications such as Data General's new CEOwrite word processing software and permit a departmental processor to be used for additional applications.

The DASHER/One supports the MS-DOS operating environment, which lets users implement specific business applications, such as word processing, data analysis or database management spreadsheets which run on the IBM PC. It provides all of the benefits of business automation at the personal level, including: applications support (for both horizontal and vertical software applications), communications support, and integration with larger systems at the departmental and corporate levels.

The DASHER/One is fully compatible with the ECLIPSE MV/Family of processors. As a workstation within a departmental cluster, the DASHER/One enables users to share peripherals, applications and information. The DASHER/One also is fully compatible with the DATA GENERAL/One portable computer.

With CEO CONNECTION software, DASHER/One users have instant access to CEO on a host computer or to MS-DOS-based IBM PC applications. The CEO CONNECTION also allows users to integrate DASHER/One workstations, the DATA GENER-AL/One, IBM PCs and larger corporate or departmental computer systems.

The DASHER/One is designed with a small desktop footprint, a tilt-swivel display and a 12-inch monochrome (green) monitor screen.

All DASHER/One models offer users a choice of two detachable, low profile keyboards: a PC AT-style keyboard or a CEO compatible-style keyboard. Both keyboards are available in a wide variety of foreign language fonts.

The DASHER/One is available in six models with varying amounts of memory and storage, which in combination with specific applications, provide solutions tailored to the requirements of a wide range of professionals.

The DASHER/One Model 1 workstation with PC AT-compatible keyboard is available 90 days after receipt of order, and with the CEO compatible keyboard is available 120 days after receipt of order. The DASHER/One Model 2 is available 180 days after receipt of order. Basic prices for a DASH-ER/One range from \$2100 to \$2415.

CEOwrite, a "next generation" word processing package, runs on the DASHER/One, the DATA GENERAL/One and the IBM PC as a stand-alone word processor or can be integrated with departmental and corporate CEO systems. CEOwrite costs \$395.

The ECLIPSE MV/4000 DC computer offers departments and businesses the power and performance of a 32-bit computer at a low cost. It provides up to 32 users with simultaneous access to an extensive array of information processing resource and can accomodate up to eight megabytes of mammemory and up to 240 megabytes of on-line data storage.

Upgrades are available for customers with ECLIPSE MV/4000 SC and ECLIPSE MV/4000 DC systems.

A typical ECLIPSE MV/4000 DC system, including four megabytes of main memory, 22 workstations, and CEO office automation software costs \$107,448. Deliveries are 45 days after receipt of order.

New Telephone Numbers Issued Next Week

A new phone service called Direct Inward Dialing (DID) is coming to Data General-Westboro in order to make the connection between outside callers and you faster and easier.

To familiarize employees with DID, information packets are being distributed via internal mail next week. Inside the packets will be background information, notification post cards and most importantly, your new seven-digit DID phone number.

Scheduled to kick-off Monday, August 19, DID will enable outside callers to contact a department employee at Westboro directly, without the assistance of a Data General operator. When a caller uses your DID number, the call will bypass the switchboard and be routed directly to you.

What's Your Number?

Your new DID telephone number will appear on the address label affixed to the outside of the information packet. Just peel the label off the envelope and affix it to your phone for easy reference.

Your seven-digit DID number is derived through a formula that makes use of your present internal phone extension. All DID numbers begin with the numbers "870". Then, to determine the remaining four digits of your DID number, add the number 3,000 to your present phone extension.

For example, if your current extension is 5432, your new DID number is 870-8432.

Send Postcards

Inside your informational packet are five postcards. These cards are designed to help you inform frequent outside callers of your new phone number. Additional cards are available as neede

In order to ensure the effectiveness of DID, it is essential that your outside contacts be made aware of your new number. You may want to make a list of those individuals and organizations who will need to be aware of the change.

To ease the transition into the new phone service, representatives have been designated throughout "estboro to respond to questions and handle the stribution of additional DID postcards."

Points To Remember

- Only those employees located at 4400 Computer Drive in Westboro will be affected by the new phone service.
- Your present internal extension and access code will remain the same. The new telephone number only will affect those calls coming in from outside locations. Current internal extensions will need to be used when calling other employees in Westboro.
- Data General-Westboro's present number (366-8911) will remain the same for callers who are unaware of the change and in need of operator assistance.

Auto Rental Advice

Data General receives favorable corporate rates from Avis, its preferred auto rental vendor. While the Data General corporate rate is favorable, it may happen that short-term promotional rates offered by Avis in certain cities may be better than the current corporate rate.

Corporate Travel and Meeting Services (CTMS) vises employees to have the Avis counter clerk verify that they are receiving the best possible rate. As a further check that you are getting the best rate, contact Corporate Travel via CEO; address to ADM TRAVEL:ISIS. As an added benefit, employees may use the Data General rate for personal use.

Note: Other than international rentals or those in Alaska and Hawaii, Collision Damage Waiver (CDW) insurance is included in the Data General corporate rate when the car is being used for business purposes. Therefore, you do not have to take out additional insurance.

Benefits

Data General Announces Retiree Medical Program

A new medical program has been announced to meet the needs of Data General and its employees retiring on or after January 1, 1986.

The program includes:

- A new medical plan for retires and dependents who eligible for Medicare.
- A choice of medical plans for retirees and dependents under age 65.
- Continued Health Maintenance Organization (HMO) participation where available and chosen by the

employee; and

• A sharing of the cost of coverages between Data General and the retiree.

Medical Eligible Plan

While complementing Medicare, the plan for Medicare-eligible people will pay specified benefits regardless of Medicare payments.

Under-65 Plans

Retirees and/or dependents under age 65 who wish to be covered by a Data General medical plan, will have several options from which to choose depending on individual needs. There will be three plans, each with a different annual deductible, coinsurance amount and annual out-of-the-pocket maximum.

НМО

Medical coverage may be provided through an HMO rather than a Data General plan, if the retiree is eligible and chooses to participate in the HMO.

Cost

Data General will contribute these fixed amounts each month toward the cost of a retiree's medical coverage:

If The Employee Retires With	Data General Contributes Up To	
	While Under Age 65,	While Over Age 65,
20 years of service or was age 55 before January 1, 1986	\$80	\$50
15 years of service	\$60	\$37.50
10 years of service	\$40	\$25

If the cost of coverage through a Data General plan or HMO exceeds the company contribution, the retiree will pay the balance. Since Data General's contribution is fixed, the retiree's cost of coverage may vary from year to year.

Based on current costs, a retiree with 20 years of service or who was age 55 or older before January 1, 1986, would pay nothing for individual medical coverage. Dependent coverage would cost the retiree as little as \$10 a month up to \$103 a month for the most comprehensive coverage for the retiree and two or more dependents under age 65.

All employees currently eligible or becoming eligible before January 1, 1986 for early or normal retirement have received full details of the new Retiree Medical Program.

In the future, employees will receive detailed information as they become eligible for retirement under the Data General Pension Plan.

Summaries of the provisions of each medical plan will be available to all employees in the next revision of the benefits booklets.

For current retirees and any employees retiring before January 1, 1986, Data General continues to provide individual and dependent medical coverage, under and over age 65, under the same Data General Medical plan currently used for active employees.
