Data General Reports Q2 Results; Sunnyvale Division Refocused

Data General revenues for the second quarter were \$318.8 million, compared with revenues in the same quarter a year ago of \$320.2 million.

Net earnings, before an extraordinary loss, were \$2.0 million, or 8 cents per share, compared with \$9.1 million, or 34 cents per share in last year's second quarter.

Operating income for the quarter was \$3.6 million, or 1.1 percent of revenues, compared with \$13.9 million, or 4.3 percent of revenues, for the same period last year.

The previously-announced redemption of the company's \$75 million 13 percent Sinking Fund Debenture due 2005 resulted in a one-time extraordinary loss, net of taxes, of \$3.8 million, or 14 cents a share. Net loss for the second quarter was a \$1.8 million, or 6 cents a share.

Low-Level Demand

According to President Ed de Castro, the financial results reflect the continuing low level of computer demand which the industry has experienced for the last 18 months.

"We have yet to see evidence that lower interest and inflation rates are resulting in improved business and capital spending in the U.S. industrial sector. For this reason, we must remain cautious in our outlook for order improvement for the remainder of our fiscal year."

New Product Acceptance

"Acceptance of our new ECLIPSE MV/Family of computers has been excellent," states Ed. "Shipments of our new ECLIPSE MV/20000 and ECLIPSE MV/2000 DC systems began several eks prior to the end of the second quarter to customers worldwide, including McDonnell Douglas, Beneficial Corporation, E.F. Hutton, Woodside Petroleum (Australia), and Banque Industrielle et Commercial de la Region Sud de Paris (France). The industry-

leading price/performance of these new systems is generating high levels of customer interest."

Sunnyvale Division Refocused

In announcing the sales and earnings results, Ed notes that the company continues to monitor discretionary spending aggressively and to implement programs to increase overall efficiency. He cites the decision to significantly reduce high-volume production of semiconductor components at the Sunnyvale Division. The division will now focus on advanced development and pilot-line manufacture of electronic components, and become a technology and business development center.

The company is substantially reducing its own volume production of proprietary semiconductor parts in favor of outside sourcing. Merchant semiconductor companies have been increasing their emphasis on customer-specific integrated circuits, making it more cost-effective to use outside merchant vendors for volume manufacturing.

The division now will focus on state-of-the-art semiconductor-related development, computer-aided design and process technologies.

As a result, 75 manufacturing, support and administrative jobs have been discontinued. Data General has put in place an extensive program of pay and benefit continuation, and outplacement assistance for those people affected. Data General will continue to pay the affected employees their regular weekly pay for between one and five months, depending on their length of service with the company. Data General also will continue to pay family life and health insurance coverage for enrolled employees for 90 days after their termination. An outplacement counseling center, staffed by a job placement consulting firm, has been established to help affected employees find other job opportunities.

Computers Rank High In Business Week

Business Week's just-published special issue on the top 1000 firms in American business in 1985 shows just how large and permanent a place the office equipment and computer industry holds in the U. S. economy.

In the issue, industries are ranked four ways:

- current market value, that is, value that investors give for the firm (number of shares times share price):
- profits after taxes;

Retailing (food)

Services

- sales; and
- · assets.

The computer industry shows up among the top 10 industries in each category.

In current market value, the computer industry ranked second among the top 10 industries at \$158 billion. Only the utilities industry ranked higher. Data General contributed \$985 million in value to that number. This says that investors are willing to pay more for utilities and computer companies than oil companies (3rd), or drug companies (5th).

Data General ranked 471 among the U.S.' to 1000 firms in current market value, a considerable drop from last year's 240 when the stock was selling in the \$60 a share range. Within the computer industry's market value ranks, Data General is valued less than Prime, although more than Tandem, Control Data Corporation and Amdahl. Investors are paying 10 times more for Hewlett-Packard, nine times more for Digital Equipment and 17 percent more for Prime than for Data General.

In profits, the computer industry ranked fourth with \$9 billion net income. The utilities industry was over three times as profitable (\$31 billion) followed by natural resources (fuel/oil) and banks.

In sales, computers came in seventh with \$116.7 billion. Data General's revenues last year accounted for about one percent of that amount. Firms in the natural resources industry, including oil, gas, etc., recorded four times the sales of the computer industry.

Formula For Success

Dave Lyons, vice president of Business Group Marketing, last week gave members of the American arketing Association his formula for success in the computer industry.

According to Dave, the computer vendors that become "major players" will be the companies that recognize industry changes and modify their marketing strategies to fit new rules. No longer are customers simply looking for the "hottest box" on the market, where price and performance alone would make or break the sale. Today, computer vendors must provide total information solutions for a broad spectrum of industries in the business and industrial automation markets. That is what is necessary to remain in the industry for the long run. Dave's remarks were made during the group's 1986 Strategic Marketing Conference.

"While technology is a leading factor in shaping new marketing opportunites," said Dave, "technology won't be bought unless it meets the specific needs and wants of customers and is priced, serviced and communicated to move the customer to purchase."

Over the past several years, Data General's marketing strategy has evolved from a "product-centered" approach to a "customer-centered" one. That is, the company now focuses on integrating office automation with specific business application lutions for users.

According to Dave, major agreements with customers such as NYNEX, PacTel, Centel, the U.S. Forest Service, E.F. Hutton, Beneficial and Life of Virginia are evidence that the company is going to be more successful than those computer vendors relying solely on new technology.

"In the end, I believe, we won many of our major accounts because of three key factors. We understood their information needs and were able to offer the best technical solution. We offered a competitive price for a competitive product. And, we were able to convince top decision-makers that they were buying a partnership, not just a computer system." And that, added Dave, is the formula for success.

Data General To Establish OA Lab In Spain

Data General will establish an Office Automation (OA) Development Laboratory in Spain. Initially, the new laboratory will aim at integrating commercial and technical application software with Data Gener-

I's CEO comprehensive electronic office software. In addition, the Office Automation Development Laboratory will develop OA software packages for eventual export to countries of similar language and cultural environments.

The opening of the development lab coincides with Data General's entrance into P.E.I.N (Plan Electronico Informatico Nacionale), a government organization which encourages the expansion of computer technology in Spain.

Currently, there are more than 800 CEO users in Spain.

The Office Automation Lab will begin work immediately from Data General's Spanish headquarters in Madrid. The staff is expected to be expanded over the next few years as development opportunities merit

Responsibility for the laboratory rests with Teofilo Del Pozo, country manager of Data General-Spain since 1981. Teofilo is a graduate of Polytechnic University of Madrid and the School of Industrial Management. He holds a PhD in electrical engineering and an MBA.

Data General introduced its CEO comprehensive electronic office software in November 1981. The company reports more than 140,000 CEO users worldwide.
