

# DATA GENERAL/One Price Lowered For Employees

With the recent reduction in price of a basic DAGENERAL / One Model 1 computer to \$1495, employees may now purchase the system at a 45 percent

discount. The price of a system with 256 KB of memory and two built-in disk drives is now \$822.25

Since last October, employees had been able to nurchase a basic system for \$1200.

If you should decide to purchase a system with additional internal equipment, the regular discount rates from the list prices will apply. The following discounts apply to ADDITIONAL items:

- 45 percent for hardware (expansion chassis, printers, etc.).
- 45 percent for software.
- 30 percent for supplies and accessories (carrying case, battery charger, battery pack, etc.).
- 30 percent for upgrades.

Payment can be made by personal check, payroll deductions for part or all of the purchase amount, or cash. If paid in cash (personal checks will be accepted), an additional 10 percent can be deducted from the total net employee discount purchase price.

# Data General Backs Series On Terminal Use

Data General is helping to educate companies throughout Massachusetts on the most comfortable use of video display terminals (VDT) in the workplace. The program, coordinated by the Associated Industries of Massachusetts (AIM), focuses on how employers may design employee work areas that maximize employee comfort and productivity. A Data General donation to AIM is helping to make the program a reality.

AIM has made available a series of 45-minute programs on VDT use for presentation at Massachusetts' Chamber of Commerce meetings. Six of the state's largest chambers, including the Worcester and MetroWest chambers, already have scheduled meetings to see the program.

Presentations will feature health experts discussing the merits of developing VDT-based work areas that provide appropriate flexibility and proper positioning for terminal users. It also includes a discussion on ergonomics - adjusting the work area to the employee.

"Each year, we find that more and more companies throughout Massachusetts are taking advantage of the advanced technologies available to the workplace," says Richard Mastrangelo, AlM's general counsel. "It is important that employers understand how to set up ergonomically-correct work areas as they introduce word processors and other VDT equipment in their offices. Educating employers in this way is a service that AlM can provide for both employers and their employees."

#### **Ergonomics In Design**

Data General is concerned with providing the most comfortable equipment for its employees and customers. According to John Martin, senior Human Factors specialist, the company's primary ergonomic focus is on the design details of VDTs and other office automation products. "Design details relating to ergonomics may include how bright to make the VDT screen, how many dots to put in the letters, how stiff to make the typing keys, and so forth," states John. "This is the piece of the technology picture Data General has direct control over. The company uses principles and research results from published experiments as well as its own scientific studies of people using the equipment to ensure maximum comfort and productivity for users.

"In keeping its commitment to customers, Data General actively participates in various organizations which write ergonomic standards and recommendations, covering both the design and use of VDTs," adds John. "The company's continuing support of AIM is an example of our broad commitment to helping our customers and employees work productively and comfortably with the latest technology."
