# Board Of Directors Approves Stockholder Rights Plan

Data General's Board of Directors has adopted a Stockholder Rights Plan that pays a special dividend of one preferred stock Purchase Right for each outstanding common share of stock to stockholders of record on October 20, 1986.

Under the terms of the plan, Purchase Rights have no value unless certain triggering events occur. Those events would involve attempts to acquire, or the acquisition of the company. If one of these events occurs, Data

neral stockholders would receive the right to purchase, for \$100 per Data General share owned, shares in the surviving company worth \$200.

If Data General stockholders do not wish to purchase shares in the surviving company, they can sell the Purchase Rights in the stock market, since they are traded with Data General common stock.

Under certain conditions, the Purchase Rights may be redeemed by the company for \$.01 per Purchase Right, thus voiding the possible Data General stockholder purchase of stock in the surviving company.

Data General believes the adoption of the Stockholder Rights Plan is in the best interest of all the company's stockholders because it encourages prospective acquirors to first negotiate with the company's Board of Directors. The plan will help protect stockholders from coercive takeover tactics that could result in an acquisition in which all stockholders would not realize fair value for their shares.

Data General is not aware of any takeover activity directed at the company.

Stockholder rights plans have come into common usage by publicly-held companies in recent years as a way to protect stockholders from corporate raiders. More than 200 companies have adopted similar plans in the past year.

# New Assignments In Field Engineering

*Paul Bielski* becomes director of Service Technology, responsible for developing field tools and test equipment, defining diagnostic requirements for Data General products, and providing technical information to the company's product repair centers. He had been director of the Product Management department.

Tom Bankert will now direct the combined Product Support Engineering and Product Management departments, responsible for developing product support strategies within Field Engineering while providing world-wide product technical support and problemmanagement systems.

Dick, Paul and Tom report to Fred Cochrane, vice president for Engineering Services.

Dick joined Data General Field Engineering in 1976 as manager for New Product Support Engineering. Since then he has held various management positions within the organization.

Paul had been director of Product Management since January 1985. He had been manager of Advanced Service Technology, and before that was with the North American Systems Engineering organization for eight years. Paul holds an MBA from Boston University and a bachelor's degree in business administration from the University of Maryland.

Tom joined Data General in 1983 as director of Service Technology. He came to the company from Xerox where he spent 12 years in a wide range of Field Engineering management positions. Tom holds an MBA from the University of Rochester, and a bachelor's degree in electrical engineering from the University of Maryland.

# Data General Helps Fight Crime

Last June, district attorneys' offices in Massachusetts recieved 255 cases of sexual abuse against more than 270 children. Due to the work load and complexity of these cases, providing help to victims, offenders and families is not a simple task. In order to make the task a bit simpler, Data General recently joined with the Worcester Area Child Sexual Abuse Task Force.

As part of Data General's ongoing community relations program, the company provided printing services conducted in Southboro's Building 5 in order to publish the 150-page Child Sexual Abuse Interdisciplinary Professional Reference Manual for Central Massachusetts.

The manual provides detailed information on how to handle child abuse cases for those professionals who may be involved in such matters. It includes: intervention scenarios; a directory of service agencies; and a reference section containing current statues and forms from appropriate governmental resources.

According to task force member Susan Getman, regional director of the Massachusetts Society for the

Prevention of Cruelty to Children (MSPCC), "The reference manual will be an important addition to the resources of attorneys, physicians, educators and human service professions not only in Worcester County but throughout the entire state."

"This printing service continues our commitment to helping children in the area." says Dave Dimmick, Donations administrator within the Public Affairs department. "In addition to this effort, the company recently made a substantial contribution to the Worcester Chapter of the MSPCC to be used for renovating its facilities in the Worcester and Framingham areas."

# Insurance Costs Reduced

Effective October 1, the weekly cost of supplemental life insurance and accidental death and dismemberment (AD&D) insurance was reduced from \$.17 to \$.136 per \$1,000 of coverage. This reduction in cost will be reflected in paychecks beginning October 16.

Business travel and accident (BT&A) and AD&D insurance is now provided through American International Group. (Prior to this change BT&A was provided through CIGNA and AD&D was through Prudential). Basic and supplemental life insurance will continue to be provided through Prudential.

There is no change in the life insurance benefits and employees do not have to update their beneficiary designations UNLESS they have made a special "gift assignment" for estate planning reasons.

Employees who do not have supplemental life insurance may enroll for coverage:

- at anytime by providing evidence of good health to Prudential, or
- during a special open enrollment that will be held in the spring (at which time evidence of good health will not be required).
