Data General Retires \$150 Million Debentures Offering

Data General will redeem its \$150 million 12 3/8 percent Sinking Fund Debentures, due in the year 2015, on May 18, 1987.

The debentures will be redeemed at a price equal to 111.138 percent of the aggregate principal amount of the debentures then outstanding plus accrued interest to the redemption date. No further interest will accrue or be payable on the debentures on or after May 18.

Data General anticipates that the redemption will result in an extraordinary charge before taxes of approximately \$18.2 million to the recently-completed second quarter, which ended March 28.

According to Data General Treasurer George McClelland, the action strengthens Data General's balance sheet and income statement. "This is a one-time action that removes debt from our balance sheet and interest expense of \$18.5 million from our income statement. At current rates of interest, this will reduce our net interest expense by about \$9 million.

"Our present positive cash flow from operations, even after retiring this debenture offering, is sufficient to meet our current and medium-term needs."

Data General's balance sheet shows the company had \$312 million in cash at the end of the first quarter. That position has continued to improve, states George.

Data General Moves Up On The List

Based on its fiscal 1986 sales of \$1.268 billion, Data General is now the 255th largest U.S. industrial corporation in Fortune Magazine's latest Fortune 500 listing. Data General moved up 14 slots from a year ago.

The company originally broke into the Fortune 500 listing in 1978 when it became the 500th firm on the list with revenues of \$355 million.

Other computer firms on the Fortune 500 listing are:

4. IBM, up from five a year ago;
44. Digital Equipment, up from 55 last year;
46. Unisys, formerly Burroughs and Sperry, up from

Burroughs' ranking of 72 last year;

51. Hewlett-Packard, which was 58 the year before;

75. NCR, up 14 places from a year ago;

146. Wang, up from 161;

190. Apple, an increase of one slot over last year's listing;

337. Prime Computer, up from 366 the year before.

This year's Fortune 500 listing saw a record 43 companies drop off of the list due to poor sales. Datapoint, number 458 last year, fell off of this year's list.

Data General Signs Agreement With Relational Technology

Data General and Relational Technology of California have entered into a joint development agreement aimed at making Relational's INGRES Distributed SQL Relational Database System available for the ECLIPSE MV/Family of 32-bit processors and DS/7500 engineering workstations. In addition, the agreement will enable Relational's 4GL and distributed database products to be integrated with other Data General products.

"With INGRES, users of the ECLIPSE MV/Family of computers, as well as DS/7500 engineering workstations, have a powerful tool to make data retrieval and analysis more efficient," says Dave Lyons, vice president of Group Marketing. "Data General has always been committed to providing the best products to our customers, and with INGRES having proven leadership in relational database technology, this commitment continues."

"With INGRES/STAR and INGRES/NET, Data General can now combine INGRES's proven 4GL capabilities and powerful applications development tools with the ability to access INGRES databases located on a wide variety of workstations, PCs and mainframes," says Michael Seashols, vice president of sales and marketing at Relational Technology. "This agreement means that Data General can now take advantage of all that INGRES has to offer and, over time, will provide access to IBM's IMS, DB2 or VSAM databases as well."

Relational Technology is a leading developer of relational database management systems and a pioneer in advanced distributed database solutions. The company's primary product, INGRES, combines an open-architecture distributed database capability with integrated 4th generation application tools and a high-performance SQL database. INGRES is currently available across a wide range of operating systems from PCs, workstations, minicomputers, and mainframe systems.

An Issue Of Trash

Trash. This is probably something most people only think about once a week as they lug their own to the street or to the dump.

A company the size of Data General must consider it on a daily basis, however, because the company generates an immense amount of trash and the cost of its disposal is likewise.

About two years ago, the Town of Southboro was faced with an escalation of the costs involved with dumping trash. In an effort to contain costs for residents, commercial and industrial users were told that their refuse would not be accepted at the town's transfer station and that the businesses must arrange for private haulers to remove their solid waste at company expense.

At Data General, the issue was resolved by Southboro Facilities Manager John LaFort, and employees Dennis Sullivan and Kevin Lemire. Together, they initiated recycling and waste reduction methods which are offsetting, in some measure, the expense.

As John puts it "Our eventual goal is to raise enough money recycling our waste to offset the dumping fees we incur when dumping non-recyclable material. We aren't there yet, but we have made giant steps."

Southboro last year recycled nearly 590,000 pounds of paper which raised \$10,000 to offset dumping fees for other waste. Had they not recycled that material, it would have cost Data General more than \$23,000.

In addition to paper recycling, Southboro recycles scrap metal and wooden pallets. There are plans to expand the efforts in these areas and to aggressively seek methods to dispose of corrugated material. This category of refuse accounts for 70 percent of Southboro's annual 1,070 tons of trash. Removal of that trash cost the company more than \$95,000 in 1986.

In Westboro and Milford, the problems which arise are slightly different. The only recyclable material which is generated is computer paper. This paper is recycled, as long as it is not mixed in with other trash. It is very important in both facilities, that the paper placed in hampers along hallways be "exclusively uncontaminated" paper. Haulers will not accept other typical wastebasket trash.

Data General receives \$100 per ton for the recyclable material it generates each year. In Westboro, about 120 tons of recyclable paper are sold annually.

General refuse in Westboro, which comes from the three food services and employees' wastebaskets, is compacted. About 700 tons of this material is generated annually excluding the soda and juice cans which are recycled by the vendors. It costs \$56,000 to remove this trash from Data General.

Westboro Facilities Manager Mac Dunbar is now looking into what adjustments he will make since the cost structure for hauling is being changed from a per ton rate to a per cubic yard rate. Trash from 2400 Computer Drive and 3400 Computer Drive currently is not compacted and Mac must decide the most effective way to deal with that.

"Obviously, we will have to compact as much of our refuse as possible so that each of our cubic yards weighs the most it can. Paying by volume, not weight, could be very expensive for us otherwise."

In Milford, general refuse costs almost \$50,000 to dispose of each year. In the past year, the cost to dispose refuse has increased more than 30 percent.

Milford generated about 75 tons of scrap computer components last year. By recycling this material, Data General received \$15 for each ton.

Southboro, Westboro and Milford face different issues with trash removal, and each is handling it in aggressive and innovative ways. The costs of dumping trash at landfills have risen from under \$20 per ton a year ago to more than \$80 per ton today. Since this expense is privately absorbed by the company and is not provided as service for its tax dollars, all employees should help the company in its recycling efforts.

Town Meetings On The Agenda

It is spring time, it is New England, and it is town meeting time.

Southboro's town meeting begins on Monday, April 13 at 7:00 p.m. at the Woodward Memorial School. All registered voters of the community are permitted to vote on the warrant. The budget articles to be voted on amount to more than \$5 million in addition to many special articles for equipment for major projects.

Among the special articles are requests for highway equipment, a new ambulance, new water lines, an electronic voting system, a consultant to advise the town on the expansion of the Massachusetts Turnpike and its impact on Southboro, and non-money articles dealing with zoning and by-law changes.

Within this annual town meeting, a "special town meeting" will also be held. This situation generally occurs when additional articles or demand for funds arise after the closing date for the annual town meeting warrant has passed. As a result, it is common practice to have a "special town meeting" occur within the annual meeting.

The warrant for the special meeting includes a major water request for \$530,000 for improvements in distribution of water to the Pine Hill area. There are also requests for a drop-in center in conjunction with the Greater Marlboro Alcoholics Center, and a rezoning of land on High Street from industrial to residential.

Westboro

The Westboro town meeting ended, and now the Board of Assessors will establish the new tax rate. At the town meeting, about \$28 million, up from \$22 million last year, was appropriated to cover articles listed on the warrant.

The town will undergo revaluation this year, which will, no doubt, increase the values of properties in the town. However, when this increase occurs, there is a commensurate decrease in the tax rate, thereby ensuring that the limits set by Proposition 2 1/2 are always in place. It will be some time yet before the tax rate can be set.

At the town meeting, residents voted to build an addition to the fire station this year, along with building a senior center. It was also decided to purchase the Ashworth Farm, which will be protected as agricultural property, forever.

More than \$8 million will be borrowed as a result of spending at the town meeting.

A number of articles were "passed over," or defeated, this year. They included proposals for a building moratorium and limiting the number of building permits to be granted in any one year.

Milford

The town meeting in Milford will not be held until May. Milford held their general elections this week and has yet to open the warrant for the town meeting. Because Milford's town meeting is representative, residents who are not elected as representatives may not actually vote at the town meeting. However, all town meetings are open and residents may be heard.

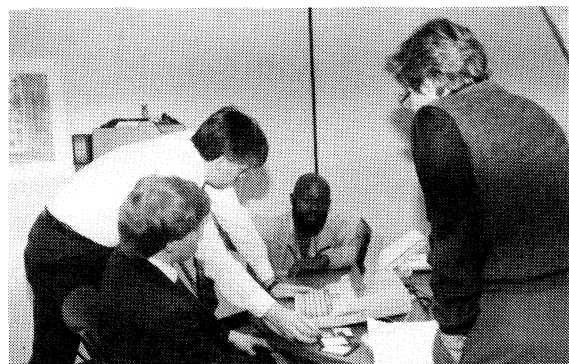
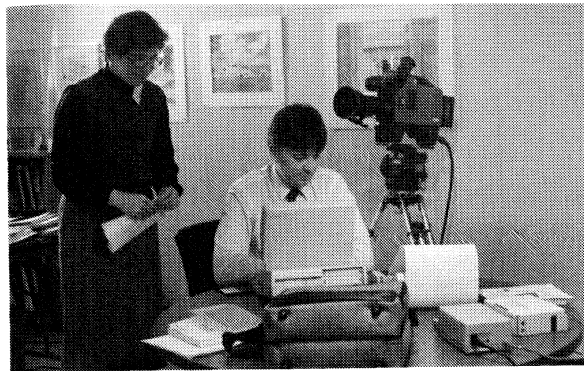
Helicopter Mail Pick Up

Employees using the helicopter mail service for packages to and from Data General sites in Hooksett, Durham, Portsmouth and Westbrook should be familiar with these guidelines:

Mail and packages may be left in the mailbox at each helipad for delivery. Senders should check with Corporate Travel to ensure that the scheduled flight is going. It is the responsibility of the sender to arrange for pick-up at the destination. The pilot will deliver material to the appropriate mailbox, but they are not serviced by the mailrooms. Any package weighing more than five pounds must be pre-arranged for delivery with Corporate Travel.

Please Don't Walk On Technology Drive

Construction on the second building in the Westboro Technology Park has begun. The Westboro Technology Park lies between Data General and Rt. 495. Therefore, a portion of Technology Drive has been closed. Heavy construction trucks will be using this road, and it is important that vehicular and pedestrian traffic cease until construction is completed. Once the building is finished, the road will be opened to the public.

Guidelines For Property Transfer

Getting a signed property pass for a company item leaving Westboro (or any other Data General location) is only the first step in the authorized transfer of property. Having a Security officer or receptionist authenticate the signature on the pass and verify the property being taken out is the second and critical requirement. All employees should make sure to follow both steps in order to help keep track of equipment within Data General.

May Is High Blood Pressure Month

Data General's Health Services department in Westboro will sponsor a hypertension screening clinic in observance of national high blood pressure month,

which is held in May. Nurses from Hubbard Regional Hospital in Webster will be available in the main cafeteria of building 14A on each Tuesday and Thursday. During the first week, May 5 and 7, the time of the screening will be 8:30 a.m. until 11:30 a.m. and 1:00 p.m. until 4:00 p.m. The times for subsequent weeks will be announced at a later date.

In October of last year, Hubbard Regional Hospital was awarded a state grant by the Department of Public Health to provide free blood pressure screenings at worksites and community settings.

Educational information is provided to each person screened. Employees with elevated readings will receive one-on-one education about high blood pressure and life-style risk factors and treatment, and will be rescreened one month later.

More than 54 million people have high blood pressure and 30 percent of those people do not know it. Because high blood pressure has no symptoms, the only way to find out if you have it is to have your pressure checked.

Educational Center Courses Ongoing

During the weeks of April 27 and May 4, Educational Services will offer several hardware and software courses to Data General employees. All classes will be held at the Education Center at 2400 Computer Drive in Westboro.

Software

- ***Hardware Concepts for Software Professionals: ECLIPSE MV/Family Fundamentals (S170)*** - This five-day course covers the structure, design architecture and terminology of computer system hardware. This complete course is for software professionals who work with ECLIPSE MV/Family systems and need a background in Data General hardware concepts. Class begins Monday, April 27.
- ***CLI Macros (S161)*** - This course is designed for CLI users, programmers and system managers who wish to implement sophisticated systems of CLI macros. Participants will learn how to write CLI macros for use in system management, user assistance and menu-driven applications. S209 (AOS and AOS/VS User) is a prerequisite or participants should have at least six months experience with the CLI. This two-day course starts Monday, May 4.
- ***INFOS II Database Design and Analysis Workshop (S406)*** - AOS and AOS/VS users will learn how to design INFOS II databases with the final course day being totally devoted to a supervised database design workshop. Class participants should be familiar with INFOS II utilization and design or have equivalent INFOS II experience. This three-day class begins Monday, May 4.

Office Automation

- *Wordperfect word processing (OA180)* - This two-day comprehensive course teaches you the features, terms and functions of the Wordperfect word processing program and how to install it. Participants will emerge from this course with a working knowledge and familiarity with Wordperfect. Class starts Monday, May 4.
- *Getting started with PRESENT (OA145)* - This complete one-day course teaches CEO users how to effectively organize, display, and manipulate numerical data using the PRESENT information presentation facility. This course is recommended for employees who would like to be able to produce reports and graphics from existing on-line and CEO databases. This course will be held on Thursday, May 7.

Hardware

- *Disc 10 MB (6045 Series) (H203)* - This five-day course for computer maintenance technicians teaches how to load and run diagnostics and perform maintenance on the 6045 series disk through the operation of the moving head disc controller, adapter, drive unit, and necessary adjustment procedures. Class begins Monday, May 4.
