Stock Purchase Period Ends Today

The Data General Stock Purchase Program for the January through July period ends today. Employees participating in the program will purchase stock at either the opening day price of \$29.50, or 85 percent of today's average market price, whichever is lower.

Data General stock certificates for the period will soon be mailed to participants' homes. Anyone who expects to receive stock but does not by August 20, should first contact Employee Shareholder Services to verify purchase, then contact Morgan Shareholder Services Trust Co. at (212) 587-6447 to find out if the certificate was returned to Morgan as undeliverable. Allow at least one week for the certificate to be returned to Morgan.

For the August through January, 1988 period, the opening day price will be set on Monday, August 3. See next week's Mini News for that price.

Educational Services is offering the following software and hardware courses to employees in August:

• Introduction to Data General 32-Bit Computer Systems (H100/MV) - The evolution of Data General's computer architecture from a 16-bit to the 32-bit design used in the ECLIPSE/MV Family series is presented in this ten-day course. It explains the terminology of virtual storage systems; provides an overview of mass storage devices, terminals, printers and data communications, and much more. A knowledge of general computer design concepts, digital circuitry, and number

conversions is needed for this class which begins on Monday, August 17.

- 6026 Magnetic Tape Drive Field Maintenance (H223)
- This course teaches employees how to operate and maintain the 6026 series mag tape drive subsystem. Employees will learn how to load, run, and interpret the appropriate diagnostics, and how to use the alignment and adjustment procedures. This course also covers mag tape format, dual mode, tape controller, and tape programming. The prerequisite of H100 or H100/MV (Data General's 16-bit or 32-bit computer systems) is required to participate in this three-day course, which begins on Wednesday, August 26.
- CEO Office Manager (OA 160) This one-day course teaches the responsibilities of a CEO office manager as they relate to using the functions of the CEO System Management Function menu. Some of the topics to be discussed include user profiles, remote aliases, and CEO queue controls. This class will be held Monday, August 24.
- Getting Started with PRESENT (OA145) This course is designed for employees who want to organize and manipulate numerical data for effective business decision planning and administrative support by using Data General's PRESENT facility. Familiarity with the CEO system would be helpful to attend this one-day class, which is scheduled for Friday, August 28.
- RDOS User (S200) This course is geared toward programmers, analysts, and system managers, and focuses on how to use Data General's RDOS operation system. This is a five-day course which begins on Monday, August 24.

Prior approval of your supervisor is required for course registration. Call (tie-line) 221-1647 to enroll in these or other classes. All classes will be held at the Education Center at 2400 Computer Drive in Westboro.

Employees Can Find Out About BU Courses

The Management and Organizational Development (MOD) group is sponsoring a set of Boston University engineering and computer science courses delivered through Boston University's Interactive Network. Courses toward an MBA and a manufacturing degree will be offered for the first time this year. The classes are given on campus at Boston University, but televised live to Data General in Westboro and other companies.

These courses can be taken on a special basis or as part of a formal Boston University degree program. **Note: Tuition is \$1476.00 for a 4-credit course and \$738.00 for a 2-credit course.** Payment can be supplemented through Data General's Educational Assistance Program.

Benefits Brief

Answers On The Savings And Investment Program

This first Benefits Brief details Data General's Savings and Investment Program. The program offers employees an opportunity to systematically save a portion of their earnings each pay day. Below are answers to some of the most-commonly asked questions about the Savings and Investment program.

What is the Savings and Investment Program?

- The Savings and Investment Program is one of three capital accumulation programs available to Data General employees. The other two programs are the Stock Purchase Progam and the Pension plan.
- The Savings and Investment Program is designed to be a long term investment program and should be viewed as a supplement to the Data General retirement plan.

What are my investment options?

- There are three investment choices: the Guaranteed Fund, the Balanced Fund (George Putnam Fund) and the Equity Fund (Investors Fund).
- Participants may invest in any combination of the three funds.
- The *Guaranteed Fund* assures a fixed return. For 1987, the rate of return is 10.15 percent.
- The *Balanced Fund (George Putnam)* has the potential to yield a higher rate of return than the Guaranteed Fund, but also poses a greater risk through investment in a balanced group of stocks and bonds.
- The *Equity Fund (Investors Fund)* has the potential to yield the greatest rate of return but it also poses the greatest risk through investment in quality common stocks.

Who is eligible to participate in the Savings and Investment Program, and how do I enroll?

- Regular employees who have been with Data General a minimum of 90 days may enroll in the Savings and Investment Program.
- Enrollment elections are effective the first day of the next calendar quarter.
- Enrollment materials are mailed to newly-eligible employees each quarter. Any other employees who wish to join the plan may obtain enrollment forms through their local Benefits department.

How are contributions made?

- Contributions are made through payroll deductions and may equal from 1 percent to 12 percent of pay, up 3 a maximum \$5500 per year. This company maximum is lower than the IRS level of \$7000 to insure that the federal non-discrimination test is met. This test prevents plans from favoring one group of employees over

another.

- Contributions are made before federal, and, except in Pennsylvania, state taxes are withheld.
- Savings and Investment contributions are figured on gross pay regardless of other deductions whether or not they are pre- or post- tax deductions.

Can money be withdrawn?

Current tax legislation places certain restrictions on withdrawing funds from the Savings and Investment Program due to government emphasis on long-term investment. Generally, contributions to the plan should be made with the intention of leaving the funds in the program until retirement. However, you may withdraw funds by following the steps as noted below. All forms may be obtained through your Human Resource representative, local Benefits department or Corporate Benefits.

Loan:

- Any participant (contributing or non contributing) in the Savings and Investment Program may take out a loan for any reason with a minimum loan of \$500 and no other outstanding loan.
- In order to apply for a loan you must complete the following:
 - 1) A Loan Application form
- 2) A Disclosure Statement and Security Agreement form
- Loans are processed the last working day of the month that an application is received by Corporate Benefits. Checks are issued the third week of the following month.
- You may only take out one loan at a time. Any outstanding loan must be paid before another loan can be submitted for approval.
- Federal legislation restricts the amount you can borrow for a single loan. The maximum loan amount that can be borrowed at any one time is based on the following schedule. However, a loan cannot exceed the difference between \$50,000 and your highest loan balance within the last 12 months.

- The maximum time allowed to pay back a loan is five years.
- The minimum weekly payment is \$10. Loan payments are deducted from your paycheck after tax.
- Once a loan has been taken, the repayment period cannot be changed. However, you may prepay the outstanding balance in full. In order to arrange for prepayment contact Corporate Benefits for the exact balance.

- The interest rate on a loan is equal to the rate of interest currently being credited under the Guaranteed Income Fund at the time of the loan, plus one percentage point. For 1987 the interest rate is 8.75 percent.
- Once the interest rate is determined, it will not change for the duration of the loan.

Hardship:

- Per federal regulation, ONLY the following three events qualify for a hardship withdrawal:
 - 1) Purchase of Primary Residence;
- 2) College expenses for yourself or your immediate family; or
- 3) Expenses in your immediate family resulting from illness, injury, death, layoff or divorce.
- Participants may apply for a hardship by completing a Hardship and In-service Withdrawal Form.
- Verification of the above will be required for approval. For example, applicants will be asked for a copy of a purchase and sale agreement, a tuition bill, medical bills or other relevant documentation.
- Immediate family is defined as spouse, child, or other person claimed as a dependent for tax purposes.
- Funds received as a hardship are subject to ordinary income tax in addition to a 10 percent excise tax.
- Hardships issued for more than 75 percent of your total account balance will be processed in two checks. The first check represents at least 75 percent of the total balance. The second check represents the remaining balance.
- First checks will be received from the trustee two weeks after the application has been processed. Second checks (if applicable) will be received four to six weeks later.

59-1/2 (In-Service) Withdrawal:

- After reaching age 59-1/2, a participant may elect to withdraw all or any portion of before tax savings and investment earnings.
- Funds received will be taxed as ordinary income but there is no additional tax penalty.
- Only one 59-1/2 withdrawal may be made in any one year.
- Participants may apply for a 59-1/2 (in-service) withdrawal by completing a Hardship and In-Service Withdrawal Application.

Distribution:

- Upon termination or retirement participants receive the balance of funds in their Savings and Investment account, including pre-tax savings as well as any investment earnings.
- Distributions may be rolled over into an IRA account or other qualified plan within 60 days of receipt.
- If the funds received are not rolled over they will be subject to ordinary income tax plus a 10 percent tax penalty unless the participant is 59-1/2 or older.
- Per government regulation, unless a participant elects not to have taxes withheld from their distribution by completing a lump sum tax withholding form, applicable taxes (if any) will be withheld.
- Distributions upon termination or retirement are pro-

cessed at the end of the month following termination. Distributions can be expected therefore for up to two or three months after termination/retirement.

Can I keep funds in the account after leaving Data General?

- Participants with account balances in excess of \$3500 may elect to leave the funds in the program until age 65.
- This election may not be changed.
- Hardship withdrawal provisions would still apply, but age 59-1/2 withdrawals and loan options would no longer be available.
- Participants may no longer contribute funds or transfer funds if distribution is deferred.

How do you make changes or transfer funds?

- Changes in the the amount contributed to the plan through payroll deductions and/or changes in the distribution of the contribution among the different funds may be made quarterly by timely completion of an enrollment form.
- Transfer of partial or total balances from any fund(s) to the one or more of the other funds may be made by timely completion of an enrollment form. Only one transfer may be made within 6 months (2 guarters).
- Elections for transfers and changes will be effective the first day of the following quarter.
- The deadline for both changes and transfers is generally two weeks before the end of a quarter.
- You can cease contributing to the plan at any time, and resume again at any time, effective the first day of the next quarter. You need not be contributing to the plan in order to take advantage of its withdrawal options as long as any requirements are met.

Who should be contacted with questions and where can I get any necessary forms?

- Contact your Human Resource representative, your local Benefits department, or Corporate Benefits with questions or to obtain any necessary forms.
