Stock Bought At \$28.00 New Period Price Is \$27.25

Employees who participated in the Data General Stock Purchase Program, which ended on July 31, purchased stock at *\$28.00*, 85 percent of the average market price on July 31, the last day of the plan.

Data General stock certificates will soon be mailed to participants' homes. Anyone who expects to receive stock but does not by *August 20*, should first contact Employee Shareholder Services to verify purchase, then contact Morgan Shareholder Services Trust Co. at (212) 587-6447 to find out if the certificate was returned to organ as undeliverable.

Allow at least one week for certificate to be returned to Morgan.

For the August through January period, the opening day price was \$27.25, 85 percent of the average market price on August 3. Stock will be purchased at \$27.25 OR 85 percent of the average market price on January 29, 1988, whichever is lower.

For your information, the average fair market value on *July 31, 1987* was *\$32.75*.

Richstone Named Acting Treasurer

Ellen Richstone has been named acting treasurer, reporting to Ron Skates, senior vice president for Finance and Administration. Ellen assumes responsibility for the Customer Finance area, in addition to her current responsibilities for the Stock, Cash Management, Corporate Finance and Investments, International Finance and Transfer Pricing, Trade Finance, Customs and Foreign Exchange departments. Ellen will have the fiduciary and signing authorities commensurate to the treasurer's position.

The Tax and Risk Management groups temporarily will report to Ron until a treasurer is named.

Ellen has been with Data General for six years. She was most recently assistant treasurer, a position she has held since April 1985. Prior to that, she was director

of International Treasury and manager of the same group.

Ellen received a bachelor's degree from Scripps College in California, master's degrees in international business law and international affairs from the Fletcher School of Law and Diplomacy, and an advanced professional certificate in finance from New York University's Graduate School of Business Administration. In addition, Ellen has attended Cornell University's Executive Development Program.

Data General Signs Agreements With VARs

Data General has signed a \$3.5 million contract with one of the company's major Authorized System Distributors, Southern States Cooperative. In addition, newly-recruited value added reseller (VAR), Comtech, will purchase \$3.4 million in equipment.

Southern States Cooperative's purchase includes ECLIPSE MV/2000 DC computers. Southern States Cooperative is one of the country's leading wholesale and retail suppliers of agricultural goods and services. Serving the farming community, the cooperative provides member farmers with crop seeds, feed grains, fertilizers, hardware and related farm equipment. ECLIPSE MV/2000 DC computers will be installed at each of the cooperative's 246 retail farm outlets to serve their needs for increased operating efficiency.

In addition, the agreement includes the ECLIPSE MV/15000 Model 10 computer and CEO comprehensive electronic office software. This system will further assist the cooperative in administration of its daily headquarter business. Within the next 12 months, the number of CEO users at the cooperative will increase from 100 to 350 users

Comtech has signed an agreement to purchase 46 ECLIPSE MV/Family processors ranging from the ECLIPSE MV/2000 DC, ECLIPSE MV/780O and ECLIPSE MV/7800 DC systems.

Nippon•Data General Wins Big In Japan

The 4,000 students enrolled at the Utsunomiya University in Japan now have greater access to information needed for research and classwork, thanks to the school's recent purchase of more than \$2 million of Data General equipment.

Before the purchase, the university's computer center supported a small number of students. Recently, however, the university began looking for a means to increase information access to a greater number of people.

Enter Nippon•Data General. When the company first entered the sale, it faced stiff competition from IBM, NEC, Hitachi, and Digital Equipment. After the second proposal and a demonstration, the competition to upgrade the school's computer center was narrowed to IBM, Hitachi and Nippon•Data General. In a demonstration, Nippon•Data General emphasized that the company could integrate the school's existing personal computers in a CEO comprehensive electronic office software system. At the same time, Nippon•Data General proposed the construction of an inter-campus network system. The school was so impressed with what it saw and heard that it bought the system from Nippon•Data General.

According to Howard Glassman, Marketing Support manager within the Japanese Business Development (JBD) group in Westboro, this sale stresses Data General's commitment to personal computer integration, networking and price/performance. Two ECLIPSE MV/20000 computers now comprise the heart of the school's new central data processing computer system, along with dedicated high-speed gateway servers and multiple communications servers. The gateway servers act as a link between the two local-area networks being used to connect computers at the university's two campuses.

Through the implementation of this system, the Utsunomiya University's computer center is now a true information processing center. The center can accommodate more users than ever before on the central system and can integrate personal computer users to the internal network.

"The Nippon•Data General agreement with Utsunomiya University highlights Data General's emphasis on CEO network integration, software solutions, and price/performance," Howard says. "The equipment and support involved in this project should serve the university's educational and informational needs for a long time to come."

Data General, E.F. Hutton Are Long-Term Partners

Brokers at E.F. Hutton branches across the country can now more quickly and easily access the kinds of financial information they need to help their clients, thanks to its long-term partnership with Data General. Over the past 10 years, Data General has installed more than 375 systems, ranging from ECLIPSE MV/4000 computers to ECLIPSE MV/20000 systems, all working together to make E.F. Hutton employees better informabout financial matters.

According to Tom Kelly, who is a branch manager at Data General's office in New York City, this project has involved more than \$85 million in equipment and service. It has required constant use of what he refers to as the "Six Cs."

"This partnership has been successful because of six fundamentals," Tom says. "These factors are communications, cost/performance, corporate commitment, customer support, compatibility, and finally, Data General's CEO comprehensive electronic office software. Many employees have been involved with the E.F. Hutton project, and all have worked together to make it happen."

Advantages

The E.F. Hutton project includes ECLIPSE MV/Family computers which run CEO at the company's branch offices. Called the Branch Information Processing System (BIPS), the computers provide business communications, data processing functionality, and local office automation.

E.F. Hutton's Data General-based system allows brokers to gain access to several types of information at once, from one terminal. This provides brokers window to all information needs, through which the may refer to research reports, margin issues, business and financial news and account information simultaneously.

"Data General has successfully brought information closer to the broker," says Data General's Art Ellsweig, account manager for the project. "At the same time, administrative personnel have all learned to use CEO, and they've come to rely on it in a short time."

Support

In 1983, when E.F. Hutton decided to upgrade its computer operations, it looked for a system which would be compatible with its existing set up of IBM Bunker Ramo terminals, mainframes and teletype machines. Data General was able to provide E.F. Hutton with a customized CEO package tailored to the brokers' needs, without changing the existing system extensively.

"More than 6,000 brokers have these Bunker Ramo terminals," says Steve Petrofsky, director of the Artificial Intelligence Technical Services group at Data General. "They are key to what a broker does. These machines directly supply stock information. E.F. Hutton did not want to replace these terminals initially, but wanted to be able to run CEO through the same terminal. Data General has accomplished that goal.

"Our efforts to integrate E.F. Hutton's existing systems are what they believe will provide the best tools for their employees," Steve says. "Together we will

continue to build an advanced workstation for the brokers.

"The tailored CEO package is easy to use, and will ensure a high level of performance. As far as we know, no other brokerage can offer a system this sophisticata."

In addition to the 6,000 brokers who use the new system, more than 14,000 E.F. Hutton employees use CEO software daily.

Employees Make The Difference

E.F. Hutton knew what it needed for its brokerage services. But it was Data General employees who knew how to deliver. According to Deb Greenberger, who has been responsible for coordinating employees needed to install and service E.F. Hutton's system, as well as train others to use the system, this project had more than 50 systems engineers and field engineers working together to make it all happen. Data General's Sales representatives, along with development and Marketing employees, also were on hand to make the project a success.

"The field engineers would typically show up on a given site two weeks before the systems engineers, to install the equipment," Deb says. "The systems engineers would then come and install the software. E.F. Hutton's office staff then had to be trained.

"The systems engineers, after meeting with the branch manager and branch office coordinator at that particular E.F. Hutton site, would train the administrative aff how to use CEO software. These training sessions would consist of lectures and labs, and were very intensive," says Deb. "The training sessions were tailored to fit their needs."

According to Deb, virtually every organization within Data General has been involved with the E.F. Hutton partnership.

"This has worked primarily because of the employee commitment and dedication. Trust has been built on both sides, making this sale very successful."

Unibol Promotes Compatibility

Data General has introduced the DG/UX Unibol software language. It is highly compatible with DIBOL-83, a simplified derivative of COBOL offered by Digital Equipment.

The introduction of DG/UX Unibol means that most business applications written in Digital Equipment's DIBOL language can run efficiently on the ECLIPSE MV/Family of computers under the DG/UX operating system. Existing DIBOL programs are quickly converted to the DG/UX Unibol language and executed on Data General computers with virtually no coding changes.

According to Ed Conner, director of the Software roducts and Services Division, "DG/UX Unibol software allows DIBOL value added resellers and customers to take advantage of the power and flexibility of the

Data General computer environment, while preserving their investment in existing DIBOL systems. DG/UX Unibol software represents a cost-effective migration path for current DIBOL users."

Prices for DG/UX Unibol range from \$1800 to \$9100, depending on the processor.

Industry Marketing Shows Its Winning Edge



Using the theme "The Winning Formula for Computer-Intergrated Manufacturing," Data General's Industry Marketing Division demonstrated front-running manufacturing planning and control, factory automation, engineering design and analysis, and administration solutions at the recent Advanced Manufacturing Systems (AMS) trade show in Chicago.

During the show, Data General featured a strong set of third-party manufacturing information and manufacturing resource planning (MRP) systems for repetitive manufacturing and job shops, financial systems for manufacturing, as well as the Data General DG/FMS Factory Management System.

According to Julie Doro, manager of Maunfacturing Automation Marketing within the Industry Marketing Division, the AMS trade show has been in existence for more than eight years.

"For the first two years, we spent most of our time convincing people attending the show that yes, Data General does manufacture computers," Julie says. "Now, people are aware of our strong presence in the computer industry, and they know we are making an aggressive contribution to computer-integrated manufacturing, or CIM."

The show typically attracts nearly 10,000 people, Julie says, from manufacturing engineers to company presidents.

"We were very pleased with the caliber of people who attended. We see this show as one of the primary tools for increasing the awareness of our presence as a major supplier of manufacturing solutions," Julie says. "People are interested in what we have to say. Our Sales representatives have been booked since the show, with follow-up calls for interested customers."

Rod Griffith, manager of the Industry Marketing booth, agrees.

"The people who come to these shows are the decision makers," Rod says. "We see plant managers, directors of manufacturing and other upper level executives. They are the kind of people who can most effectively, and directly, have an impact on our success."

A Winning Combination

The media coverage of the show was extensive, says Julie, which was due in part to the Data General Team Tyrrell Formula One race car and crew on hand to underscore the "Winning Formula" theme.

The car was on display near the booth, and Ken Tyrrell, founder of the Tyrrell racing organization, was available for questions. Nigel Beresford, largely responsible for the design of this year's car, also spoke with customers. The AMS show was held directly following the Detroit Grand Prix, which helped peak interest in the car and Data General.

"It was a winning combination, having the car and Ken and Nigel there during the show," Rod says. "The car got people's attention, and when customers discovered that Data General workstations were used in its design, the questions started.

"Customers were intrigued by the incredible precision involved in designing and building a Formula One car. Many had specific questions. One man, in particular, races as a hobby and writes for an automotive magazine. He proceeded to interview Ken Tyrrell for the magazine.

"Having that kind of expertise in our booth strengthened our image," Rod says. "Ken and Nigel's expertise came across as Data General's expertise, as well. Customers walked away with the best possible image of Data General."

Winning The Race

The Industry Marketing group has been amply prepared to handle the customers' information requests since the actual show. Through the use of a bar code management system, names of show attendees interested in Data General have been compiled and stored on a database.

"By using the information on this database, we know the specific requests and interests of the customers at the show," says Rod. "In just a week after the show, customers received specific brochures about Data General's manufacturing solutions. We are better able to address particular areas of interest by having better access to lead information.

"We've been very aggressive in following up on the show. Our management system puts us a step ahead of our competition, and gives us an advantage,"Rod says. "By being able to get information on our products and services out to customers so soon after the show, we stand a good chance that Data General will stay fresh in the customers' minds."

In Field Engineering

Jane Braley was recently appointed coordinator for Direct Line, which gives all Field Engineering employees the opportunity to submit questions, issues and concerns that relate to the company, the division, or their own job and environment. Jane is responsible for receiving all submissions, directing the question or suggestion to the appropriate vice president or director, and tracking responses.

An employee using the program may receive a confidential response from the executive most qualified to respond, or may be contacted directly by that person, if the employee authorizes an open response. An employee wishing to remain anonymous may also receive a response through the coordinator. In this case, only Jane knows the employee's name. Responses cannot be made to unsigned submissions. Those submitting queries to Direct Line can now expect responses within two weeks in most cases.

Jane joined Data General in December 1984. Before taking her new position, she was manager of Telemarketing in North American Field Engineering in Milford. She holds a bachelor's degree from Wheaton College, where she majored in psychology.

Training

Educational Services is offering the following software and hardware courses to employees in August and September:

• ECLIPSE MV/4000 Field Maintenance (H148) - This five-day course teaches employees how to install and

configure a Data General ECLIPSE MV/4000 computer system; load and run diagnostic programs to verify proper system operation, and perform board-level maintenance by isolation of faults to the Field Replaceable Unit. The prerequisite for this course is H100/MV (Intro to DG 32-Bit Systems). This class starts on Monday, August 31.

- ECLIPSE MV/10000 Field Maintenance (H168) This course provides a functional board-level overview of the ECLIPSE MV/10000 computer. It covers information flow and control functions in three levels; within boards, between boards and over system buses. The class emphasizes calling, running and interpreting the three levels of diagnostic programs used to troubleshoot the ECLIPSE MV/10000 computer. H100/MV (Intro to DG 32-Bit computers) is the prerequisite for this five-day course. This class will start on Monday, August 31.
- Artificial Intelligence: A Programmer's Guide (SM502)
- This three-day course will provide an introduction to the problems, techniques and applications of Artificial Intelligence. This course emphasizes actual AI case studies which allow employees to learn from actual AI programs to solve engineering problems, diagnose disease, reason about assemblies, engage in English discourse and learn from experience. The prerequisite for this course is programming experience; no previous knowledge of AI or LISP is required. This class begins on Monday, August 24.
- Communications Hardware Architecture (SM333) This course examines the concepts, architecture and characteristics of Data General communications hardware used on ECLIPSE and ECLIPSE MV computer systems. This course also provides information to those selecting operations and troubleshooting communications hardware. The prerequisite for this three-day course is DC131 (Introduction to Data Communciations and Networking) or equivalent experience. This class starts on Monday, August 31.
- AOS/VS Asynchronous Communications (SM527) This seminar describes AOS/VS structures that support asynchronous communications and explores how users can customize this interface. Standard Data General devices are used to illustrate AOS/VS data bases and the distribution of support responsibilities among system code and application programs. Interfaces to popular non-Data General communications packages and adding non-standard terminals to AOS/VS are also presented. This two-day course starts Monday, August 31.
- AOS/VS Systems Performance for System Managers (SM524) This three-day seminar is designed for system managers who want to obtain the best results from their systems for the minimum cost. Information presented here will also prove useful in estimating capacity requirements for future system growth. S219/VS (AOS/VS System Manager) and system programming experience are the prerequisites for this course. This class starts on Tueday, September 1.

Prior approval of your supervisor is required for course registration. Call (tie-line) 221-1647 to enroll in these or other classes. All classes will be held at the Education Center at 2400 Computer Drive in Westboro.

Have You Filled Out Your New W-4 Or W-4A?

The Tax Reform Act of 1986 requires that a new W-4 or W-4A be submitted to employers no later than October 1, 1987. Failure to comply with the law can result in a higher federal withholding. If a new W-4 or W-4A form is not submitted to a Data General Payroll site by October 1, the Payroll departments are required to alter employee exemptions according to the law. The law states that "if a new form W-4 or W-4A is not submitted, the employer must withhold if the employee is single, claiming one withholding allowance, or married claiming two withholding allowances, depending on whether the employee checked the single or married box on the most recent W-4 on file with the employer."


