## New Computers Extend Performance



The new ECLIPSE MV/7800 XP computer processes information faster than its predecessor, the ECLIPSE MV/7800 system.

Data General has enhanced its ECLIPSE MV/7800 series of mid-range computers with the introduction of the ECLIPSE MV/7800 XP and ECLIPSE MV/7800 DCX computers.

The ECLIPSE MV/7800 computer is a rack-mount system which offers up to 40 percent better compute performance, and provides up to 40 percent more I/O bandwidth than the original ECLIPSE MV/7800 system.

An office-packaged system, the ECLIPSE MV/7800 DCX brings the same high performance and office automation support to departmental and small business environments in a quiet, under-the-desk unit. Both systems include a full one-year, on-site warranty for both the hardware and expansion memory.

The ECLIPSE MV/7800 XP is an enhanced single-board implementation of the MV/Family architecture first introduced on the ECLIPSE MV/7800 last summer. Enhancements include an advanced microMV chip set, faster memory, and a faster processor cycle time.

Improved performance and an easy growth path for customers migrating from a 16-bit environment are available through a wide selection of printed circuit board-level and system-level upgrades. A printed circuit board-level upgrade program is also available for present ECLIPSE MV/7800 customers who want to take advantage of the improved performance of the ECLIPSE

MV/7800 XP computer.

Pricing for the ECLIPSE MV/7800 XP begins at \$23,000. Pricing for the ECLIPSE MV/7800 DCX computer begins at \$33,300.

# "The Picture Of Health" And Data General

"The Picture of Health" was the theme of the Data General exhibit at the American Hospital Association annual convention, which was held recently in Georgia. Data General illustrated its leadership in hospital computing technology by demonstrating for the first time its specialized hospital bedside terminal created exclusively for the health-care industry. Data General also introduced a new presentation called "CEO In Healthcare," which features the way CEO comprehensive electronic office software is used in hospitals.

According to Alan Law, director of Data General's Industry Marketing group, several of the leading health-care system suppliers were on hand to show that Data General is the business partner of choice by jointly exhibiting in the company's booth. These vendors included EDS/Health Services Division; Health Data Sciences; Micah Systems; Travenol Healthcare Information Systems; 3M Health Information Systems; and Elcomp Systems.

To highlight the exhibit, Health Data Sciences (HDS) demonstrated the hospital bedside terminal developed by Data General for use with the HDS ULTICARE software. ULTICARE is an innovative bedside-based hospital information system which improves the quality of patient care and shortens hospital stays. The system saves a nurse one to two hours of clerical work each shift.

The hospital bedside terminal has a 14-inch amber screen which displays characters in larger-than-normal size. An integral modem, which can handle both voice and data over twisted pair wiring is crucial, since few hospitals can rewire their buildings. An embedded badge reader, a Micom voice board and additional function keys also are integral to the terminal.

In multi-hospital corporations, CEO software allows for electronic exchange of information among hospitals throughout the country and around the world. Individual hospitals use CEO software as an efficient means to route messages and documents to anyone in the organization within seconds, greatly expanding the scope of internal communication.

In combination with powerful ECLIPSE MV/Family computer systems, these terminals will help hospitals deliver better care and keep better records, while lowering costs at the same time.

"As hospitals seek new ways to optimize their operations, they will discover that CEO is an important productivity improvement," says Alan. "It also can help hospitals market their services, an attractive benefit in today's competitive health-care environment.

"The hospital of tomorrow will provide more computerized patient care," Alan adds. "With fewer nurses and increasing attrition rate, hospitals are looking for both competitive and cost-effective solutions for quality patient care. Data General and its third-party vendor are providing those solutions and demonstrating their commitment to the future of the health-care industry."

Tempest, Rugged Systems Make The Headlines



Data General made a strong impression in June at the annual Armed Forces Communications and Electronics (AFCEA) trade show in Washington, D.C. With the announcement of the new ECLIPSE MV/15000T (Tempest) and ECLIPSE MV/15000R (Rugged) series. the company firmly established its position in the military marketplace. Now, the headlines are still telling the story in several military and government publications across the country. Below is a reproduction of the front cover of Defense News magazine, a weekly publication. The cover is a copy of the poster which was part of Data General's exhibit at the AFCEA show. According to Tom Roberts, product manager within the Federal Products group, the Tempest and Rugged systems have become industry standards. "Defense is an important vertical market within the Federal sector, and "rugged" command and control is key within that marketplace. These products have put us squarely in position of leadership in the rugged marketplace," Tom says.

# Corporate Traffic Implements New Payment System

The Corporate Traffic department, working closely with employees from the Information Management Group's Manufacturing Field Service Development Division, has developed and implemented a new freight payment system which allows Data General to ship

material more cost-effectively, and provide immediate access to shipping information.

Prior to the installation of the new system, Transportation Freight Control (TFC), Data General used outside rvices to handle freight payment. With TFC, however, ecompany now has the necessary tools to conduct the payment process in-house.

"We discovered a definite need for an upgraded method of monitoring costs," says Bob Proulx, Corporate Transportation manager. "Before we made the transition, we had outside companies pre-audit and pay our bills. We then had them post-audited as part of a verification process.

"It was then and only then that we had a true picture of freight activity and associated costs. This process took as long as six to eight weeks which severely restricted our response time to act on identified problems. We felt we had to make freight payment more visible at the company."

#### TFC And EDI

According to Brenda Pascale, Corporate Traffic section manager, TFC is a freight-payment/audit processor. The system, which has been operating since last fall, relies heavily on electronic data interchange (EDI) between Data General and its carriers. This is necessary, Brenda says, because Data General's Westboro headquarters is responsible for all the company's freight-payment activity, processing an average of more than 20,000 freight bills a month.

"We've established the standard for EDI in the transportation industry," Bob says. "We can set the pace, as well. About 80 percent of Data General's carriers now submit freight bills electronically. Now, rather than taking a month to complete the bill paying process, we can take complete the process in a matter of days."

#### How The Program Works

The first step of TFC requires the Corporate Traffic department to electronically enter bills received into the system. The software then validates the bill to ensure that it is Data General's freight bill and that the correct charges were assessed.

The next day, any exceptions are noted and processed. At this point, all information is transmitted to the Accounts Payable department, which prepares a check. The system is automatically updated each step of the way. At the end of the month, a complete ledger report is generated, which separates payments and accruals. All in all, payments to freight carriers are made quickly and accurately.

#### Other Advantages

This program will also integrate the freight-payment and private-fleet software programs, and provide for the electronic transmission of payment information between Data General, its carriers and their banks.

"As a shipper or receiver, I would much rather control my own information than rely on outside sources," Bob

says. "We know our business better than any audit house. If any issues come up, we would know how to better handle them than an outside company."

Ed Bleczinski has been named director of Corporate Purchasing. He reports to Lee Henning, vice president of Central Manufacturing Services. Ed replaces John Kavazanjian who was named vice president for International Manufacturing Operations last May.

#### Employee Devotes Time To Music



Sunday's outing at the Great Woods Performing Arts Center had a special meaning for Data General's Larry Bassett. Instead of attending the concert as a member of the audience, Larry sang with the Great Woods Festival Chorus. He has been a member of the choral group for two years.

Singing is not new to Larry, a systems engineer within the Information Management Group (IMG). He has been singing with another group, Masterworks, for 11 years. Masterworks makes up the nucleus of the Festival Chorus. The Festival Chorus typically performs with the Pittsburgh Symphony Orchestra several times a year. Masterworks performs four concerts of large classical choral music during its September to May season. Both groups are important to Larry.

"The Great Woods Festival Chorus attracts singers from the greater Boston area, as well as from towns around Mansfield," says Larry, who has been with Data General for 11 years. "You have to audition to get into the group. You are asked to sing a prepared solo piece for the director. Being chosen depends on your solo work, your ability to blend with the section, and the choral requirements for the coming season."

The Festival Chorus performed with the Pittsburgh Symphony Orchestra at the opening dedication of Great Woods in the first concert of the season last summer.

"Masterworks does not meet during the summer, and I began to miss the singing," Larry says. "Then Great Woods came along. Our total performance time is not as much as in the winter, but I enjoy it just as much. Michael Tilson Thomas, who conducts the orchestra, has said that the Great Woods chorus will play a larger role with the orchestra next season."

When performing, both Masterworks and the Great Woods group require one rehearsal a week, which runs about two and a half hours. As each group gets closer to the actual performance, an extra rehearsal may be scheduled in addition to the dress rehearsal with orchestra and soloists. According to Larry, however, the time is well-spent.
