# Mark Your Calendars - Data General Open House Drawing Near

Data General employees and their families are invited to help kick off the start of fiscal 1988 with an open house to be held on Saturday, October 10 in Westboro. This is the first time an open house has ever been held in Westboro.

On that day, employees and their guests will be able to tour the company's product development and manufacturing testing laboratories, and the new Executive Briefing Center.

This marks the first time the laboratories and the EBC have ever been opened for general viewing. Together, the tours in both buildings will provide you and your family with information on how Data General computers

are developed, their markets and their applications.

A good deal of the day's events will take place outside. The areas adjacent to Buildings 14A and 14B will be turned into a street festival. Bands and some of the most talented "street" performers from Quincy Market will entertain you throughout the day.

Hot and cold foods will be available along with soft drinks and ice cream all day long.

In addition, Data General's corporate helicopter will be on display.

So, mark October 10 on your calendar and plan on coming to Westboro. In the event of rain, all outdoor events will be moved inside.

# An Open House Feature

Come Data General-Westboro's open house on October 10, the Executive Briefing Center (EBC) will open its doors to employees, giving them a chance to see a side of the company normally viewed by customers.

Starting at noon, the EBC officially will be opened with a cake-cutting ceremony, hosted by President Ed de Castro. At that point, employees will be invited to tour the facility.

In the EBC, Marketing employees will describe Data General's products, their markets and applications. At the same time, employees will be able to view a section of the EBC which is devoted to various components of the traveling show, "Data General In Concert," which was presented this year in Chicago and New York.

According to Peace Conant, manager of Field Marketing within the Marketing Support division, the Data General In Concert components will provide employees and customers with a good history of the company.

"Placing components of Data General In Concert in the EBC serves two purposes," Peace says. "These

ces of the show clearly demonstrate Data General's corporate viability. We have a good story to tell, and a strong track record. In addition, these components show that we do have the computing solutions needed to remain a leader in this industry."

During the tours of the EBC, employees will walk through Data General In Concert components such as the Corporate Capabilities area, which includes the Time Wall, the Technology Displays area and the Video Wall. They will get a view of Data General which visitors to Data General In Concert received.

The Time Wall is a 36-foot-long by 8-foot-high mural of photographs, newsclips and corporate memorabilia which geographically represents Data General's history. In addition to glancing at the company's past, the Wall also focuses on the future with a section which depicts Data General's commitment to deliver software, telecommunications and artificial intelligence solutions. in the future.

The Technology Displays area allows employees and potential customers to view the breadth of Data General's product line and how the products work in a multitude of business environments.

The Video Wall is a collection of several customer testimonials on the benefits their firms have reaped since purchasing Data General products, reinforcing Data General's ability to deliver state of the art products for business computing solutions. In the Solutions Demonstrations area, another component of Data General in Concert, an imaginary company has been created. "The Limitless Potential Corporation" is made up of more than 40 workstations that help the company automate and integrate all of its departments and business applications using Data General equipment. This area demonstrates Data General's commitment to its six target markets of banking, brokerage, health care, insurance, manufacturing and petroleum. In the EBC, visitors will be able to see a sample of each of these industry solutions.

According to Marlene Granderath, manager of the EBC, the center also has conference rooms outfitted with executive furniture, demonstration areas for handson computer use, a customer lounge and an executive dining room which seats 80 people.

A large conference room, seating 110 people and outfitted with the latest audio-visual equipment, serves as a theater. In addition to hosting large groups of customers, the room will be used for product announcements, computer industry consultants' forums, and a range of meetings involving people interested in Data General products.

"The EBC is an extremely interesting place for anyone looking at Data General and its products," Peace says. "At the same time, on October 10, employees will get a chance to see how Marketing directs its efforts, and will walk away with a better understanding of the company they work within."

# **Attention All Music Lovers**

During Data General's open house, some of the area's most popular bands will perform.

John Lincoln Wright and the Sour Mash Revue will kick off the day's entertainment when they take the stage at 11:00 a.m. Many of you may be familiar with this country/blue grass band. They have performed in the area for quite some time. Their show will last until about 1:00 p.m.

The sounds of be-bop and jazz will then take over at about 2:00 p.m. when the Bob Brenner Swingtet takes the stage. The band plays a repertoire of hits from the 40s to the 80s. This swing band will play until 4:00 p.m.

Data General's own Robert Wheeler and Vic Berry will make their musical debut at Data General during the open house on October 10. The pair, with their ukuelele and tuba combination, will bring "Ukuelele Consciousness" to Westboro. Look for Robert and Vic at 1:00 p.m.

# **Try For A Computer**

Just for coming to the Data General open house, you will be eligible to walk away with a DATA GENERAL/One computer. In all, 100 DATA GENERAL/One Model 1

computers will be awarded to lucky employees during the afternoon.

To be eligible to receive a system, simply return the RSVP card which can be found in this newsletter. On the afternoon of October 10, 100 RSVP cards will be randomly selected. Employees whose cards are selec ed will be notified that they can pick up a DATA GENERAL/One computer, along with a printer, hard carrying case, and software, before heading for home.

Remember, to be eligible to receive a computer, you must be present at the open house.

Winners should note that they will be responsible for paying a tax based on the value of their computer.

# Data General, Logica B.V. Win \$32 Million Contract

The Ministry of Social Affairs and Employment in Netherlands has awarded Data General and Logica B.V., a software systems supplier, a \$32 million contract to implement a nation-wide integrated network to link employment bureaus. The network is designed to more efficiently match the unemployed with job vacancies. The contract was awarded after nearly two years of study.

The Data General portion of the contract is worth \$15 million. It includes the sale of 64 ECLIPSE MV/15000 and ECLIPSE MV/7800 computer systems as well as 1,600 workstations. The computers and workstations will be integrated using XODIAC and CEO comprehensive electronic office software. Data will be transmitted between locations using the Dutch public data network.

The ECLIPSE MV/Family systems will be installed in cations throughout the Netherlands including the maof cities of Amsterdam, Rotterdam, The Hague, and Utrecht. The network will be implemented in stages. Initially, systems will be installed in pilot employment bureau locations and five central support centers. Data General is the principal contractor responsible for delivery and installation of the computer systems, the fourth-generation language Powerhouse and data communications equipment. Logica B.V. is responsible for the coordination, execution, and project management of the application.

# Franson Sales, Marketing Controller; Donie, Casey Division Controllers

*Art Franson* has been named Worldwide Sales and Marketing controller, reporting to Al Getz, corporate controller. Art will provide financial support for the Sales and Marketing divisions.

Art joined Data General in 1983 as controller for the North American Sales Division (NASD). Prior to joining Data General, Art was with Digital Equipment for eight years, serving in various controller-level positions. Before that, he held financial positions with Converse Rubber and Northeast Airlines. Art holds an MBA in finance from Babson College, and a bachelor's degree in business administration from Northeastern University.

Reporting to Art are: Ed Donie, who has been named European controller based in Paris; Jim Casey, who has been appointed controller for NASD; Dave Evans, controller for the Americas/Far East Division; Dave Ridlon, director of North American Credit Operations; William Plant, controller for the Customer Service Division; and Tom Stone, Corporate Sales Administration controller.

*Ed Donie* has been with Data General since 1981, most recently as the Group Marketing controller. Ed will continue to serve as controller for Group Marketing until a successor is named. He holds an MBA in finance from Bentley College and a bachelor's in business administration from the Massachusetts Institute of Technology.

*Jim Casey* has been with Data General since 1983 as the controller for NASD's Area I. Jim holds an MBA in finance from St John's University, and a bachelor's degree in finance from New York University.

# Data General, E.F. Hutton To Provide Employee Stock Service

A new era in service for employee stockholders begins Monday, September 28, as Data General and E.F. Hutton join forces to provide brokerage accounts for United States participants in the Data General Employee Stock Purchase Plan and Stock Option plans. By opening a Hutton account for either or both programs - the purchase plan or stock option plan - an employee may more easily acquire, hold and sell Data General stock.

"We are pleased to be able to bring this service to employees," explains Ellen Richstone, acting treasurer. "As part of the company's agreement with E.F. Hutton, the commission rates for the sale of Data General shares by individual employees are extremely competitive. We believe these accounts will encourage greater participation in stock plan programs."

"Employee participation in our stock programs is important," explains Don Bateman, vice president of Human Resources. "First, it provides for employee ownership in the company. Second, it provides the opportunity for additional compensation over time through the purchase and sale of stock."

#### **Option Plan**

An information package on the Hutton brokerage accounts is currently being mailed to participants in stock option programs. The package includes the agreements needed to open separate brokerage accounts for both option and purchase plan transactions.

The main feature of the option plan account is a simultaneous sale provision that allows employees to exercise an option and at the same time sell enough shares to cover the option price and taxes.

### Purchase Plan

The account for the purchase plan will allow employees who participate in the Employee Stock Purchase Plan each six months to accumulate shares to sell at the end of the purchase period. These account agreements will be mailed in November to both current and eligible participants in the Employee Stock Purchase plan.

Any employee participating in the current Stock Purchase plan period will be able to use a Hutton brokerage account for shares purchased on January 29, 1988. Any other employee choosing to open an account may use it during any period in which he or she actively participates in the purchase plan.

"Historically, some employees have chosen not to participate in the purchase plan because of the difficulty and expense of trading small numbers of shares," states Sue Singer, Corporate Stock manager. "With the E.F. Hutton brokerage account, an employee may choose to sell each purchase period's shares immediately without ever receiving a stock certificate. The employee may also choose to use the account to accumulate shares and sell any number of shares at any time."


# New Forms

Participation in either or both E.F. Hutton brokerage accounts is, of course, optional. An employee may continue to exercise options or participate in the purchase plan and receive stock certificates as in the past.

Whether participating in a Hutton plan or not, however, a new form will be used for exercising options beginning on Monday. These forms will be available from Employee Shareholder Services at Mail Stop F-233 in Westboro; at Benefits offices; and through the Literature Distribution stockroom at Southboro. Transactions through Hutton accounts cannot be completed on anyother form. For the next stock purchase period, the authorization and withdrawal form will also be modified so that participants may indicate whether or not they have a Hutton account.

Completed agreements to participate in either or both of the Hutton programs and all stock option transactions must be forwarded directly to Employee Shareholder Services in Westboro. Purchase plan enrollments and withdrawals will continue to be processed through the Benefits department. All activity in individual brokerage accounts, will be handled directly between the employee and E.F. Hutton.

The same advantages being offered to U.S. employees will be extended to international employees in the future in accord with local laws.



Data General employees can learn various ways to address and fix certain concerns they may encounter with their terminals or CEO comprehensive electronic office software. # **Benefits Brief**

# Retirement Update

The following article will provide you with information on Data General's Pension Plan. It appears in a question and answer format to make it easy to understand.

The Data General Pension Plan is a part of a retirement program established for employees. The plan provides a monthly pension, life insurance coverage for you, and a choice in medical benefits for you and your family. The Pension Plan, together with the other Data General capital accumulation plans, such as Savings & Investment, Stock Plans and Stock Option, should be viewed as a part of your total retirement which also includes other sources of income such as Social Security and personal savings.

# Who is eligible to participate and when does participation begin?

- Generally, all Data General employees are eligible to participate unless hired after turning 60.

- Participation begins automatically the month after you have completed one year of service and have reached age 21.

#### When are you eligible for retirement?

- *Normal Retirement.* You are eligible for normal retirement at age 65.

- *Early Retirement.* You may retire early starting at age 55 if you have at least 10 years of service. Your benefits will be reduced by a percentage based upon your age at retirement.

#### How do you apply for retirement?

- You apply for retirement by writing to Retiree Benefits at Mail Stop D-138 in Westboro at least 90 days prior to your requested date of retirement.

- In order to complete the process you must submit the following by the first of the month during which you will be terminating employment:

1) A completed *Pension Application and Authorization Form.* 

2) A completed Retiree Benefits Election Form.

- 3) A copy of your birth certificate.
- 4) A copy of your spouse's birth certificate.

- Your pension checks will be received by the first week of every month following your last day worked.

#### Are pension benefits taxed?

- Pension benefits are taxed as ordinary income. You must elect whether or not you wish to have taxes withheld, and the number of exemptions to be applied, when you retire.

# Does employment elsewhere after retirement affect pension benefits at all?

- Employment elsewhere after retirement does not affect your Data General pension benefits. However employment might effect any Social Security benefits to which you are entitled.

- Your pension benefit is not affected or reduced in any way by your Social Security benefit.

# Are survivor benefits available for a beneficiary if you die after retirement?

- When you retire you can elect a Life Annuity payment which will be received for the remainder of you lifetime with no survivor benefits

OR

- You can elect one of the survivor options which provides you with a reduced benefit for the remainder of your lifetime but also provides your survivor with a percentage of this benefit after your death.

#### How are benefits determined?

- After you become a participant you earn a benefit every year until you retire or reach age 65.

- For each year (from October 1 to September 30) you earn a benefit equal to 1 percent of your base pay as of October 1, up to the Social Security wage base for that year (\$43,800 in 1987).

- In addition, if your rate of pay exceeds the wage base, you will earn a benefit equal to 2 percent of your pay in excess of the wage base.

- The benefit you earn each year is added to the benefits you have accumulated from past years of service. This total is the annual amount to which you will be entitled at 65 if you are 100 percent vested.

#### - Example:

Plan Year	Compen- sation		Accrued Benefit
1982-1988	\$30,000	x 1% x 7 yrs. =	\$2100
1989-1996	\$35,000	x 1% x 8 yrs. =	\$2800
1997-2004	\$40,000	x 1% x 8 yrs. =	\$3200
2005-2007	\$45,000	x 1% x 3 yrs. =	\$1350

Total Annual Benefit To Date = \$9,450 Monthly Pension Received At 65 = \$787

(Above example assumes 25 years of service, and assumes little salary change over time. Example also assumes an increase in the Social Security wage base from \$43,800)

#### What does it mean to be vested?

- A vested benefit is that portion of your benefit which is non-forfeitable.

- Vesting is based upon your years of service with the

company as of age 18. Vesting begins after five years of service.

- The percentage of your benefit which is non-forfeitable increases with every year of service up to 15 years. For example, after five years of service you are 25 percent vested, and entitled to 25 percent of your benefit. After 10 years you are 50 percent vested. After 15 years of service you will be 100 percent vested and entitled to 100 percent of your benefit.

- If you are eligible for retirement you are automatically 100 percent vested.

- If you terminate employment with Data General before retirement and the present value of your retirement benefit is greater than \$3500 you will receive a monthly pension starting at 65. You can receive a reduced monthly benefit before reaching 65, after reaching 55 if you have at least 10 years of service at termination.

- If the present value of your benefit is \$3500 or less you will automatically receive your benefit in a lump sum within 2-3 months of termination.

- Persons receiving a deferred vested benefit or a lump sum are not eligible for Retiree Medical or Retiree Life Insurance.

# What happens to your benefits if you die before retiring?

- If you are married and vested at the time of your death your spouse is eligible to receive death benefits, otherwise no survivor benefits are available.

#### Who should you contact for further information?

- Your Benefit Statement that you receive each year wil<sup>\*\*\*</sup> provide you with personalized pension information.<sup>\*\*</sup> Please refer to it to determine the benefit you have accrued and your vesting percentage.

#### Fiscal Calendars Available From Southboro

A 1988 fiscal calendar, produced by the Westboro PRIDE Circles, is available to employees. It contains extensions to commonly-called departments and tie lines to other Data General facilities. # **PSAT Dates For Data General Scholarships Set**

If you are a regular full-time Data General employee d have a child who will be graduating from high school in 1989, now is the time to consider applying for a Data General Scholarship. The scholarship program is a Data General benefit established for the children of Data General employees. It is administered by the National Merit Scholarship Corporation. Ten scholarships are awarded each year. The stipend of each scholarship ranges from \$500 to \$2,000 per year for up to four years, or until bachelor's degree requirements are completed, whichever comes first.

Students applying for a Data General scholarship must take the PSAT (Preliminary Scholastic Aptitude Test) during their junior year in high school. This year the test will be administered in high schools throughout the country on October 17 or October 20. Interested students should contact their guidance counselors as soon as possible to register for the PSAT.

Keep in mind that application for a Data General scholarship must be made during the students JUNIOR year in high school. Therefore, even students who are currently undecided as to whether or not they want to attend college should be encouraged to take the PSAT in October.

Applications for the Data General Scholarship program are available from the Benefits and Human Resource departments. A letter will be sent to all applicants

the end of December to let them know their entry form was received.

# **Helicopter Schedule Is Revised**

Effective Monday, September 28, the Data General helicopter will operate on the following schedule. Service is available to all employees traveling on company business on a first-come, first-served basis. The traveler's cost center is charged \$45 for trips between Westboro/Southboro and Durham/Porstmouth, or \$75 for trips between Westboro/Southboro and Westbrook.

To make reservations call Corporate TRavel in Westboro at (tie line) 232-HELI (232-4354). Passengers must be at the helipad **5** minutes before scheduled departure time for loading and a safety briefing. Unless delayed by weather, flights will depart precisely on time, or earlier if all scheduled passengers are boarded.

Passengers desiring to depart/arrive at Southboro may do so by advising the reservationist. Actual departure time may be a few minutes before or after the scheduled time shown for Westboro/Southboro.

Mail and packages to sites the helicopter travels to may be left in the mailbox at each helipad for delivery. Senders should check with Corporate Travel to ensure that the scheduled flight is going. *It is the responsibility of the sender to arrange for pick-up at the destination.* The pilot will deliver the material to the appropriate mailbox, but they are not serviced by the mailrooms. *Any package weighing more than five pounds must be pre-arranged for delivery with Corporate Travel.*

• *Diagnostic Operating System User (H101)* - This course teaches employees how to use Data General's diagnostics to test for and isolate malfunctions to a field replaceable unit level.
