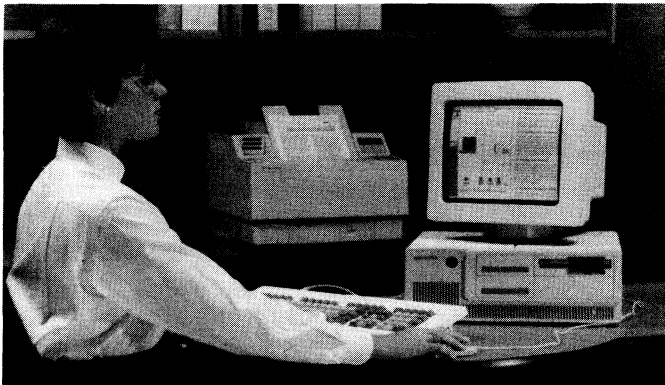

Data General Introduces Desktop Composition Solution



With CEO Desktop Composer, customers can produce documents ranging from four-page newsletters to brochures. CEO Desktop Composer is a version of Ventura software from Xerox.

Data General has introduced its first complete PC-based desktop composition product. **CEO Desktop Composer** is a version of Xerox Ventura Publisher 1.1 software, customized by Data General for its systems. The software is being offered through a marketing agreement between Data General and Xerox.

The desktop publishing system will allow users to combine word processing with a graphics capability that allows them to integrate charts, tables, headlines and drawings into documents. All of the steps can be done electronically at a video terminal, rather than manually at a drawing board. The result, whether a four-page newsletter or a book, can then be sent electronically to a typesetter or to an office printer.

The market for corporate publishing systems is expected to reach \$9 billion by 1990.

CEO Desktop Composer takes advantage of connectivity capabilities provided by CEO and networking software. By using CEO Connection and DG/PC*1 network software, CEO Desktop Composer users can share information and resources among each other, with ECLIPSE MV/Family computers and with main-frame systems.

"Ventura Publisher is a recognized leader in corporate publishing," says Dave Lyons, vice president of Group Marketing. "By integrating Ventura's superior qualities with CEO and networking software, Data General now offers a broad range of corporate publishing tools."

"Xerox is very pleased that a leading information system supplier, Data General, selected Ventura Publisher for their end-users," says Donald Dempsey, vice president of Xerox OEM marketing and sales. "With the added value that Data General brings to Ventura Publisher, Data General users can experience the software's full publishing power within their own proprietary environment."

A Three Stage Offering

Data General will sell CEO Desktop Composer in three packages: the Workstation Package, the Peripherals Package, and the Software Package.

The **Workstation Package** includes a Data General DASHER/286 computer with 640 KB of memory; a 20-MB hard disk; a 15-inch, high-resolution full-display monochrome monitor; a mouse; CEO Desktop Composer, MS/DOS CEOwrite, and CEO Connection. This package costs \$6,460.

CEO Desktop Composer, which operates on MS-DOS software, is compatible with IBM PC/XT, AT, and compatible computers. For customers already using these

systems, Data General offers the *Peripherals Package*, priced at \$3,090. It provides the same CEO software as the Workstation Package, the mouse, and the full-page monochrome display.

For users with an existing set of PC hardware, the company offers the *Software Package*. It includes CEO Desktop Composer, MS/DOS CEOwrite, and CEO Connection. Customers can purchase this package for \$1,640.

Additionally, for customers already operating on PC hardware, and CEO software except for CEO Desktop Composer, a single version of CEO Desktop Composer is available for \$895.

As an optional item, Data General now offers a compatible, 12-page-per-minute (PPM) tabletop laser printer. The printer costs \$4,195.

For customers requiring the power of PostScript output, Data General has entered into an Independent Hardware Vendor Agreement (IHV) with QMS, Inc., for its 8-PPM PostScript printer. QMS is a leader in providing superior and cost-effective PostScript printer solutions for desktop publishing requirements. In the future, Data General plans to offer this level of output capability as well.

"Because of Ventura's rich functionality, and ability to publish a range of documents, we feel that Ventura has greater appeal in many of our targeted vertical markets like insurance, banking and finance," says Caren Spital, Data General product manager for CEO Desktop Composer.

"Our ability here is to act as a systems integrator. By integrating Ventura into our CEO software, and by using our departmental processors as communication and peripheral servers, we enable a customer to easily share information in a corporate environment. In the future, we will enhance our PC-based desktop composition offering with multi-user capability."

Through DG/PC*I, a CEO Desktop Composer customer can communicate with other PC users, a departmental system, and share and print files. CEO GKM graphics files, AOS/VS CEOwrite and MS/DOS CEOwrite word processing documents can be integrated into CEO Desktop Composer using CEO, DG/PC*I, and/or CEO Connection.

Data General will offer a comprehensive training program for CEO Desktop Composer customers, including self-study and classroom-based offerings. In the near future, the company will introduce versions of CEO Desktop Composer in French, German, Spanish, Swedish and Italian.

All CEO Desktop Composer products and packages are available for shipment 60 days after receipt of order.

A Full House

In addition to CEO Desktop Composer, Data General currently supports two other publishing systems.

Intercon Associates offers a CEO-integrated software application, OFFICE/Publisher. Operating on ECLIPSE MV/Family computers, it can be used in publishing applications which do not require graphics.

Data General also supports Penta software, a series of CEO integrated electronic publishing systems for high-end corporate, commercial and publishing typesetting markets. Penta Systems' software operate on ECLIPSE MV/Family computers.

CEO Is Enhanced

Data General has introduced a new version of CEO office automation software, with significant enhancements in the word processing, document processing, and electronic mail functions. CEO Revision 3.00 supports Data General's CEO Desktop Composer package.

Three major improvements include the ability to create compound documents, to access a new version of AOS/VS CEOwrite word processing software, and to use a global user directory.

CEO 3.00 offers customers two word processing options: CEO Word Processor, and now AOS/VS CEOwrite. AOS/VS CEOwrite is available as an optional purchase with CEO 3.00, under the Data General AOS/VS operating system.

A user can select AOS/VS CEOwrite as the primary word processor in the CEO Filing Profile menu. CEO 3.00 provides easy conversion between CEO Word Processor and AOS/VS CEOwrite files. AOS/VS CEOwrite text files are also automatically accepted by CEO Desktop Composer.

AOS/VS CEOwrite allows customers to incorporate graphics, spreadsheets, and data tables in word processing documents. Users can create a compound document component within an AOS/VS CEOwrite document, or create a reference to a spreadsheet, data table or graphic stored separately within the CEO filing system.

"Since CEO's inception in 1981, Data General has designed CEO as a customer-driven product that evolves as the needs of our customers evolve," says Chris Stone, manager of office systems software. "Our new version of CEO, and its rich functionality, is a continuation of that product design strategy."

CEO Features

Other CEO 3.00 features include:

- Advanced word processing features like forms fill-in, column snaking, scientific notation, side-by-side columns, and line and box drawing available with AOS/VS CEOwrite;
- Printing enhancements for desktop composition, such as Postscript printer support (text and graphics), and HP Laserjet graphics support;
- A "global" network directory system for multiple sites that allows sending mail without requiring knowledge of the recipient's host system name;
- Mailing entire folders as a single entity. (Includes CEO files, AOS/VS files, and graphic files);
- Specifying the time of electronic mail delivery;

- Increasing the length of short messages;
- Automatic archiving;
- Retrieving deleted files in a user's electronic mail Inbox;
- Allowing a user to only read, delete, or reply to an electronic message by selecting the "Eyes Only" mail option;
- Spell checking and verification "anywhere" in CEO;
- Scheduling meetings through CEO Interrupt facility;
- Observing four different calendars at once; and
- Accessing calendars across networks.

Current CEO customers with the appropriate support and subscription service contract will receive CEO 3.00 at no additional charge. AOS/VS CEOwrite is priced separately. For new CEO customers, pricing has not changed from prior revisions. For example, CEO ranges in price from \$5,360 for the Data General ECLIPSE MV/1400 system, to \$50,015 for the ECLIPSE MV/2000 Model 2 system. There are currently 6,000 CEO software licenses worldwide.

AOS/VS CEOwrite is available for shipment 90 days after receipt of order (ARO). CEO 3.00 is available for shipment 60 days ARO.

NASA Uses New CEO

CEO 3.0 has been installed at the National Aeronautics and Space Administration's (NASA) Marshall Space Flight Center in Huntsville, Alabama.

Boeing Computer Support Services provides computational support to the flight center. Willie Staggs, CEO Technical manager for Boeing Computer Support Services, says, "The new version of CEO 3.0 addresses all user levels at the flight center. The advanced word processing features are beneficial to those users handling the administrative functions, while middle management and executives can incorporate graphics, compound documents and spreadsheets into their projects and reports. We find new features of CEO 3.0, such as the global user directory and sending messages without knowledge of the recipient's host, provide employees with greater ease of use and performance."

The Alabama center focuses on research and development for major projects such as the Shuttle, Space Station, Hubble Space Telescope and Spacelab.

Data General Expands Rack-Mount Processor Family

Data General has expanded its 32-bit offerings with the introduction of the rack-mounted ECLIPSE MV/1400RM computer, and an enhanced version of the rack-mounted ECLIPSE MV/2000RM computer. Each computer occupies only seven inches of vertical rack space, and is mounted on slides so that it can be upgraded and maintained easily.

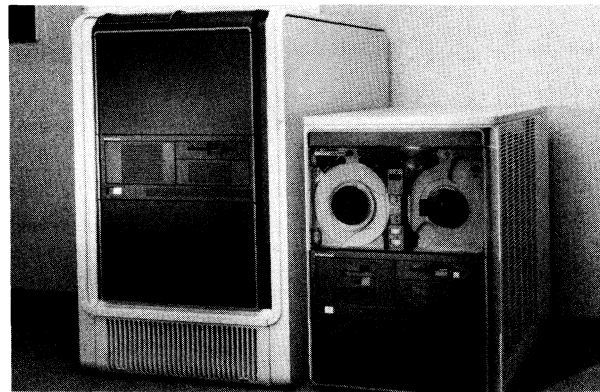
According to Product Manager Jerry Schiowitz, all ECLIPSE MV/1400 and ECLIPSE MV/2000 computer systems are now available in rack-mount configurations, at about the same pricing as under-the-desk units. In

addition, the rack-mounted computers are optionally available with a streaming tape subsystem. Targeted at value added resellers (VAR) and systems integrators, the rack-mount product family is geared to many technical and commercial situations.

The ECLIPSE MV/1400RM supports up to eight users.

The ECLIPSE MV/2000RM has been enhanced to include 4MB of base system memory and supports as many as 24 users, depending on the application.

Prices for the ECLIPSE MV/1400RM computer begin at \$9,995. The ECLIPSE MV/1400RMT (which includes the ECLIPSE MV/1400RM computer and a 1600-BPI streaming tape subsystem in a 29-inch-high cabinet) is \$18,370. All systems are available with 45 days after receipt of order.

Recruiting Workshops To Enforce Company's Image

When graduating college seniors are interviewing for positions at dozens of companies, how does a recruiter set Data General apart from the others? What should be conveyed to the potential candidates so that they will feel that Data General is a company where they will make a difference?

To prepare employees who recruit graduates on college campuses all across the United States, the College Relations department is conducting a series of college recruiting training workshops. Two of those seminars, "The Role Of The Recruiter," and "On-Campus Interview Skills," were held earlier this week. Another, "Selling Data General," is being held next week. The same set of seminars will be held again in February, just in time for the college recruiting season in order to acquaint employees involved in the recruiting process with the techniques needed to conduct effective interviews.

These training sessions will help employees who accept recruiting assignments to feel comfortable talking about the company and its employment and career opportunities.

"Data General hires a high percentage of new employees from college campuses each year," says Harry Flad, manager of College Relations. "In 1987, we conducted 400 recruiting sessions on college campuses across the country. As a result, we receive an average of 8,000 resumes in a year. With that many people looking at Data General as a potential place of employment, we must be sure the prospective candidates are given the right information and feedback to make the right choice."

This week's first session included presentations from employees within Corporate Compensation, Employee Relations, and Management and Organizational Development (MOD).

Audrey King, an employee within Corporate Compensation, helped recruiters to better understand their role in attracting talented graduates to the company. Ken Kerber, who works in MOD, complemented Audrey's presentation by emphasizing the role recruiters have in setting expectations of the company and their responsibilities for the prospective candidates.

The session also included a presentation from Dick Gaucher, manager of Employee Relations. Dick delivered information on equal employment opportunity and Data General's commitment to affirmative action.

Experience is always a good teacher. That is why one of this week's sessions included a panel discussion with three employees who had recruited college graduates in the past. Jane Marvin, Phyllis Goldberg and Kris Gregson, employees within Human Resources, described various experiences they have had as college recruiters so that this year's college recruiters can learn from them.

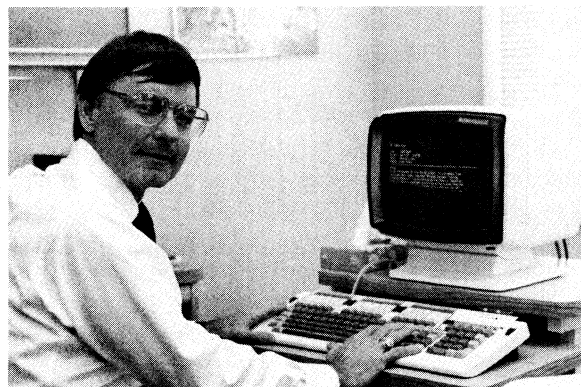
During the second workshop on Wednesday, "On-Campus Interview Skills," Harry left recruiters with ideas on planning and conducting the actual interview.

"The employee acting as a recruiter is the first handshake, the first impression of Data General, that prospective candidates have," Harry says. "The recruiter sets off a chain of events during which the prospective candidate must make a decision. Data General has an accept ratio - graduates who accept offers to Data General - which is often better than the national average. Our recruiters play a highly-visible, crucial role."

The third workshop in the series, "Selling Data General," scheduled to be held next Tuesday, will include a session in which recruiters are taught how to deliver an overview of the computer industry and Data General's strategy for the future.

"Our main objective with these training workshops is to help employees understand the importance of the role of the recruiter," Harry says. "With these training sessions, we also want employees to maintain a sense of pride in the company. Recruiters deserve to be prepared effectively, and should feel comfortable talking about the company. These sessions will accomplish these goals."

Data General Gives Athletes An Edge

Because of the division's extensive use of equipment which has been donated to it by Data General, the company has been selected as the "Official Technical Computer Sponsor of the 1988 U.S. Olympic Committee and the 1988 U.S. Olympic Team." The Sports Science Division has used Data General computer equipment since 1979 for an integrated program that analyzes and improves the biomechanical, physiological and psychological performance capabilities of many U.S. athletes. The cornerstone of the division's computer system is an ECLIPSE MV/10000 computer which is used for data storage, statistical computing and graphics production, and CEO office automation software. Other equipment donated includes an ECLIPSE MV/4000, DASHER 286 personal computers, DATA GENERAL/One portable computers, a DS/7500 graphics workstation and complete field support for both new and existing equipment.

Vote Your Proxy

Data General's Annual Meeting of Stockholders will be held at 11:00 a.m. on Wednesday, January 27 at the State St. Bank and Trust Company in Boston. Proxy material for the meeting has been mailed to all stockholders.

This year's Proxy Statement asks stockholders to elect five directors and approve amendments to the:

- Restricted Stock Option Plan;
- Employee Incentive Stock Option Plan; and
- Employee Qualified Stock Purchase Plan.

Approval of the amendment to the Restricted Stock Option Plan would increase the number of shares which may be issued to 11 million from 10 million. A "For" vote to this amendment would also extend the plan for

an additional 10 years, to December 31, 1998. Through this program, the company is able to grant "restricted stock options" to employees.

The amendment to the Employee Incentive Stock Option Plan would change the title of the program to the "Employee Stock Option Plan." It also would permit the Incentive Committee to grant stock to participants as either "qualified" or "non-qualified."

The amendment to the Employee Qualified Stock Purchase Plan would reduce the term of service with Data General required to be eligible to participate in the plan to 90 days from one year.

Approval of each of the amendments will help Data General to attract, retain and motivate key employees.

For further information about any of the amendments, employees should read pages 2 through 20 of the Proxy Statement you received.

Employees can vote their proxy by filling out your proxy card(s), signing and dating it, and returning it in the return envelope which accompanied your Proxy Statement. You also may return the proxy card via internal mail to the Public Affairs department in Westboro at Mail Stop A-235.
