Data General Reports Third Quarter Results

Data General's net income for the third quarter, which ended June 25, was \$1.9 million, or \$0.06 per share. During the same quarter a year ago, the company reported a net loss of \$65.1 million, or \$2.40 per share, including a non-recurring charge resulting from a restructuring and cost-reduction program of \$53.8 million, or \$1.99 per share.

Revenues for the third quarter were \$330.7 million, compared with revenues of \$313.6 million for the third quarter last year, an increase of 5.5 percent.

Operating income for the quarter was \$3.0 million, or 0.9 percent of revenues, compared with an operating loss of \$62.1 million, including the non-recurring charge, for the third quarter last year.

Net income for the first three quarters of 1988 was \$31.5 million, or \$1.06 per share, including an extraordinary tax credit of \$4.6 million, or \$0.15 per share. For the same period last year, the company reported a net loss of \$104.4 million, or \$3.89 per share, including an extraordinary loss of \$18.2 million, or \$0.68 per share, and a non-recurring charge of \$53.8 million, or \$1.99 per share.

Revenues for the first three quarters of 1988 totaled \$1.02 billion, compared with \$942.1 million for the same period last year, an increase of 8.6 percent. Operating income for the nine-month period was \$40.7 million, or 4.0 percent of revenues, compared with an operating loss, including the non-recurring charge, of \$63.6 million in the prior year.

"While we remain profitable, we are disappointed with the level of revenues generated in the current quarter," says President Ed de Castro. "Over the last few months we have increased hiring in the R&D and Sales areas. Our recruiting program has been very aggressive and we are pleased with the quantity and quality of talent we have been able to attract to Data General. These investments, while critical to growth in the long term, have had a negative effect on current profits.

"In light of ongoing uncertain demand, we continue to identify opportunities to reduce costs, such as our

previously announced intention to phase out manufacturing operations in Sunnyvale, California, and in Singapore by the end of the calendar year."

Basoli Named Direct Material Purchasing Director

Lou Basoli has been named director of Direct Material Purchasing. He reports to Ed Bleczynski, director of Corporate Purchasing in the Central Manufacturing Services organization.

As director of Direct Material Purchasing, Lou will be responsible for the Semiconductor Purchasing, Peripheral Purchasing and Commodity Purchasing operations. He also will manage the strategic partnerships with selected direct material suppliers to Data General.

Lou has been with Data General for 10 years. Most recently, he was manager of Direct Material Purchasing. Prior to that, Lou was manager of Purchasing Services.

Controller Appointments Made Within Finance

Neil Rossen, David Smyth and Jim Gribaudo have assumed new controller responsibilities within the Finance division.

Neil has been named controller of the Communications Systems Group (CSG), reporting to Al Getz, vice president and corporate controller. Since joining Data General in 1982, Neil has held a variety of senior financial positions, including controller responsibilities for the Americas/Far East division, the United Kingdom and, most recently, the Software Business Unit. Prior to joining Data General, Neil held financial management positions with Northern Telecom and Peat, Marwick, Mitchell and Company. Reporting to Neil are: Al Lanzetta, assistant controller within CSG; and Mark Harris, Project Office manager.

David succeeds Neil as controller for the Software Business Unit. He reports to Bob McBride, assistant

controller of Worldwide Sales and Marketing. During David's three years with Data General, he has held senior financial positions in the United Kingdom, most recently as assistant controller for that subsidiary. Before joining Data General, David was with Honeywell Information Systems for nine years.

Jim has been named controller for the Systems Development Division, reporting to Al Getz. Jim has been with Data General since 1981 and most recently was controller for the Special Systems group.

China Moves Towards Modernization With Data General

As industrial China moves towards the twenty-first century, Data General is playing a key role with the modernization efforts within the transportation, education and communication industries. Dalian Locomotive and Rolling Stock Works and Shanghai Maritime Institute have both recently installed Data General ECLIPSE MV/Family computer systems.

Dalian Locomotive and Rolling Stock Works was founded in 1901 and has become the nation's leading

factory in the industry with 11,000 employees. The main products manufactured are: diesel engines, steam engines and locomotive compartments.

One of the first firms in the industry to look to computerization as part of its continuous full-scale technical reform, Dalian Locomotive and Rolling Stock Works looked to Data General as its supplier of hardware to run the administration, management and engineering application software systems. In 1986, Dalian Locomotive and Rolling Stock Works installed two ECLIPSE MV/4000 computers and three DESKTOP GENERATION computer systems. At the same time, the Data General hardware is able to provide the platform for the full integration and networking of the various systems.

Recently, these systems have been upgraded and expanded to a large scale network which is centered around an ECLIPSE MV/20000 computer and three ECLIPSE MV/7800 systems.

Shanghai Maritime Institute is one of the most prestigious institutions providing tertiary education in communication and transportation. The institute has more than 4,000 students studying in more than ten area of specialization.

It recently purchased one ECLIPSE MV/20000 computer, an ECLIPSE MV/7800 and four ECLIPSE MV/7800 DC systems. These computers form an integrated system which is used as a teaching aid for office automation, networking, management information system (MIS) and other computer studies. The system also is used in the research and development of various application software. With CEO software, the system also serves the school's administration department and faculty members.

Singapore Company Goes With Data General

Industrial Resources Enterprise Contract Services (IRE) of Singapore has recently purchased an ECLIPSE MV/2000 DC computer to be used in the accounting, payroll, contract and stock-keeping department.

With 100 employees and nearly 3000 contract workers, IRE is one of the largest contractors in Singapore which offers painting, architectural coating, water-proofing and building maintenance services. Its customers include the Singapore Housing and Development Board as well as other property owners. The ECLIPSE MV/2000 DC computer is the first multi-user system installed in IRE.

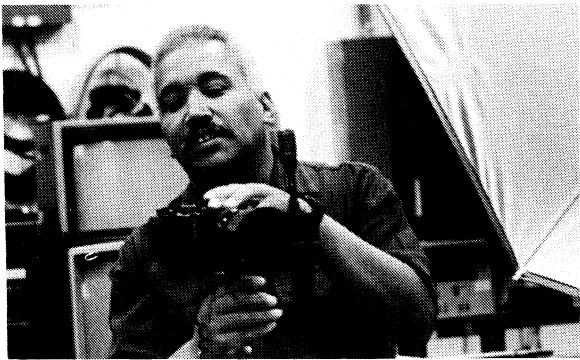
Data General Employee Becomes Citizen

Security Policy Focuses On Data

Of paramount importance to an industry as competitive as the computer industry is the need to protect information. That is why Data General's Security department and Communication System Group have developed a policy that advises employees on how they should handle the information they generate. Highlights of the policy are featured below, a full version can be obtained from your manager.

Managers

All Data General managers and supervisors are personally responsible within their areas of control for:

1. Implementing the electronic information security policies and procedures.
2. Ensuring that all employees, for whom they are directly responsible, understand their obligations for protecting all Data General assets.

3. If any customers are to be given any information, they will receive only information on an announced product.

Individual Contributors

All employees accessing and using electronic information have the responsibility to:

1. Comply with all Data General information security policies and procedures, electronic or otherwise.
2. Report any known, suspected, or potential policy violations to their respective managers.
3. Use data to which they have access only for company purposes. Under no circumstances will employees transfer data to non-Data General sites or individuals by any means unless the transfer has been authorized by managers.
4. Change CEO passwords at least quarterly. Passwords should be kept confidential, and employees should not use easily guessed passwords.
5. Employees having access to personal systems which permit them to store, delete, modify, or transfer files using electronic media accept full responsibility for security and back-up/recovery of the electronic media as well as the data's integrity.

Stock Purchase Plan Information Must Be Verified

To ensure that the correct number of shares are purchased for each employee in the Employee Stock Purchase Plan for the period ending July 29, participants should verify the contribution amount shown on their pay stubs. This is especially important for employees who have transferred payroll locations.

The Stock Purchase balance shown in the lower right-hand box of your pay stub should be the total of the amounts withheld each week since February 1 plus any carryover from the previous plan. If you have any questions about the accuracy of your balance, please contact your local Payroll department. Corrections that may be necessary after the plan ends will be processed through August 29 only.

Employees receiving stock certificates will have them mailed to the address that appears on their pay stub.

If you have moved recently, please make sure your records have been updated.

Employees using an E.F. Hutton account will receive a statement from E.F. Hutton reflecting the number of shares held in the account, or a check for the net proceeds on the settlement date.
