Window Hours Change

Stock Bought At \$14.50, New Period Price Is \$14.25

Employees who participated in the Data General Stock Purchase Program, which ended on July 31, purchased stock at \$14.50, 85 percent of the average market price on July 31, the last day of the plan.

Data General stock certificates will soon be mailed to participants' homes. Anyone who expects to receive stock but does not by August 21, should first contact Employee Shareholder Services in Westboro to verify purchase, then contact First Chicago of New York at (212) 587-6447 to find out if the certificate was returned to First Chicago as undeliverable.

Allow at least one week for the certificate to be returned to First Chicago.

For the August through January period, the opening day price was 4.25, 85 percent of the average warket price on August 1. Stock will be purchased at \$14.25 or 85 percent of the average market

price on January 31, 1990, whichever is lower.

For your information, the average fair market value on July 31, was \$16.81.

Data General Introduces Korean CEO



The Korean version of CEO attracted a lot of attention at the recent Korean Software Exhibition.

Data General and its Korean distributor, Zungwon Systems (ZWS), recently introduced a Korean version of Comprehensive Electronic Office (CEO) automation software at the Korean Software Exhibition held in Seoul.

CEO is the first office automation product introduced in Korea which supports Hangul and Chinese capabilities; both are necessary for the Korean business environment. The Korean language consists of two written forms. The first, Hangul, is a phonetic language with about 50

phonetic alphabets which form Hangul characters. The second, Chinese, consists of approximately 4,000 characters and are used frequently to clarify the meaning. Most Hangul phrases can be translated into Chinese phrases. A Korean person's name and address are usually written in Chinese characters.

Since the introduction of the English version of CEO in 1981, CEO is now available in many languages including Italian, French, Portuguese, Spanish, German and Japanese. There are more than 280,000 users worldwide and more than 8000 licenses have been issued.

"We were very pleased to introduce Korean CEO at the Korean Software Exhibition Centre," says S.S. Lee, director of Research and Development for ZWS. "This localized product is the first integrated office automation system to be introduced in Korea and has many features which meet the requirements of the business environment in the fast growing economy of this country."

Paul Jones, general manager at Data General-Korea, says, "We already have more than 170 Data General users in a broad range of industries in Korea, including 36 universities, the Korean Electric Corporation, the Investment and Finance Corporation, government ministries, banks, hospitals and

manufacturing plants. We are very excited about the potentials and opportunities for both existing and new customers that Korean CEO will bring to Data General and our distributor, Zungwon Systems."

Sarkissian Addresses Japanese

In an event sponsored by Data General and Nippon Telegraph and Telephone (NTT), Vahe Sarkissian, vice president of the Telecommunications Products Division, recently discussed information exchange and networking with Japanese computer users. Vahe talked about Data General's relationship with NTT and Data General's efforts in producing a new generation of high-speed, integrated communications systems for NTT. The Japanese company

expects to make the private networking product available to its customers this fall.

"NTT chose Data General as its partner to bring you networking solutions because NTT saw Data General to be a computer company with a strong commitment to information networks," said Vahe. "Data General believes in the convergence of computing and telecommunications into the information business.

"NTT and Data General have teamed up to provide a comprehensive solution for Japanese-based, private, multinational networks to address tremendous diversity. Network solutions such as CEPT 1, ISDN-SD, ISDN-T1 and ISDN, are based on international standards and migration capabilities from older standards.

"With this capability, network integration becomes greatly simplified and enables users to plan for long range requirements and begin to implement solutions in an orderly manner.

"These comprehensive solutions will be available in various phases over a period of time. As these solutions become available, managing information will become easier and we will see smiles on the faces of information managers. We are very happy to be a part of this joint program with NTT and look forward to a prosperous relationship for a long time to come in bringing comprehensive solutions to information networking problems."

Data General's Position On Drugs In The Workplace

Data General has a long established practice with regards to drug use by employees. The company will make every effort to help any employee who has a problem with alcohol or drugs. At the same time, however, the company will not tolerate drug use in the workplace.

Data General is committed to maintaining a drug-free workplace. Additionally, as a federal contractor, the company is required to outline its policies to employees. These requirements are contained in the Drug Free Workplace Act of 1988.

Drugs In The Workplace

Data General rules prohibit the unlawful manufacture, distribution, dispensing, possession or use of drugs, including alcohol, in the workplace. Violation of the rules is considered a serious offense that cannot be tolerated and would result in discipline up to and including termination of employment.

The Drug-Free Workplace Act requires that all employees abide by company rules regarding drugs as a condition of continued employment on a government contract. If convicted of a drug violation occurring at work, the employee working on a government contract must notify the company within five days. If remaining with the company following conviction, the employee must satisfactorily participate in an approved drug abuse assistance or rehabilitation program.

Assistance

Data General's Health Services department provides con-

fidential assistance to employees seeking help with an alcohol or drug-related problem. Additionally, Data General's medical benefit plans and most of the HMOs offered to employees provide financial assistance for treatment of such problems.

Drug Testing

Data General does not test employees for the presence of drugs and, under the current law, does not foresee the implementation of such a practice. However, Department of Defense rules could result in a requirement for testing in very limited situations in which an employee was directly involved in government contract work having access to classified information. In such cases, employees would be expected to agree to testing as a condition of employment.




Steve Expenses to we say

Director's Award Recipients






