2. Terms and Conditions

Prices and Taxes

Prices are exclusive of, and Customer is responsible for all sales, use and like taxes. Zetaco will invoice Customer for all applicable taxes, unless Customer supplies an appropriate tax exemption certificate in a form satisfactory to Zetaco.

Acceptance of Orders

All orders placed with Zetaco by buyer shall be subject to acceptance by Zetaco at its principal place of business and on the condition that buyer assents to the terms and conditions set forth herein. Failure to object in writing within ten (10) days of the date of Zetaco's acknowledgement, acceptance of the first shipment of the products, or the first of any payments for the products purchased, whichever is earliest shall be deemed to be buyer's assent to purchase of the products in accordance with the terms and conditions set forth herein.

Definitions

Equipment:

Shall mean the hardware components of Zetaco's products.

Software:

Shall mean each software program provided by Zetaco in machine readable, object, printed or interpreted form.

Products:

Shall mean any configuration of hardware and software, including documentation sold or licensed by Zetaco.

OEM:

Shall mean a customer that incorporates the Zetaco products purchased under this agreement into systems (including hardware and software) that the OEM sells or leases and supports. The OEM may also use the product internally, but the predominate use is to be incorporated into his product for resale. The OEM must sign an OEM sales agreement with Zetaco, and be a "Value Added Reseller" of Data General Products.

Active Product:

Shall mean product that is actively being built or stocked

with lead times typically 30 days.

Build to Order:

Shall mean product that is presently not actively being built, or stocked, and therefore lead times will be typically 60 to

120 days.

Valid 1-1-91 thru 6-31-91

Customer Special: Shall mean product that is built especially for a customer

and not actively built or stocked. Lead times will be

typically 60 to 120 days.

Discontinued: Shall mean product that can not be built without first

checking to insure documentation, tooling, test equipment and materials are still available. It is Zetaco's intention not to produce these products, except under critical customer

requirements, and then only if possible.

Shipment and Delivery

A. The method of packaging shall be at the discretion of Zetaco and otherwise prepared in accordance with good commercial practices. An itemized packing list shall accompany each shipment. The method of shipment and carrier will be at Zetaco's discretion unless otherwise specified by Customer.

- B. Delivery will be made F.O.B. Zetaco's facilities, unless otherwise specified by customer, freight charges prepaid and billed within the contiguous limits of the United States, including Alaska and Hawaii. Freight charges to all other destinations shall be made collect.
- C. Title to the equipment will pass to Customer upon delivery of the equipment by Zetaco to a carrier, and upon that delivery, Customer will be responsible for, and will bear the entire risk of loss or damage to the products, regardless of when acceptance occurs. In no event shall title pass to Customer for any Software, except title shall pass to Customer for the media on which the Software is recorded.
- D. The scheduled delivery date shall be that date acknowledged by Zetaco. Zetaco shall consider any date requested by Customer. Zetaco shall use its best efforts to meet the scheduled delivery date.
- E. The standard delivery date is 30 days ARO. An expedite fee of 5% is standard for all purchase orders requesting delivery within 15 days ARO. Zetaco will on a best effort basis attempt to fill these orders within requested delivery time. Zetaco will invoice the expedite fee if successful in shipping these orders within 15 days of receipt. Product support tapes and manuals are excepted.

Terms of Payment

Payment terms are net thirty (30) days from the date set forth on the invoice, which date shall not precede the date of shipment of the products. The foregoing terms are subject to customer maintaining credit arrangements satisfactory to Zetaco. Otherwise, terms are cash in advance of delivery. Customer agrees to execute financial statements and other instruments at Zetaco's request.

Export/Import

Regardless of any disclosure by Customer to Zetaco of the ultimate destination of the products, Customer will not export, directly or indirectly any Zetaco product without first obtaining an export licenses from the U.S. Department of Commerce Bureau of Export Administration or any other agency or department of the United States Government, as required. When products arrive at the foreign point of entry, buyer shall take all actions and pay all duties, taxes, and other cost necessary to import products subject to the import control laws and regulations of the foreign country.

Proprietary Rights

Zetaco retains all proprietary rights in and to all designs, engineering details, schematics, drawings, and other similar data pertaining to the products and which are provided to customer under this agreement. Proprietary information which Zetaco may furnish to customer shall be in customers's possession pursuant only to a restrictive, nontransferable, nonexclusive license under which customer may use such proprietary information solely for the purpose of operating, servicing, and repairing the products, or integrating the products into a system, and for no other purpose. Customer shall not, without the express written consent of Zetaco, provide, disclose, transfer or otherwise make available any proprietary information, or copies, thereof, to any third party. Customer shall take appropriate action by instruction, agreement, or otherwise with those of its employees and third party agents having access to any proprietary information to restrict and control the use, copying, modification, disclosure, transfer, protection, and security of such proprietary information in accordance with the provisions of these terms and conditions. Customer agrees to protect any proprietary information with the same standard of care and procedures which it uses to protect its own like proprietary information.

Inspections and Claims

Upon receipt of shipment, buyer shall inspect the products. Claims for shortages, incorrect materials or invoicing errors must be made by buyer within fifteen (15) days after receipt of shipment. Claims for non-receipt of shipment must be made within fifteen (15) days after receipt of invoice.

Limited Warranty

- A. Peripheral Controllers: Zetaco manufactured controllers are warranted free from workmanship and material defects, when used in a normal and proper manner, for a period of up to two years from date of shipment on a return to repair facility basis. Defective products under warranty shall be returned to Zetaco freight prepaid. Zetaco shall, at it discretion, repair or replace defective product surface freight prepaid.
- B. Peripheral Subsystems: Subsystem components that are produced by firms other than Zetaco are warranted free from workmanship and material defects, under normal and proper use, per the manufacturer's warranty, but not less than six (6) months from date of shipment from Zetaco on a return to repair facility basis.
- C. Products manufactured by Zetaco that prove to be DOA(dead on arrival) or inoperative, under normal and proper use, within 30 calendar days after being shipped from Zetaco(shipping damage excluded), shall be replaced immediately. After Customer contacts Zetaco's Customer Support Group (1-800-537-5292) and obtains a Return Material Authorization (RMA) number, a comparable product will be sent via overnight express shipment to Customer's site. The defective unit is to be returned to Zetaco upon removal.

Cancellations

The buyer may, prior to the scheduled shipment date, cancel delivery of any <u>Active</u> product, providing seller receives written notice of such cancellation at least thirty (30) days prior to scheduled shipment date and buyer shall be subject to cancellation charges.

Payment of cancellation charges shall be made within ten (10) days of invoice for same and shall constitute the buyer's entire liability with respect to the cancelled equipment.

The buyer may not cancel product built under the <u>Build to Order</u> or <u>Discontinued</u> product definition.

Reschedules

Orders for Active products accepted and scheduled for shipment by the seller are subject to being rescheduled upon written notice by the buyer at least fifteen (15) days prior to the scheduled shipment date and with the written consent of the seller providing such rescheduling does not result in actual delivery being delayed more than one hundred twenty (120) days beyond the originally scheduled shipment date. Units not accepted for delivery by the buyer within 120 days of the originally scheduled shipment date will be considered as cancelled. Should rescheduled units be subsequently cancelled, the original shipment date for such units shall be utilized in calculation of the cancellation charges.

Orders for <u>Build to Order</u> or <u>Discontinued</u> product can be rescheduled per above paragraph, but only within sixty (60) days of scheduled shipment date.

Limitation of Liability

Except for express warranties stated in this document, Zetaco disclaims all warranties including all implied warranties of merchantability and fitness. The stated express warranties are in lieu of all obligations of liabilities on the part of Zetaco for damages, including but not limited to special, indirect or consequential damages arising out of or in connection with the use or performance of Zetaco's products.
